






Top View

Top View Pin-Out








Thermal Resistance (°C/W) 50mm x 50mm D=0.5 D=0.2 Pulse Width (s)






VCE(sat) v IC


VCE(sat) v IC

VBE(sat) v IC




Ic - Collector Current (Amps) **VBE(on) v IC**


