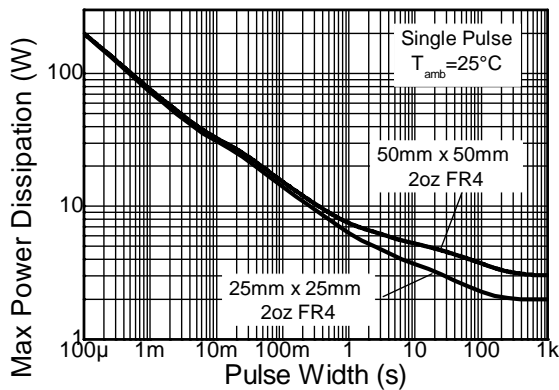

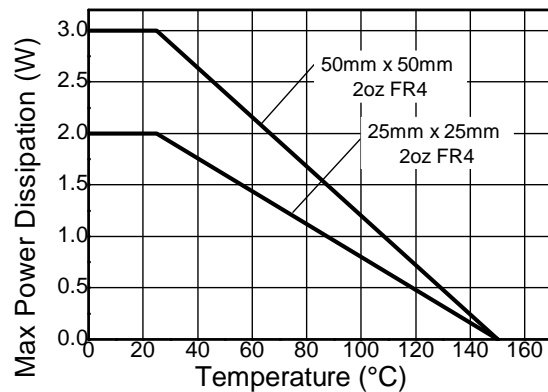
Transient Thermal Impedance

Pulse Power Dissipation



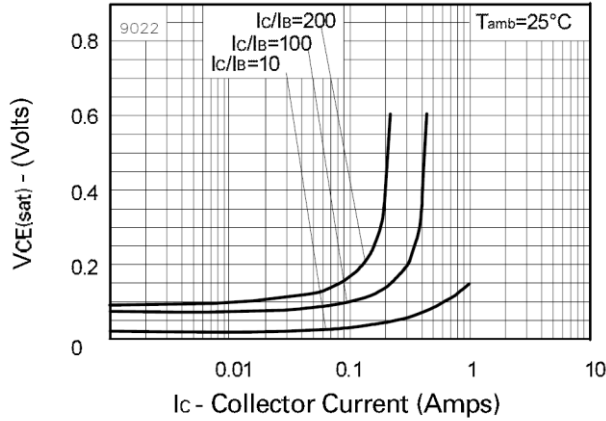
Derating Curve

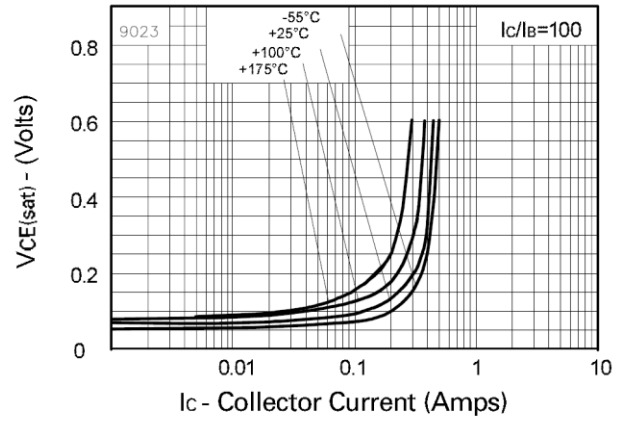

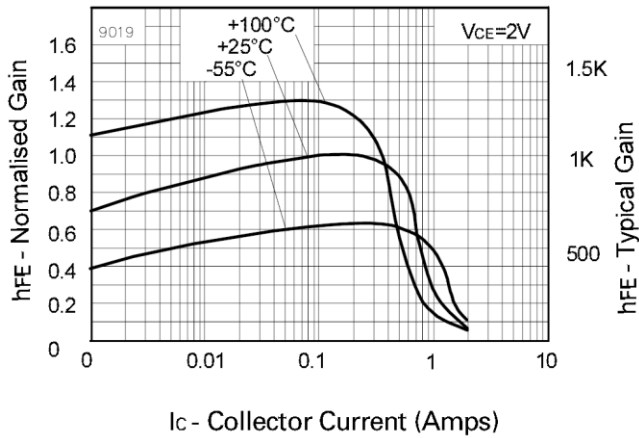

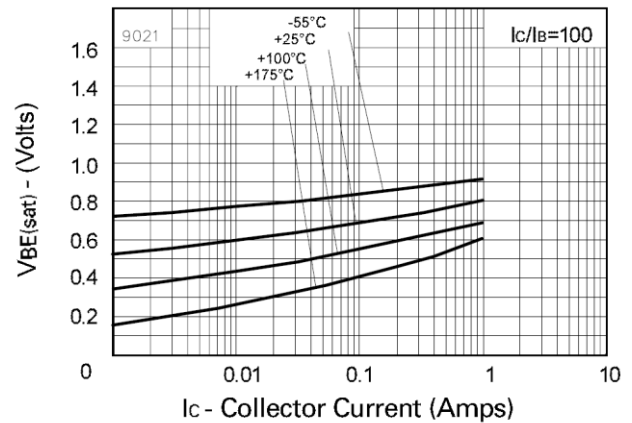
**$V_{CE(sat)}$  v  $I_C$**



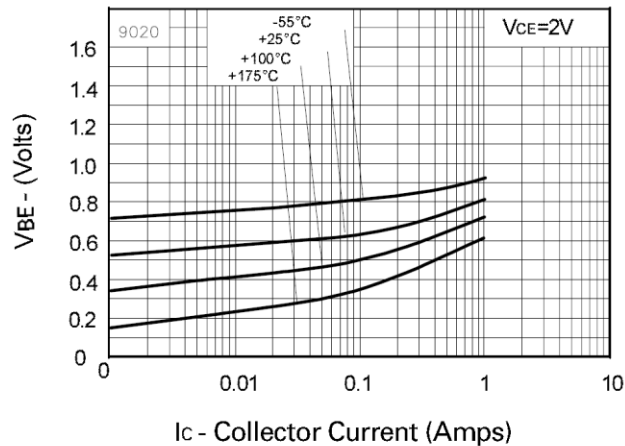
**$V_{CE(sat)}$  v  $I_C$**



**$h_{FE}$  v  $I_C$**



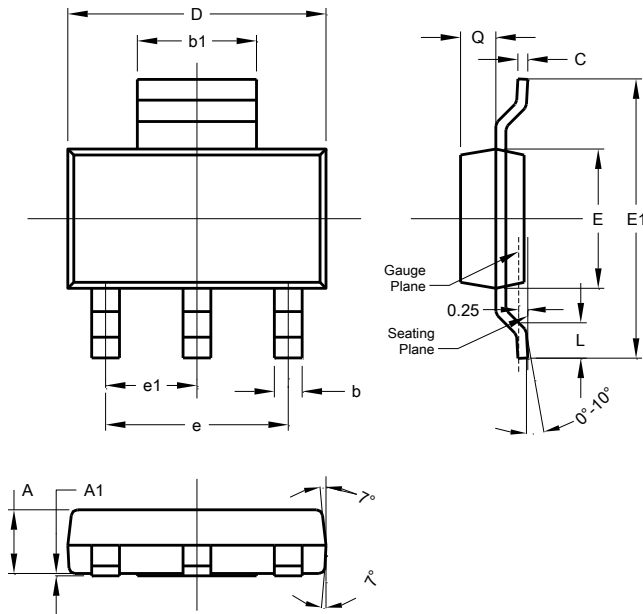
**$V_{BE(sat)}$  v  $I_C$**

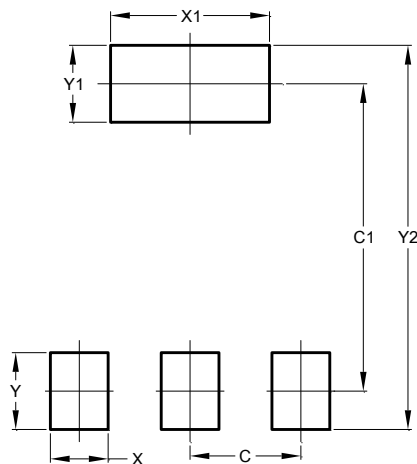
