## DESCRIPTION

The PS9506, PS9506L1, PS9506L2 and PS9506L3 are optically coupled isolators containing a GaAlAs LED on the input side and a photo diode, a signal processing circuit and a power output transistor on the output side on one chip. The PS9506 Series is designed specifically for high common mode transient immunity (CMR) and high switching speed.

The PS9506 Series is suitable for driving IGBTs and MOS FETs.

The PS9506L1 is lead bending type for long creepage distance.






**Lead Bending Type (Gull-wing) For Surface Mount**



**Lead Bending Type For Long Creepage Distance**












**Fig. 8 CMR Test Circuit and Wave Forms**






**DIODE POWER DISSIPATION vs. AMBIENT TEMPERATURE**




**DETECTOR POWER DISSIPATION vs. AMBIENT TEMPERATURE**




**FORWARD CURRENT vs. FORWARD VOLTAGE**




**THRESHOLD INPUT CURRENT vs. AMBIENT TEMPERATURE**




**HIGH LEVEL OUTPUT VOLTAGE – SUPPLY VOLTAGE vs. AMBIENT TEMPERATURE**




HIGH LEVEL OUTPUT CURRENT vs. AMBIENT TEMPERATURE




LOW LEVEL OUTPUT CURRENT vs. AMBIENT TEMPERATURE




LOW LEVEL OUTPUT VOLTAGE vs. AMBIENT TEMPERATURE




SUPPLY CURRENT vs. AMBIENT TEMPERATURE



HIGH LEVEL OUTPUT VOLTAGE – SUPPLY VOLTAGE vs. HIGH LEVEL OUTPUT CURRENT




LOW LEVEL OUTPUT VOLTAGE vs. LOW LEVEL OUTPUT CURRENT




SUPPLY CURRENT vs. SUPPLY VOLTAGE




PROPAGATION DELAY TIME, PULSE WIDTH DISTORTION vs. AMBIENT TEMPERATURE




PROPAGATION DELAY TIME vs. FORWARD CURRENT




PROPAGATION DELAY TIME vs. SUPPLY VOLTAGE



PROPAGATION DELAY TIME vs. LOAD CAPACITANCE




PROPAGATION DELAY TIME vs. LOAD RESISTANCE








Tape Direction









<R> **RECOMMENDED MOUNT PAD DIMENSIONS (UNIT: mm)**





## 1. Recommended soldering conditions

## (1) Infrared reflow soldering

- Peak reflow temperature 260°C or below (package surface temperature)
- Time of peak reflow temperature 10 seconds or less
- Time of temperature higher than 220°C 60 seconds or less
- Time to preheat temperature from 120 to 180°C 120±30 s
- Number of reflows Three
- Flux Rosin flux containing small amount of chlorine (The flux with a maximum chlorine content of 0.2 Wt% is recommended.)

## (2) Wave soldering

- Temperature 260°C or below (molten solder temperature)
- Time 10 seconds or less
- Preheating conditions 120°C or below (package surface temperature)
- Number of times One (Allowed to be dipped in solder including plastic mold portion.)
- Flux Rosin flux containing small amount of chlorine (The flux with a maximum chlorine content of 0.2 Wt% is recommended.)

## (3) Soldering by Soldering Iron

- Peak Temperature (lead part temperature) 350°C or below
- Time (each pins) 3 seconds or less
- Flux Rosin flux containing small amount of chlorine (The flux with a maximum chlorine content of 0.2 Wt% is recommended.)

(a) Soldering of leads should be made at the point 1.5 to 2.0 mm from the root of the lead

## (4) Cautions

- Fluxes Avoid removing the residual flux with freon-based and chlorine-based cleaning solvent.

## 2. Cautions regarding noise

Be aware that when voltage is applied suddenly between the photocoupler's input and output at startup, the output transistor may enter the on state, even if the voltage is within the absolute maximum ratings.

## USAGE CAUTIONS

1. This product is weak for static electricity by designed with high-speed integrated circuit so protect against static electricity when handling.
2. Board designing
  - (1) By-pass capacitor of more than 0.1  $\mu\text{F}$  is used between  $V_{\text{CC}}$  and GND near device. Also, ensure that the distance between the leads of the photocoupler and capacitor is no more than 10 mm.
  - (2) When designing the printed wiring board, ensure that the pattern of the IGBT collectors/emitters is not too close to the input block pattern of the photocoupler.  
If the pattern is too close to the input block and coupling occurs, a sudden fluctuation in the voltage on the IGBT output side might affect the photocoupler's LED input, leading to malfunction or degradation of characteristics. (If the pattern needs to be close to the input block, to prevent the LED from lighting during the off state due to the abovementioned coupling, design the input-side circuit so that the bias of the LED is reversed, within the range of the recommended operating conditions, and be sure to thoroughly evaluate operation.)
  - (3) Pins 1, 4 (which is an NC<sup>\*1</sup> pin) can either be connected directly to the GND pin on the LED side or left open. Also, Pin 7 (which is an NC<sup>\*1</sup> pin) can either be connected directly to the GND pin on the detector side or left open.  
Unconnected pins should not be used as a bypass for signals or for any other similar purpose because this may degrade the internal noise environment of the device.  
Note: \*1. NC: Non-Connection (No Connection).
3. Make sure the rise/fall time of the forward current is 0.5  $\mu\text{s}$  or less.
4. In order to avoid malfunctions, make sure the rise/fall slope of the supply voltage is 3 V/ $\mu\text{s}$  or less.
5. Avoid storage at a high temperature and high humidity.
