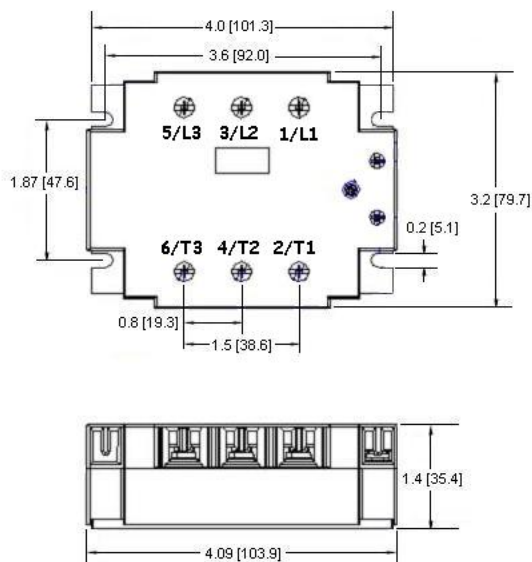

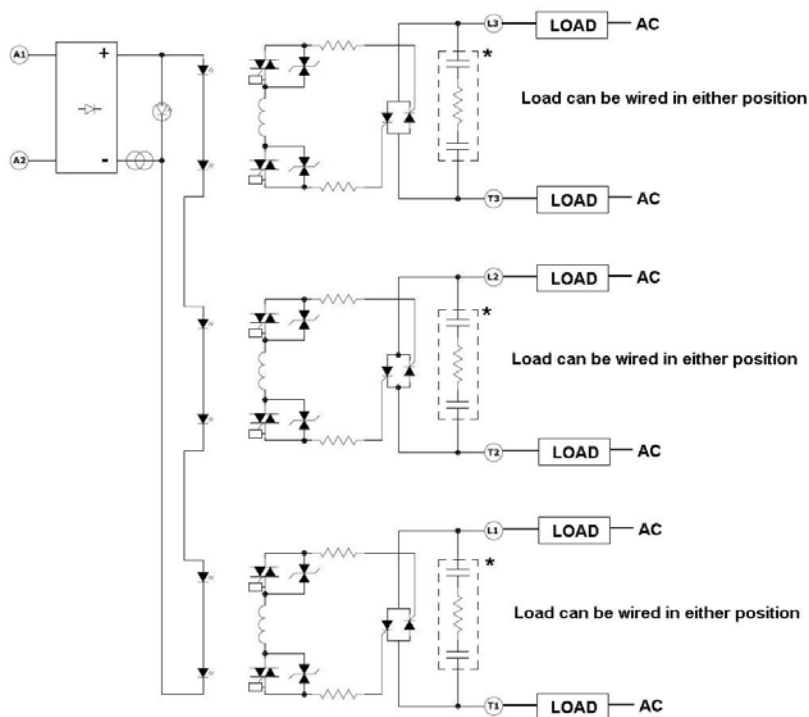

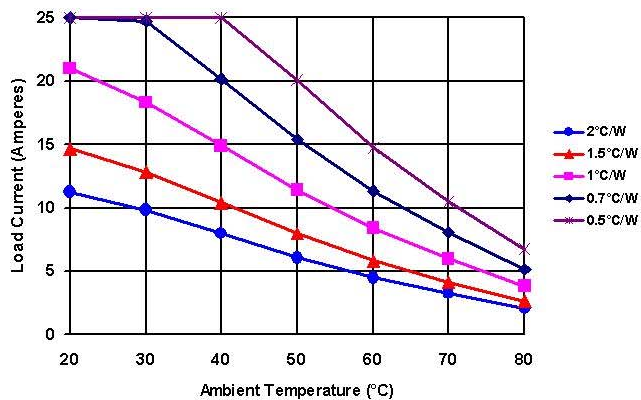
WIRING DIAGRAM



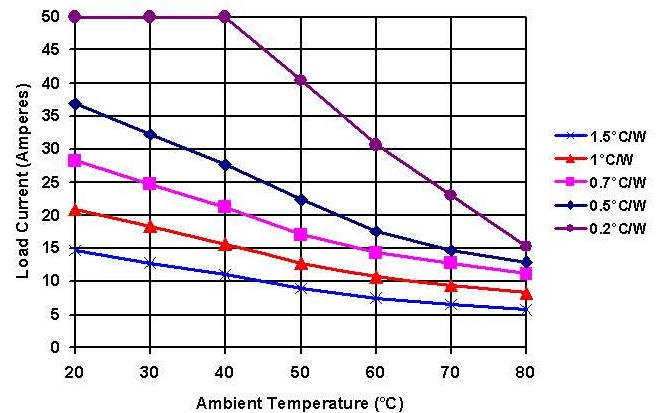
