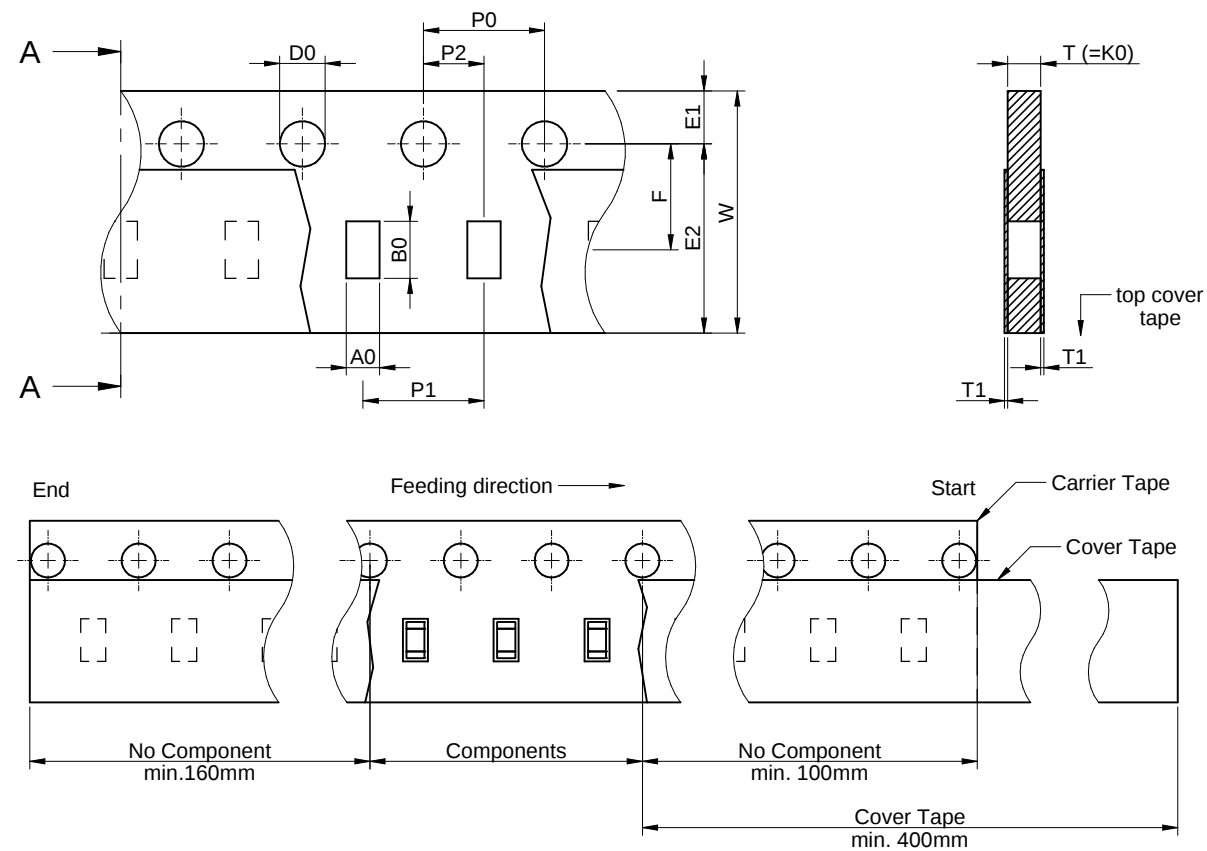
Derating Curve:

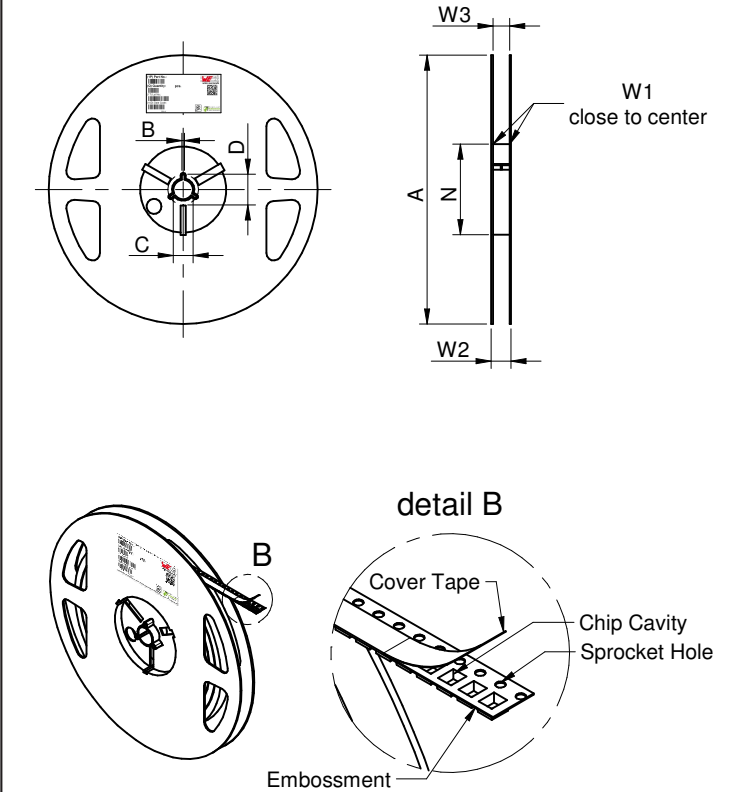

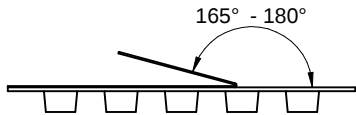
