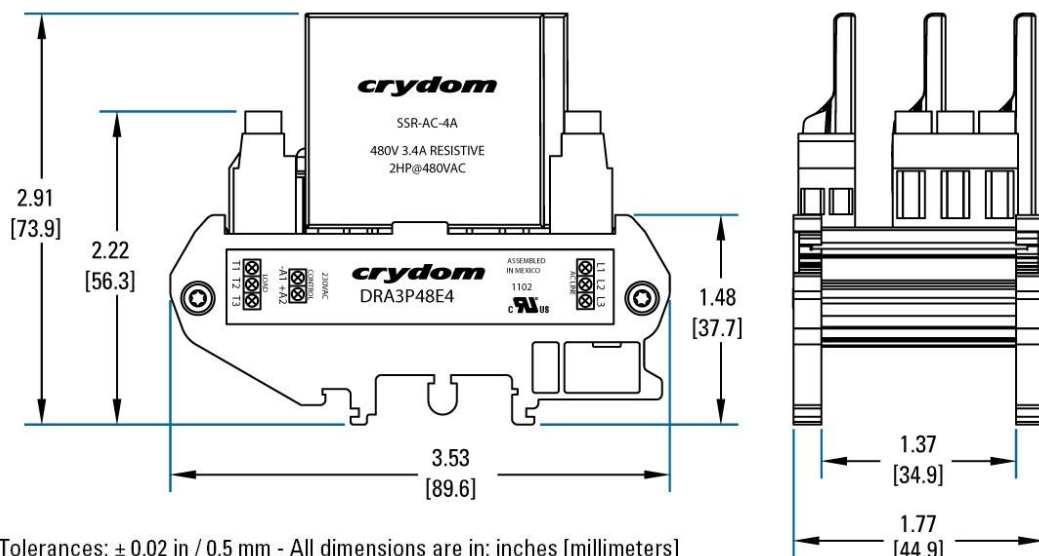

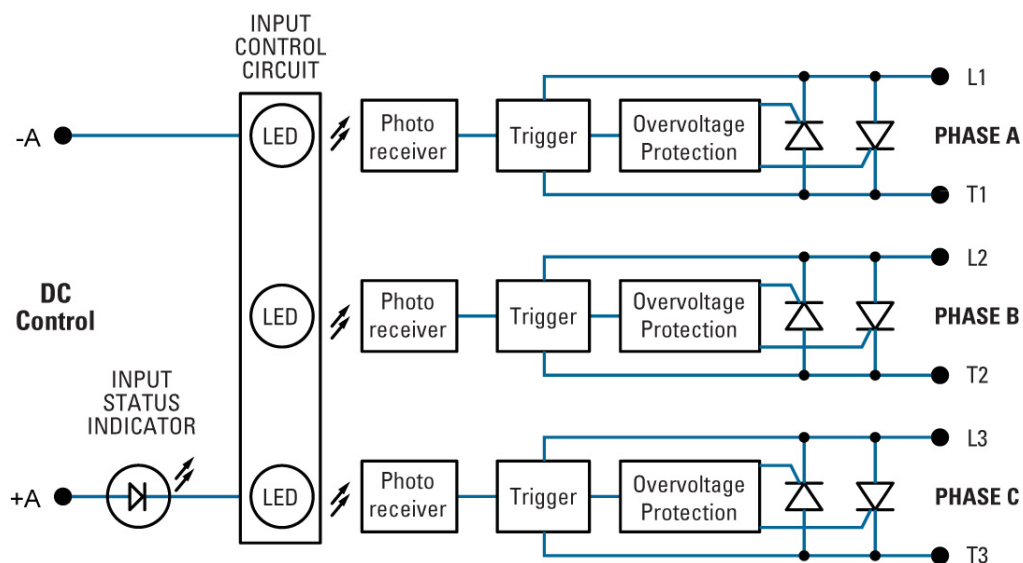

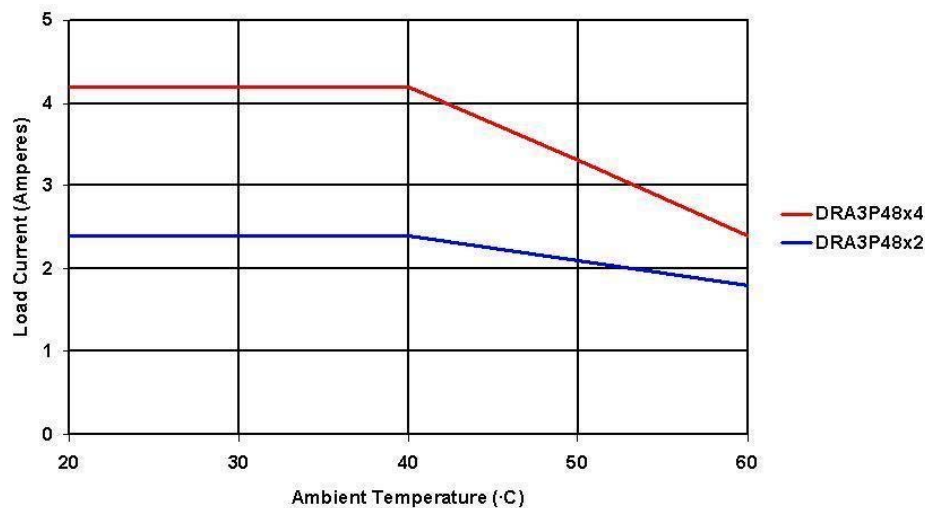


WIRING DIAGRAM
