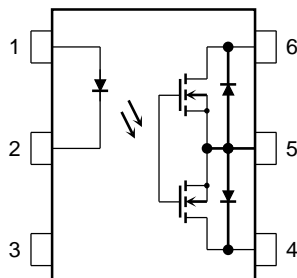

The TLP597GA is a bi-directional switch which can replace mechanical relays in many applications.

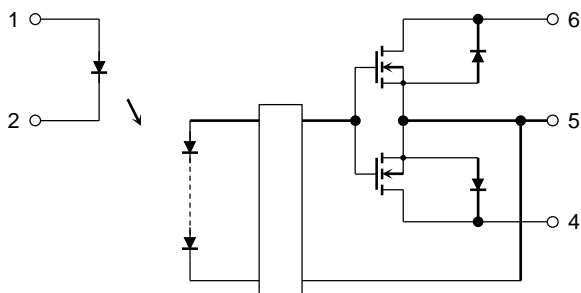

Pin Configuration (top view)

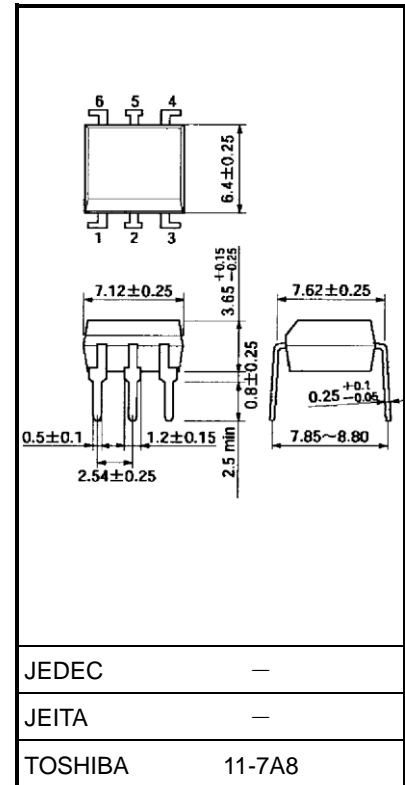


1: ANODE
