



- 10. To fulfill requirements of the latest ErP regulation for lighting fixtures, this LED power supply can only be used behind a switch without permanently connected to the mains








■ Power Factor Characteristic




■ DRIVING METHODS OF LED MODULE

There are two major kinds of LED drive method "direct drive" and "with LED driver".

A typical LED power supply may either work in "constant voltage mode (CV) or constant current mode (CC)" to drive the LEDs.

Mean Well's LED power supply with CV+ CC characteristic can be operated at both CV mode [with LED driver, at area (A)] and CC mode [direct drive, at area (B)].



Typical LED power supply I-V curve

In the constant current region, the highest voltage at the output of the driver depends on the configuration of the end systems.
