(@ Chamber and natural convection 0.1 m/s)



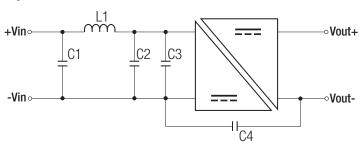
