Description

The NC7WZ04 is a dual inverter from Fairchild's Ultra-High Speed (UHS) series of TinyLogic®. The device is fabricated with advanced CMOS technology to achieve ultra-high speed with high output drive while maintaining low static power dissipation over a broad $V_{\rm CC}$ operating range. The device is specified to operate over a very broad $V_{\rm CC}$ operating range. The device is specified to operate over the 1.65V to 5.5V $V_{\rm CC}$ range. The inputs tolerate voltages up to 7V independent of $V_{\rm CC}$ operating voltage.




Figure 1. Logic Symbol




Figure 2. SC70 (Top View)




Figure 3. MicroPak (Top Through View)




Figure 4. Pin 1 Orientation



Figure 5. AC Test Circuit





Figure 6. AC Waveforms




Figure 8. 6-Lead, SC70, EIAJ SC88, 1.25mm Wide






Figure 10. 6-Lead, MicroPak2, 1x1mm Body, .35mm Pitch
