Typical Impedance Characteristics:

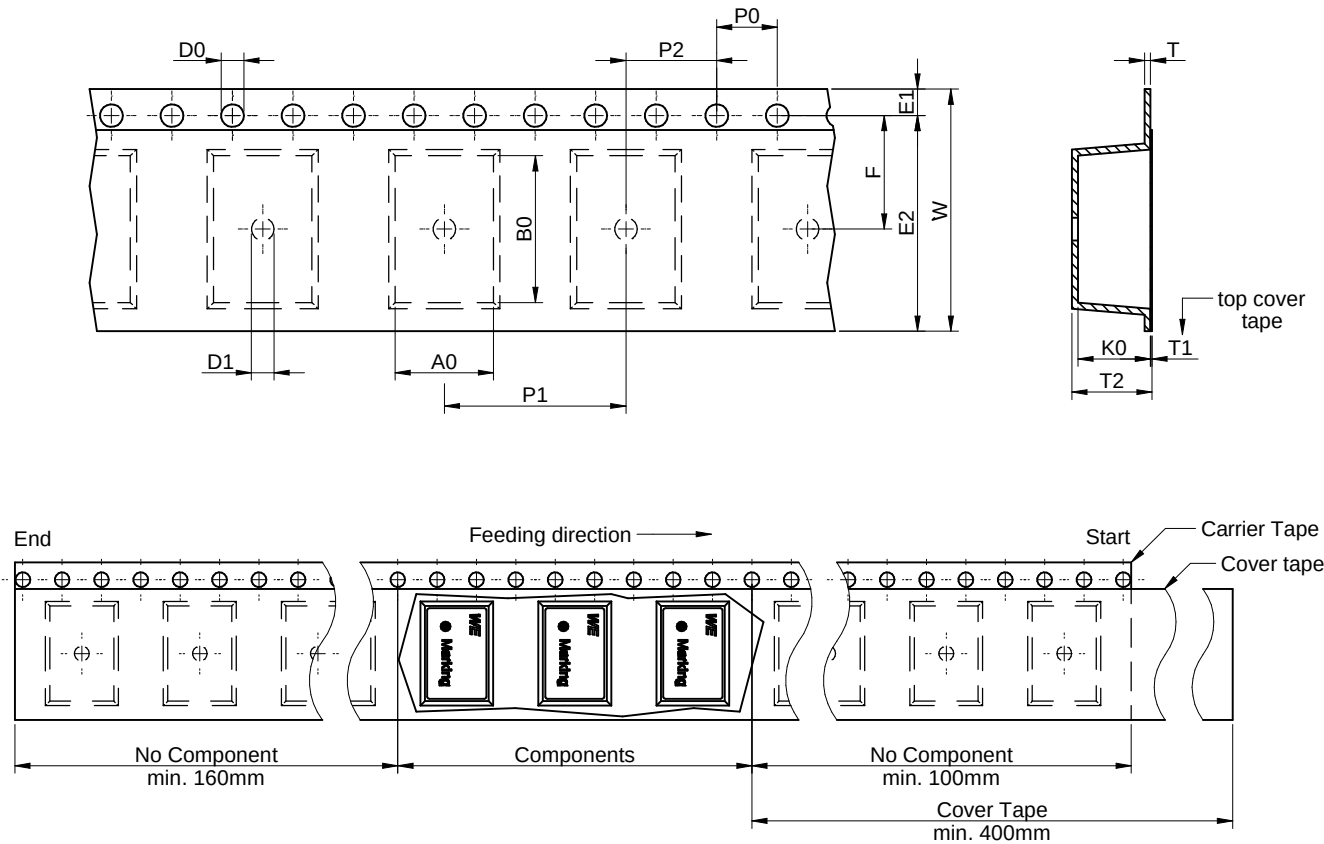
