



Description

The QED522 and QED523 are 880nm AlGaAs LEDs encapsulated in a clear peach tinted, plastic TO-46 package.

Figure 1. Normalized Intensity vs. Wavelength




Figure 2. Peak Wavelength vs. Ambient Temperature




Figure 3. Normalized Radiant Intensity vs. Forward Current




Figure 4. Normalized Radiant Intensity vs. Ambient Temperature




Figure 5. Forward Voltage vs. Forward Current






Figure 6. Forward Voltage vs. Ambient Temperature


Figure 7. Radiation Diagram
