






Fig 1. Typical Output Characteristics




Fig 3. Typical Transfer Characteristics




Fig 5. Typical Capacitance vs. Drain-to-Source Voltage




Fig 2. Typical Output Characteristics





Fig 4. Normalized On-Resistance vs. Temperature



**Fig 6.** Typical Gate Charge vs. Gate-to-Source Voltage www.irf.com





Fig 7. Typical Source-Drain Diode Forward Voltage



**Fig 9.** Maximum Drain Current vs. Case Temperature




Fig 11. Typical C<sub>OSS</sub> Stored Energy




Fig 8. Maximum Safe Operating Area




Fig 10. Drain-to-Source Breakdown Voltage




Fig 12. Maximum Avalanche Energy vs. DrainCurrent




Fig 13. Maximum Effective Transient Thermal Impedance, Junction-to-Case




Fig 14. Typical Avalanche Current vs. Pulsewidth




Fig 15. Maximum Avalanche Energy vs. Temperature




Fig 16. Threshold Voltage vs. Temperature




Fig. 18 - Typical Recovery Current vs. dif/dt




Fig. 17 - Typical Recovery Current vs. di<sub>f</sub>/dt




Fig. 19 - Typical Stored Charge vs. dif/dt





Fig. 20 - Typical Stored Charge vs. dif/dt

Fig 21. Peak Diode Recovery dv/dt Test Circuit for N-Channel HEXFET® Power MOSFETs




Fig 22a. Unclamped Inductive Test Circuit




Fig 23a. Switching Time Test Circuit




Fig 24a. Gate Charge Test Circuit




Fig 22b. Unclamped Inductive Waveforms




Fig 23b. Switching Time Waveforms






Fig 24b. Gate Charge Waveform


