Planar Maximum Efficiency General Application (MEGA) Schottky barrier rectifier with an integrated guard ring for stress protection, encapsulated in a SOD128 small and flat lead Surface-Mounted Device (SMD) plastic package.

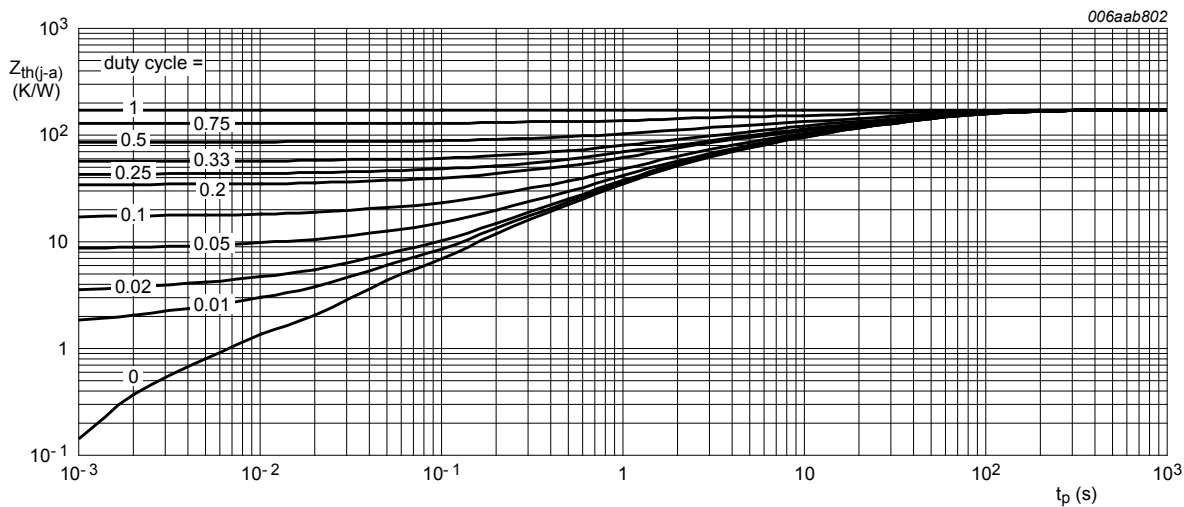

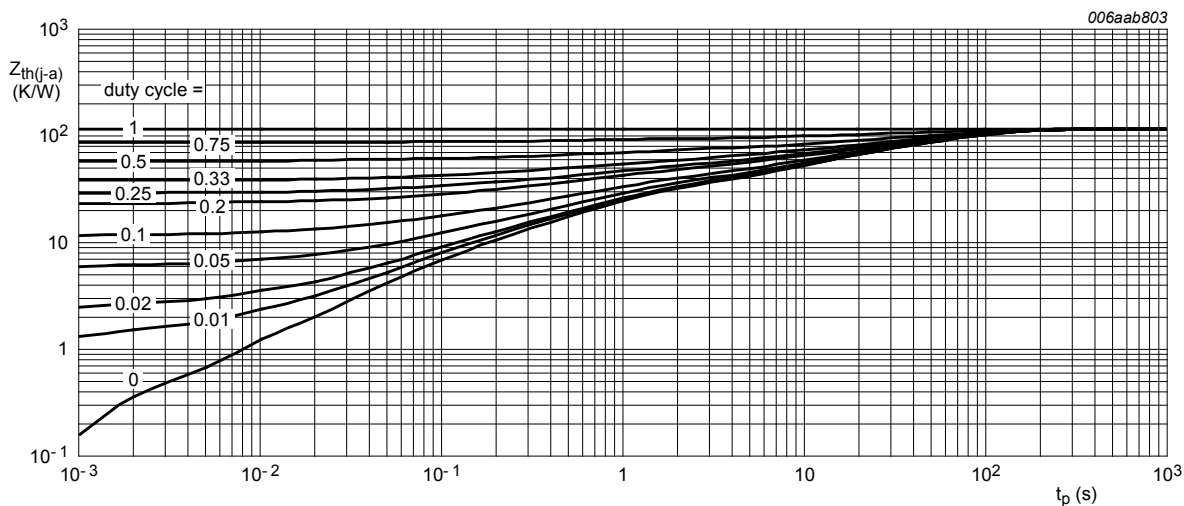

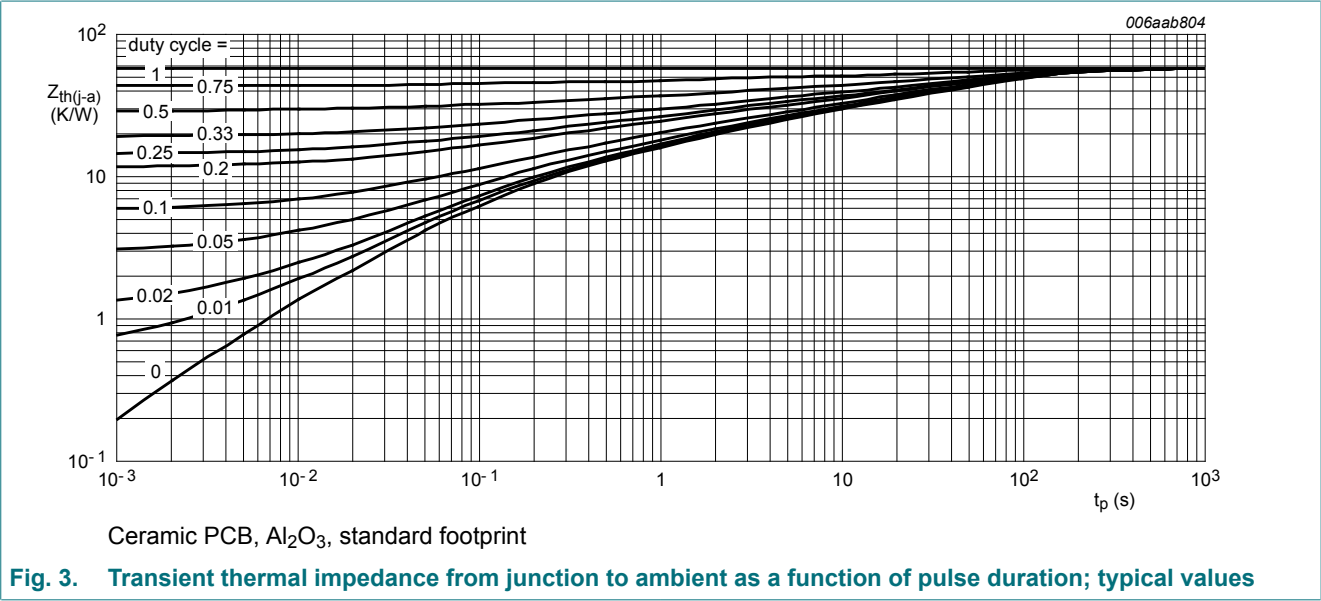
FR4 PCB, standard footprint

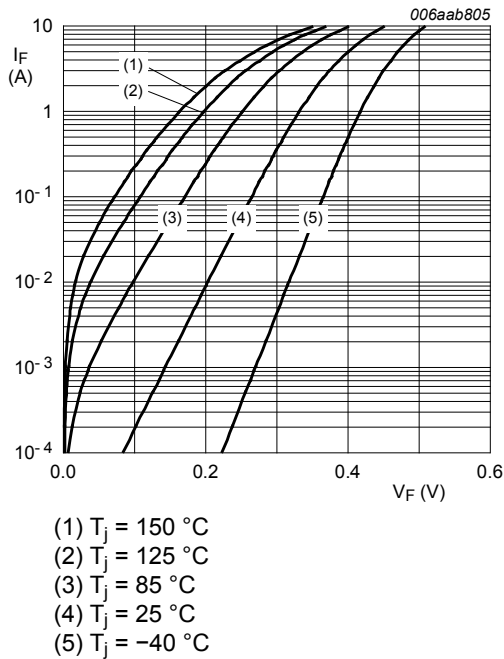


Fig. 4. Forward current as a function of forward voltage; typical values

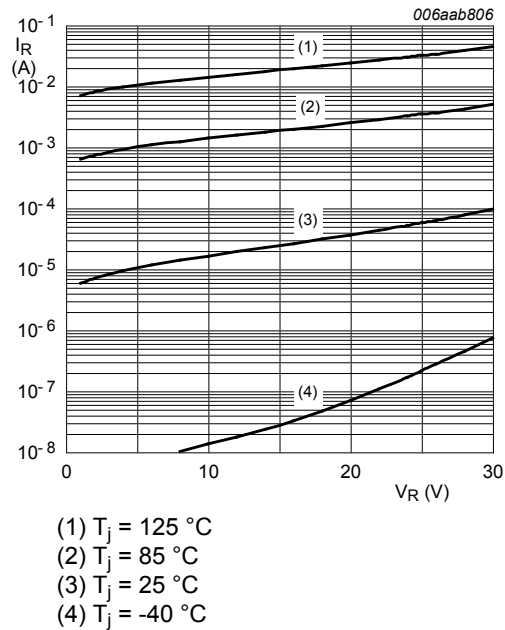
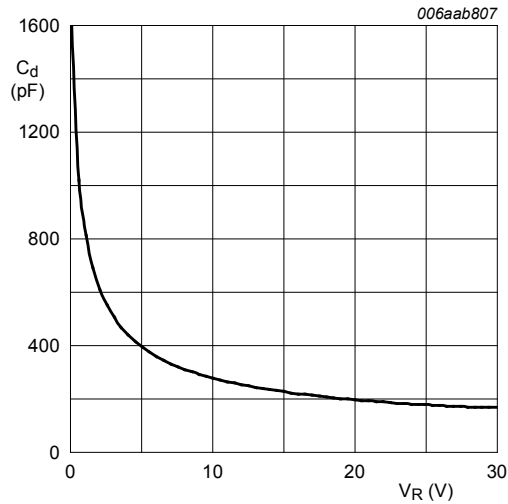
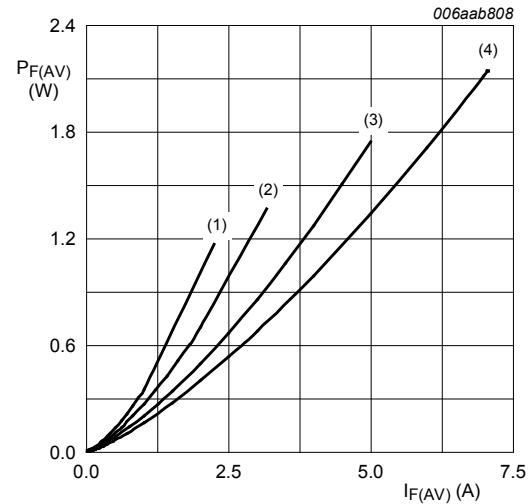


Fig. 5. Reverse current as a function of reverse voltage; typical values



$f = 1 \text{ MHz}$ ;  $T_{\text{amb}} = 25 \text{ }^{\circ}\text{C}$

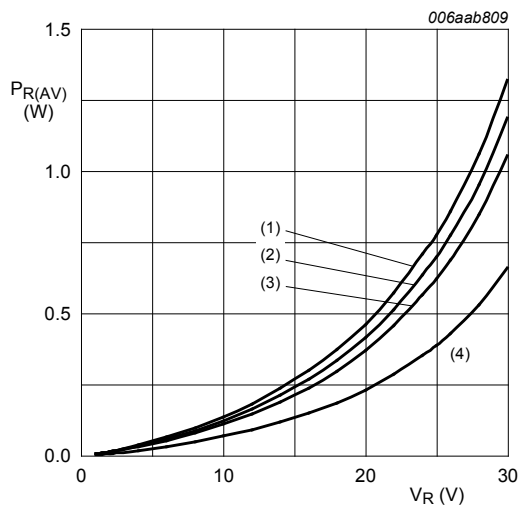
**Fig. 6.** Diode capacitance as a function of reverse voltage; typical values

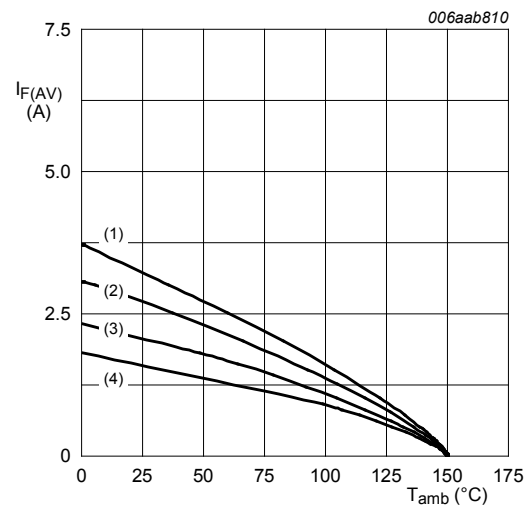
**Fig. 7.** Average forward power dissipation as a function of average forward current; typical values

**Fig. 8.** Average reverse power dissipation as a function of reverse voltage; typical values

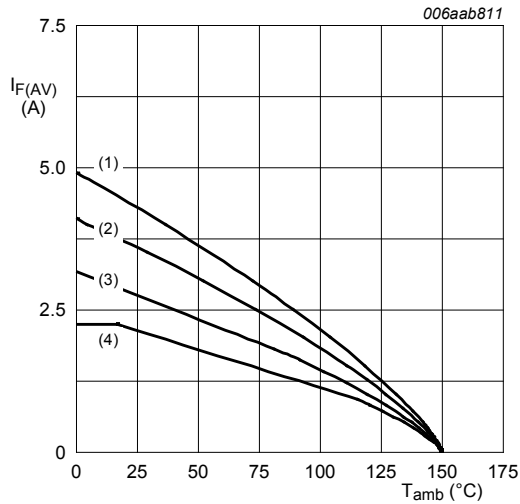

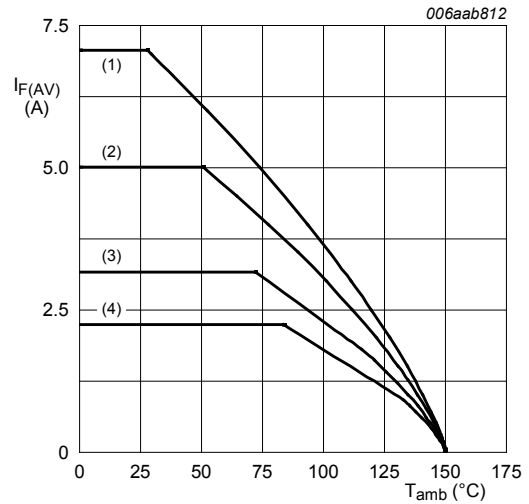

**Fig. 9.** Average forward current as a function of ambient temperature; typical values



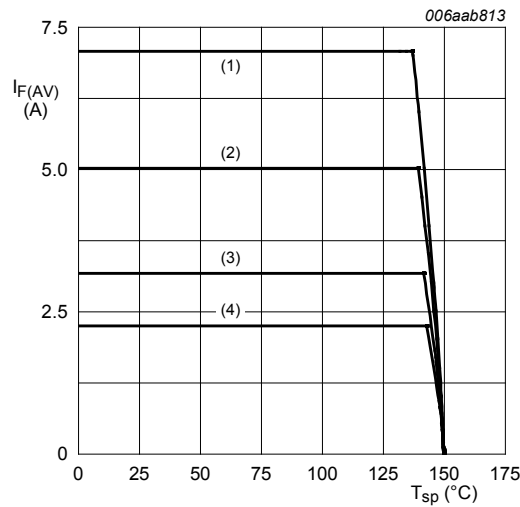

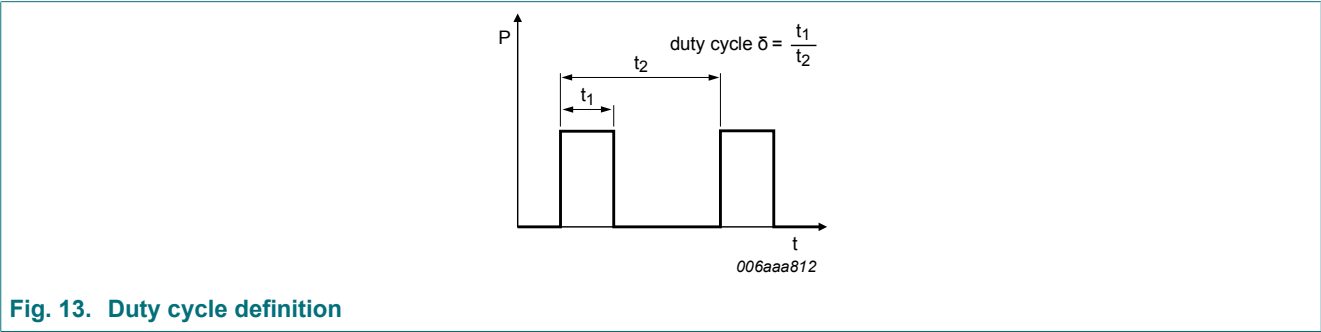
**Fig. 11. Average forward current as a function of ambient temperature; typical values**

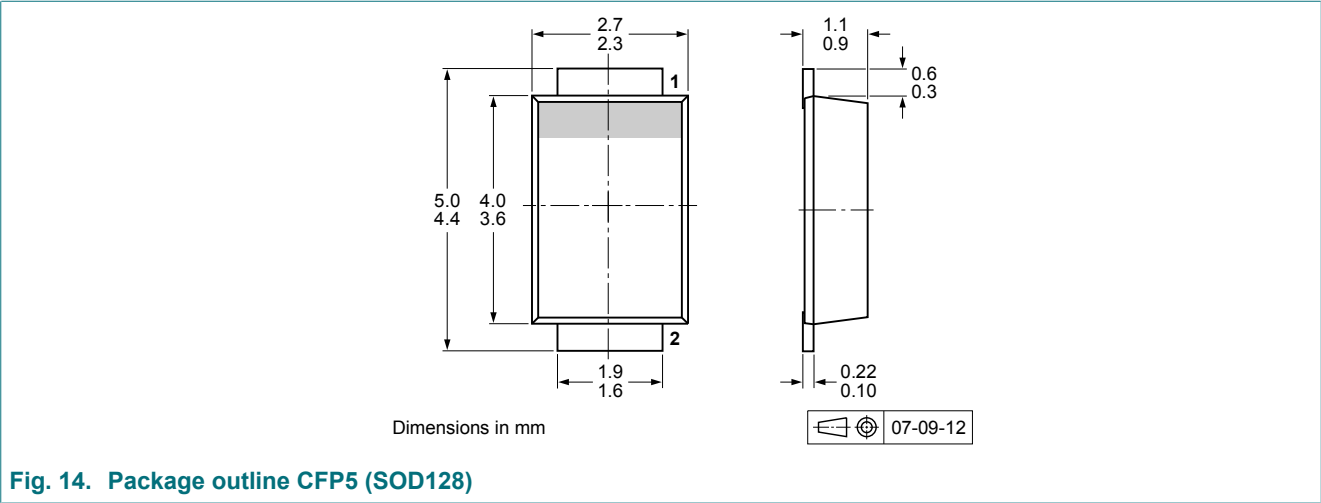

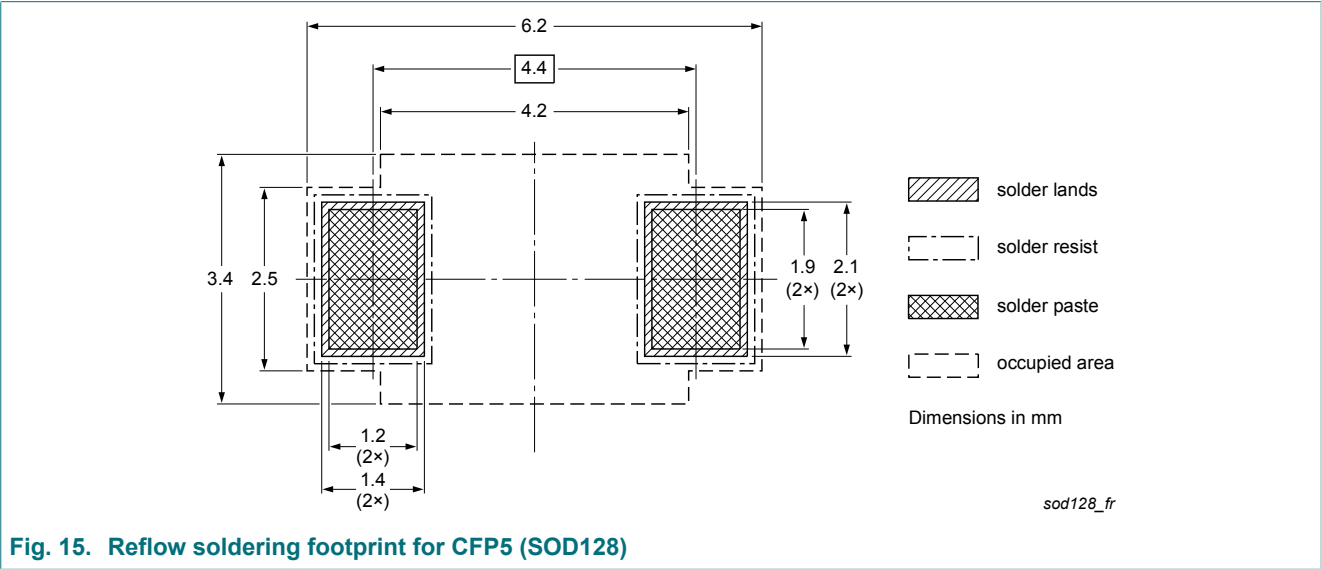

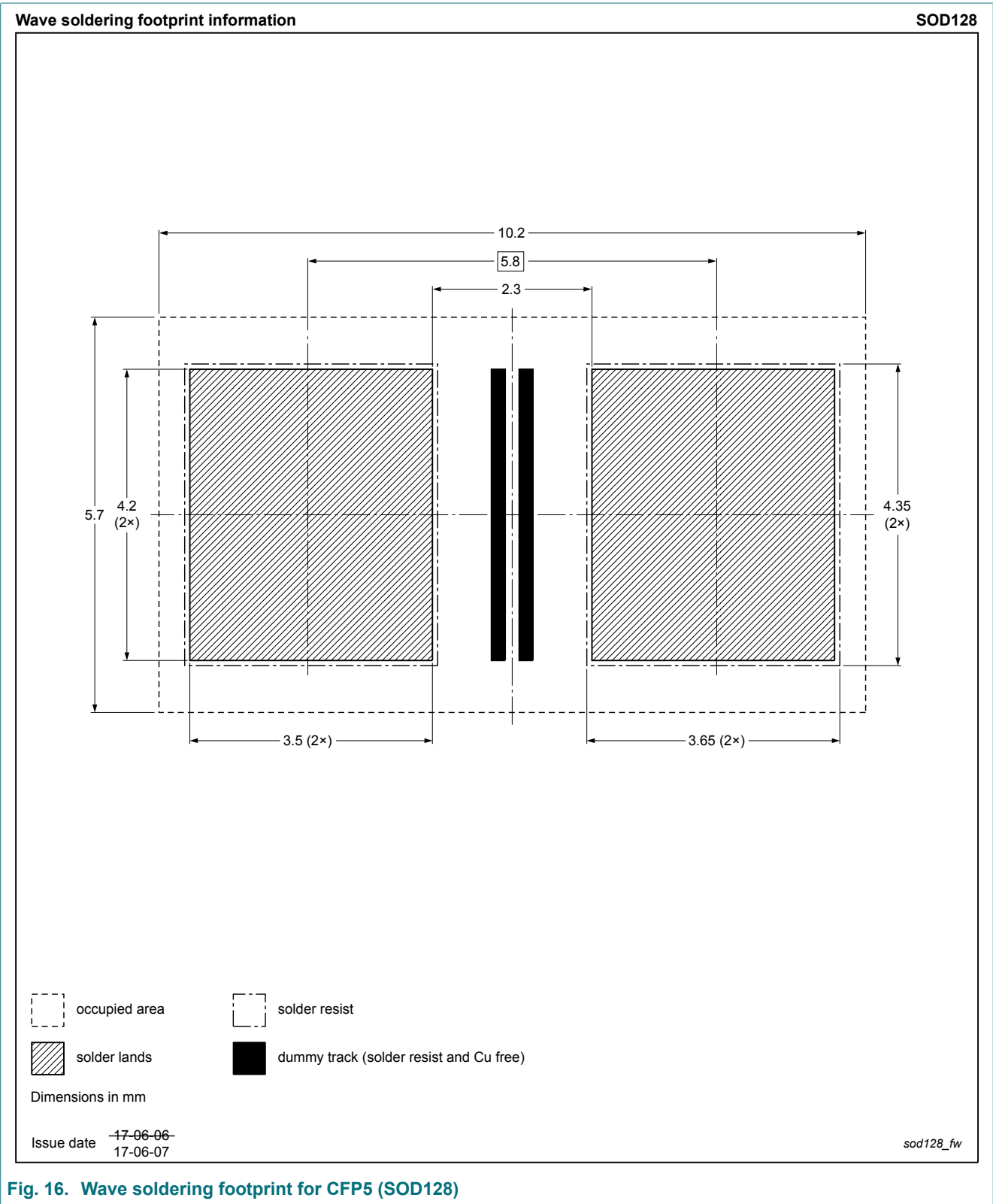


Fig. 16. Wave soldering footprint for CFP5 (SOD128)
