## 1 INTRODUCTION

The Texas Instruments LMT88-9EVM evaluation module (EVM) helps designers evaluate the operation and performance of the LMT88 and LMT89 analog temperature sensors.

## 2 SETUP

This section describes the jumpers and connectors on the EVM as well and how to properly connect, set up, and use the LMT88-9EVM.

### 2.1 *Input/Output Connector Description*

1. **J1.P1-LMT88:** Output is the output of the LMT88 analog temperature sensor.
2. **J1.P2-LMT89:** Output is the output of the LMT89 analog temperature sensor.
3. **J1.P3-GND** is the ground
4. **J1.P4-V+** is the power supply for the LMT88 and LMT89 sensors.

### 2.2 *Operation*

1. Supply a voltage to V+ (pin 4 of J1) and GND (pin 3 of J1).
2. Measure the output of the temperature sensor at pins 1 and pin 2 of J1.

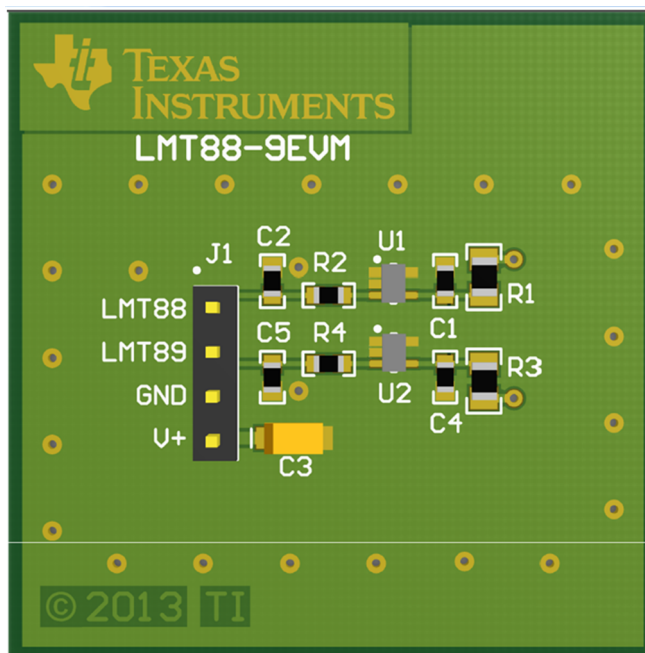


Figure 1. Top Layer

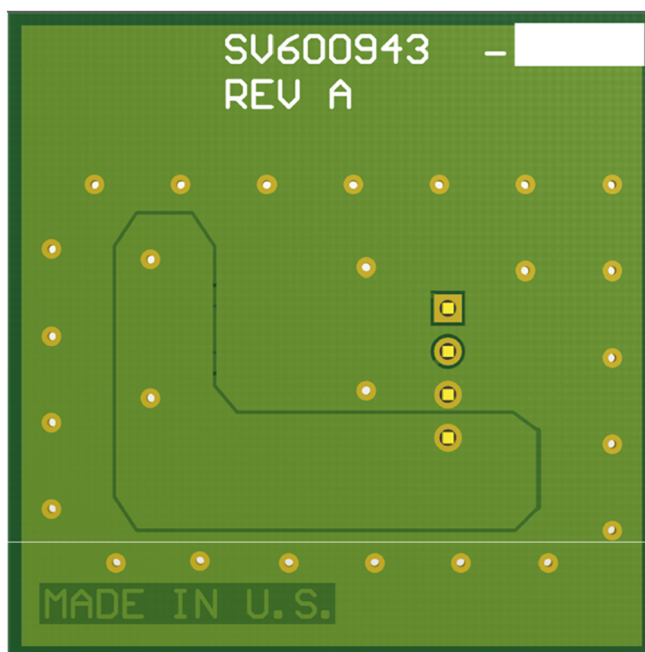


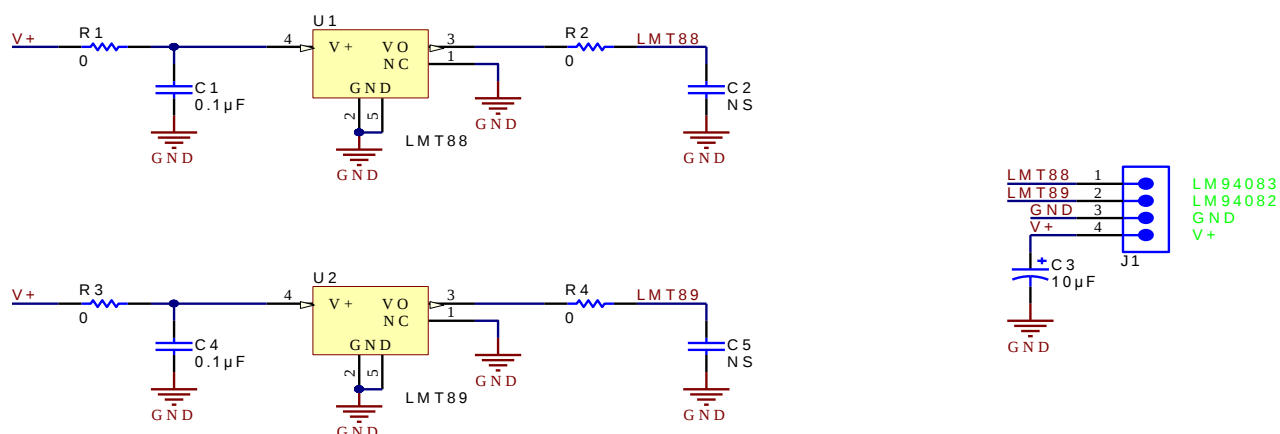
Figure 2. Bottom Layer
