

Reflow Soldering Profile For Lead-free SMT Process.




- NOTES:

 1.We recommend the reflow temperature 245°C(+/-5°C). The maximum soldering temperature should be limited to 260°C.

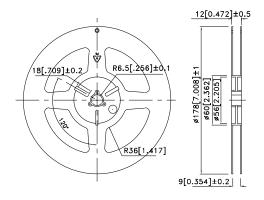
 2.Don't cause stress to the epoxy resin while it is exposed to high temperature.

 3.Number of reflow process shall be 2 times or less.


Recommended Soldering Pattern (Units: mm; Tolerance: ± 0.1)

Tape Dimensions (Units: mm)






