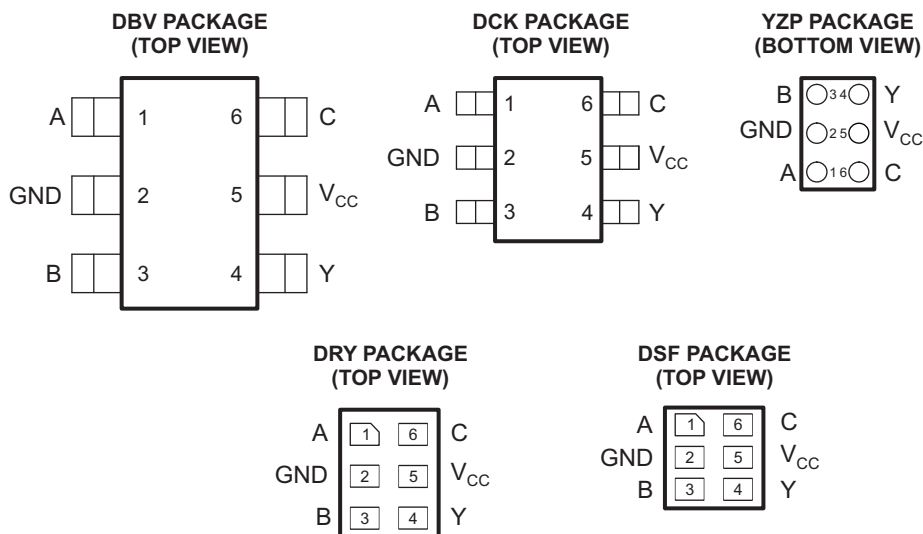

DESCRIPTION

The SN74LVC1G332 device performs the Boolean function in $Y = A + B + C$ or $Y = \overline{A} \cdot \overline{B} \cdot \overline{C}$ positive logic.

NanoStar™ and NanoFree™ package technology is a major breakthrough in IC packaging concepts, using the die as the package.

This device is fully specified for partial-power-down applications using I_{off} . The I_{off} circuitry disables the outputs, preventing damaging current backflow through the device when it is powered down.

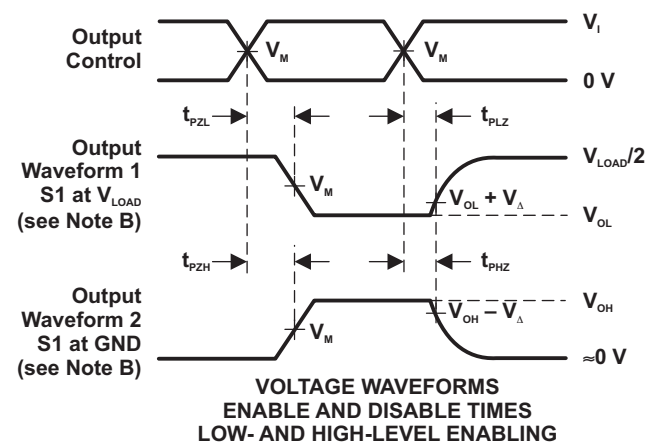
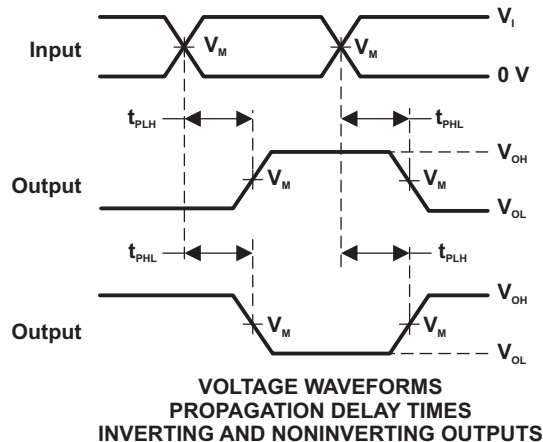
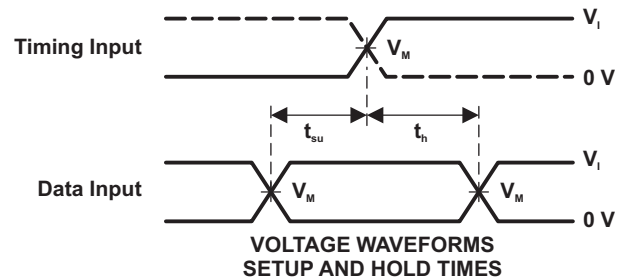
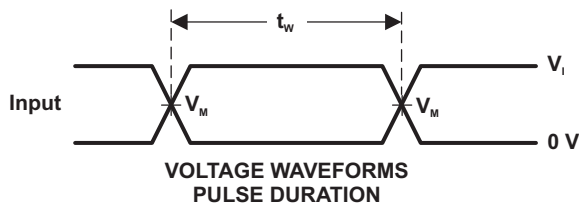
Figure 1. Load Circuit and Voltage Waveforms

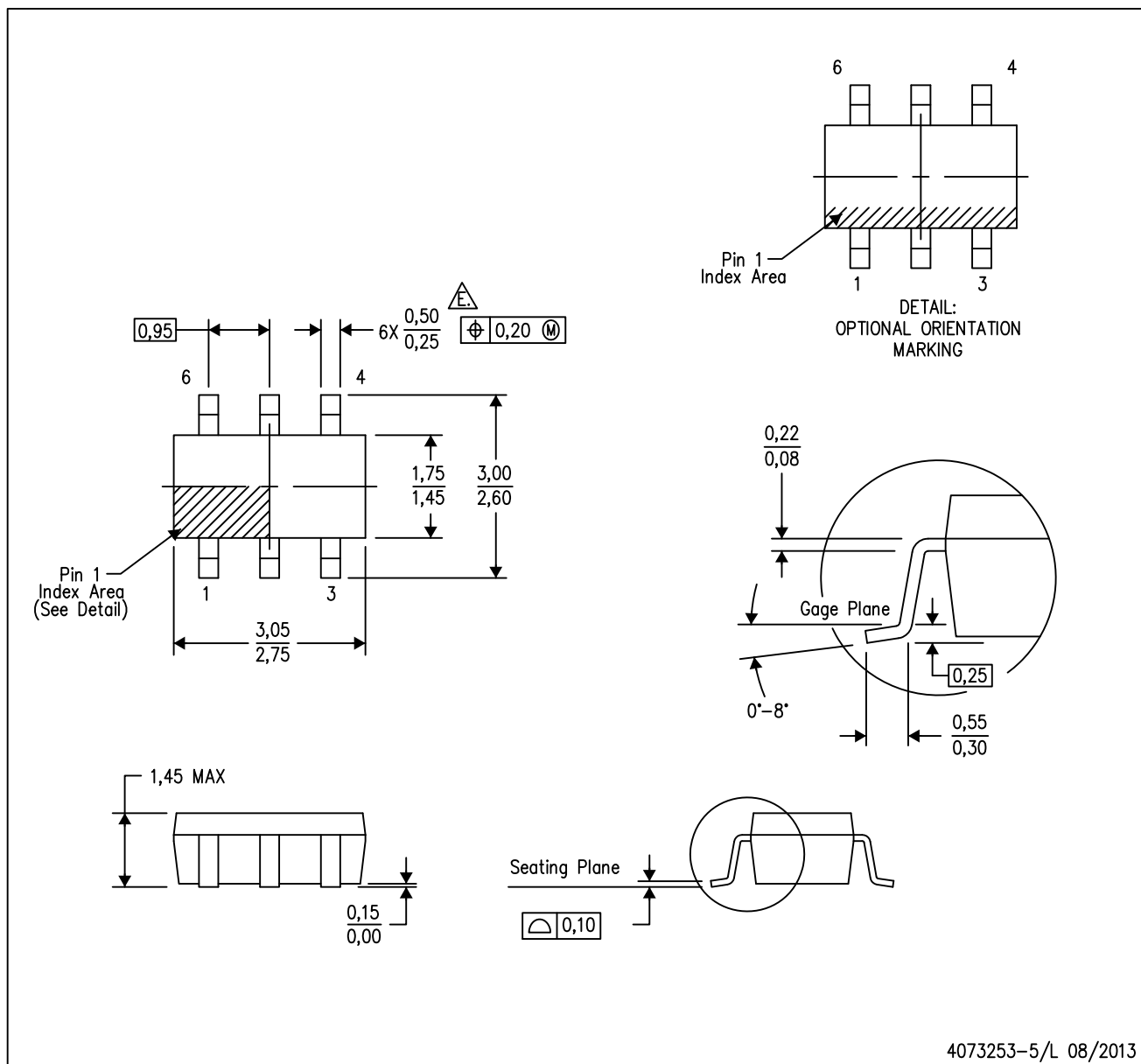

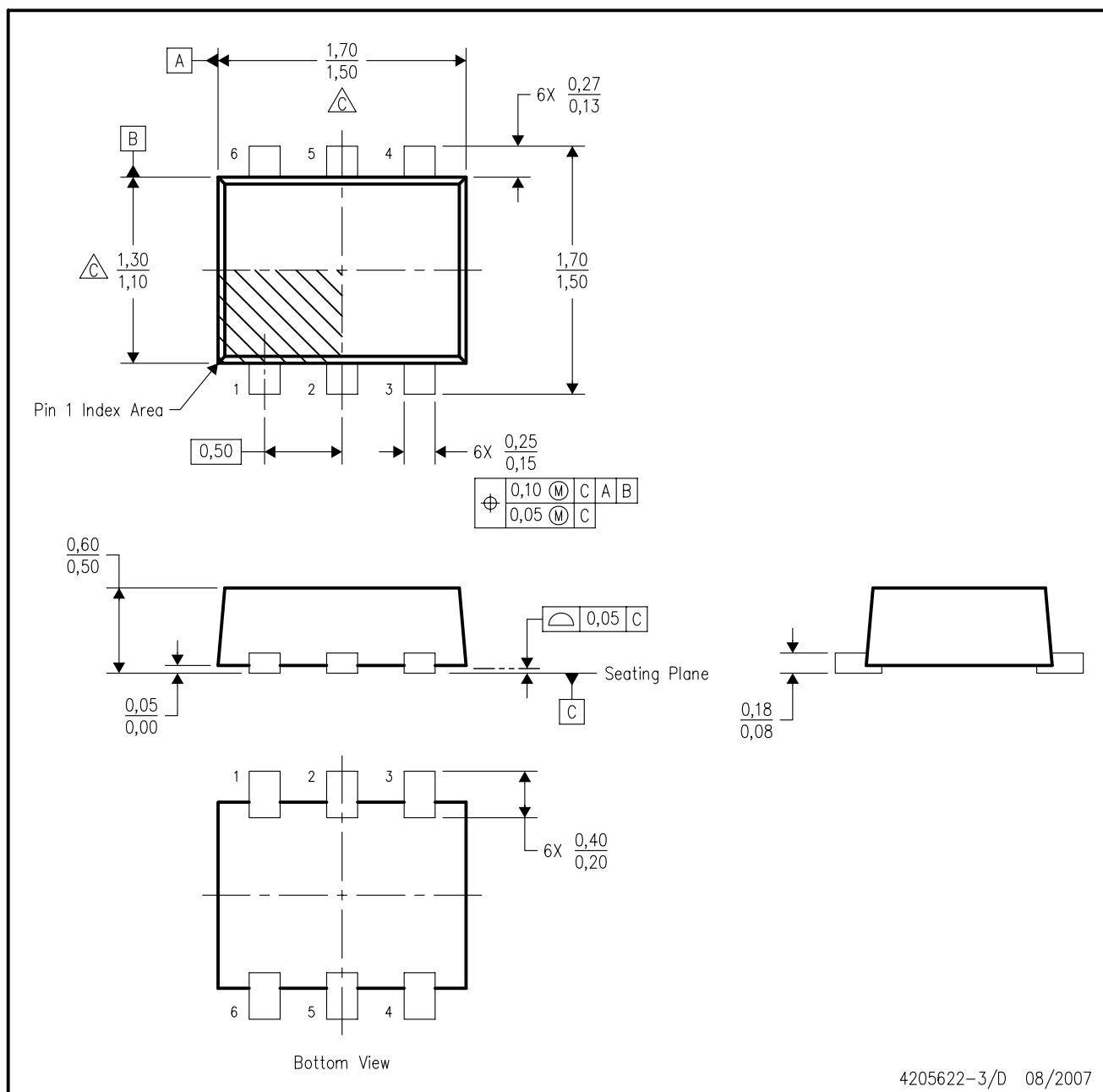

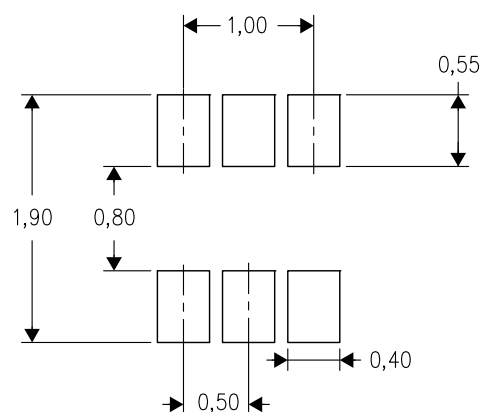

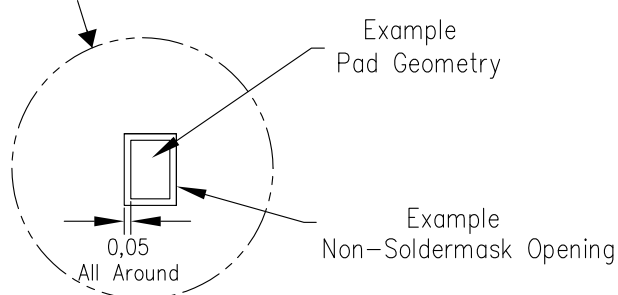
Example Board Layout

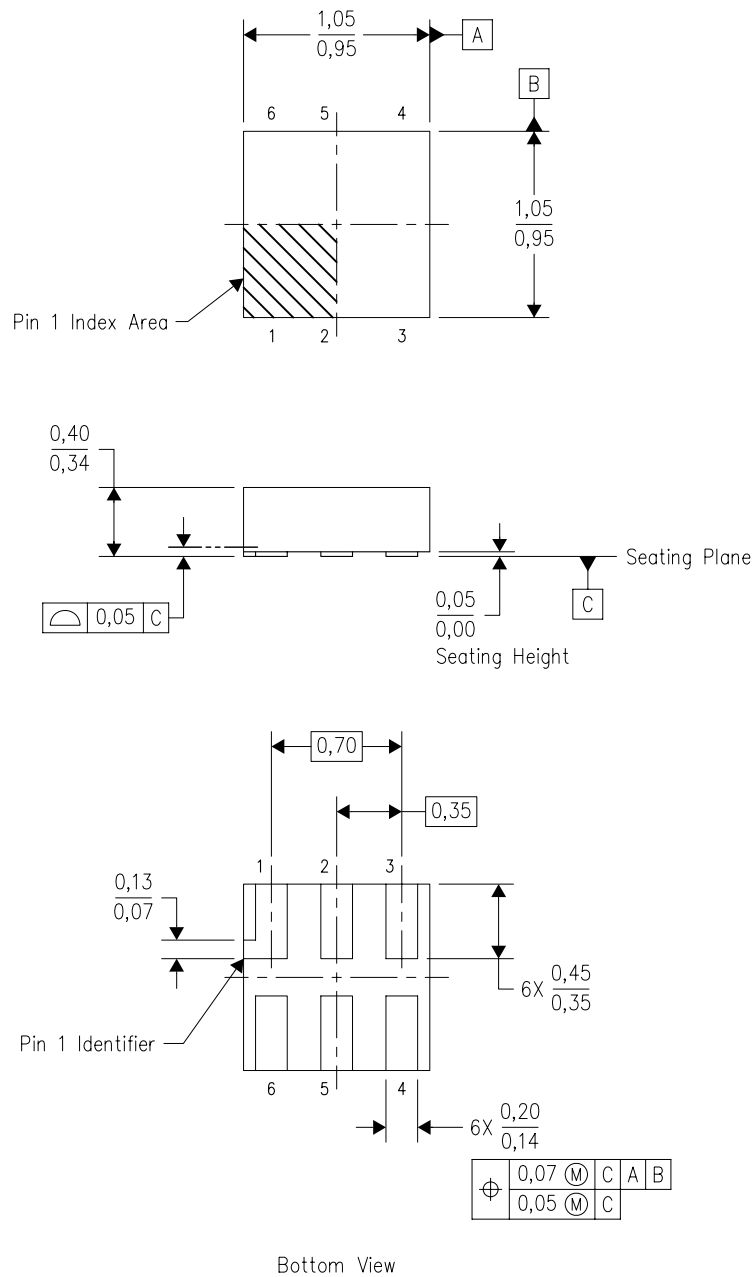

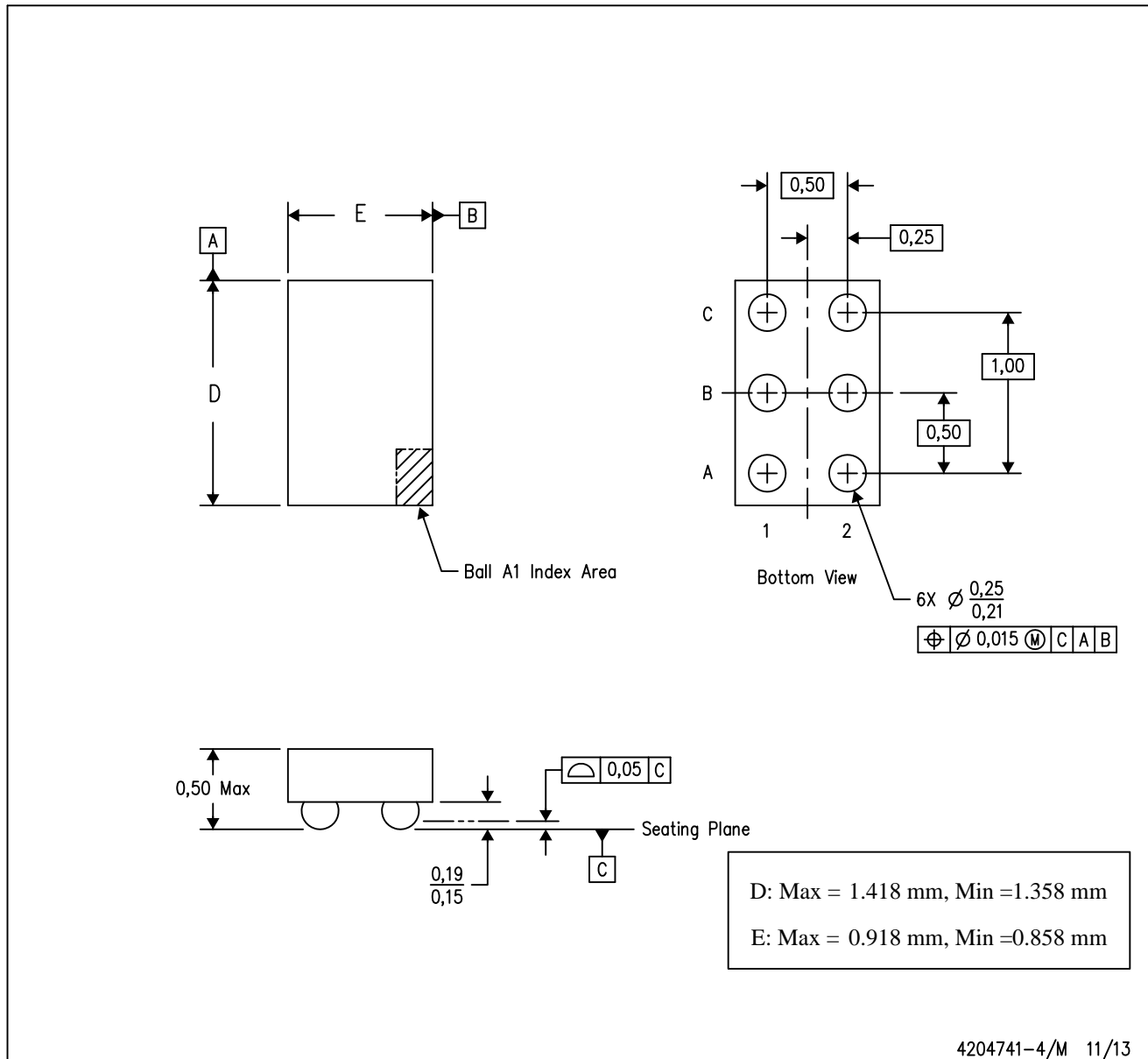
