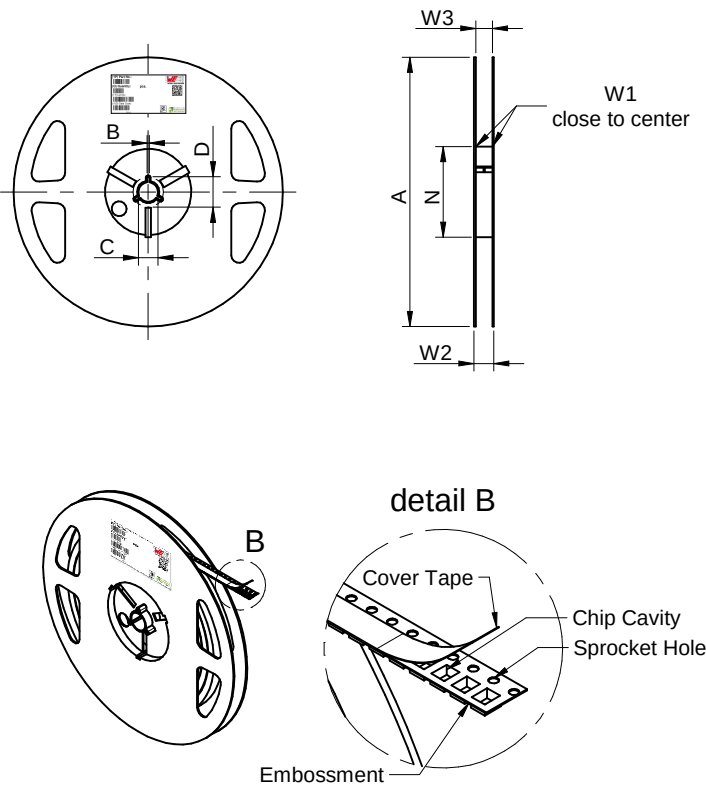

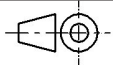

### Soldering:

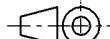
### Storage Conditions:

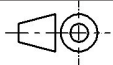
