Typical Inductance vs. Frequency Characteristics:



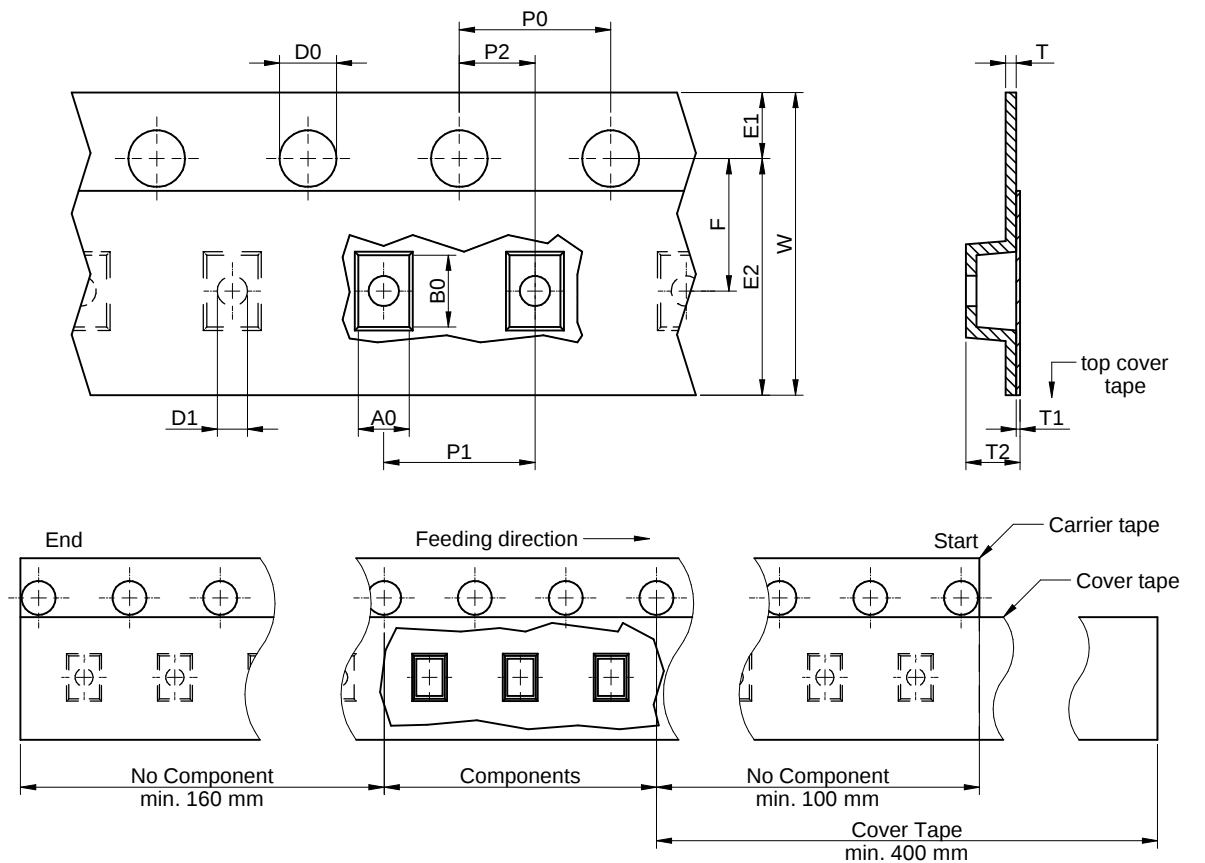
Q-Factor vs. Frequency:



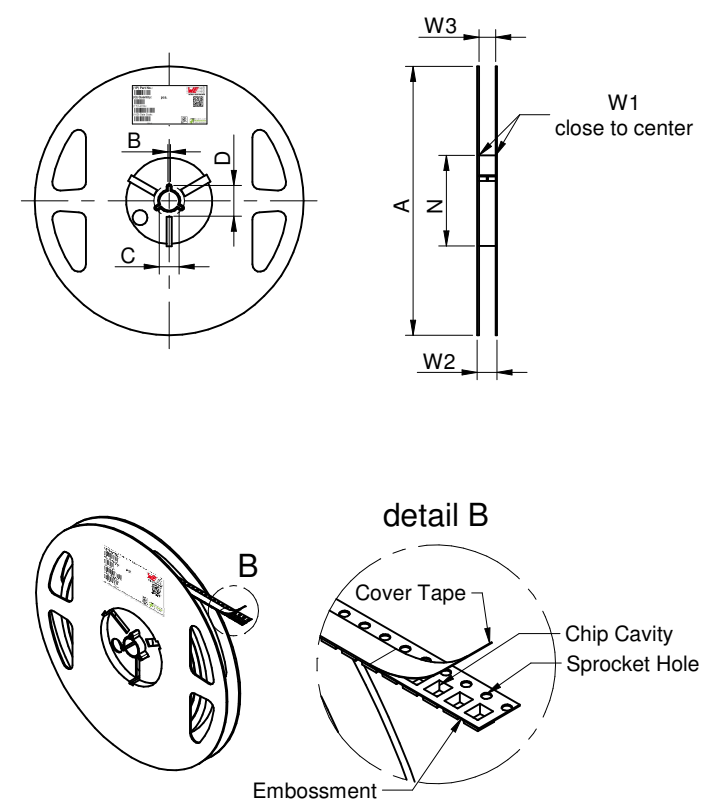

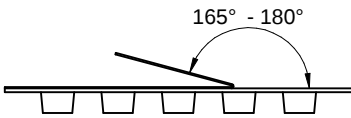

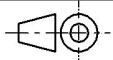

Product specific:

Soldering:

- The solder profile must comply with the technical product specifications. All other profiles will void the warranty.

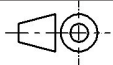
Packaging:

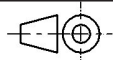
