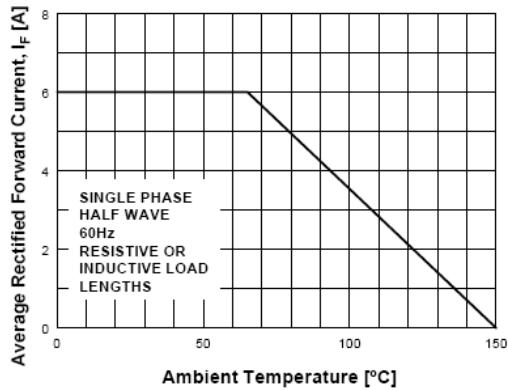



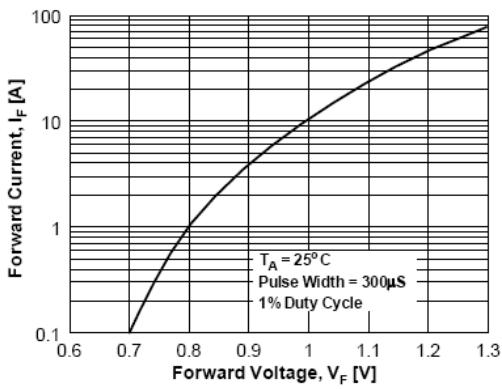
**Figure 1. Forward Current Derating Curve**




**Figure 2. Non-Repetitive Surge Current**
