

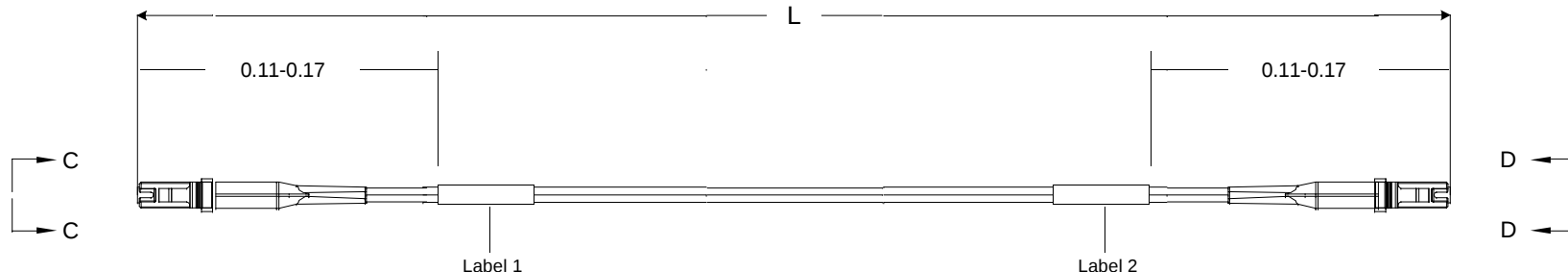

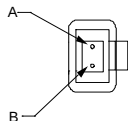

Fiber Path

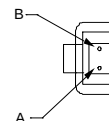
Fiber A -  - Fiber B

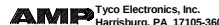
