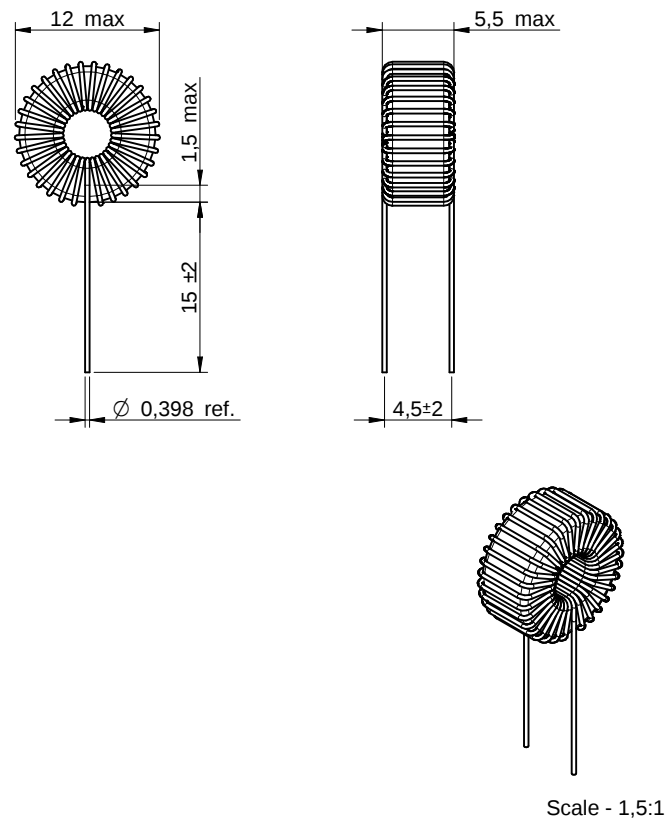

If the product is potted in customer applications, the potting material might shrink during and after hardening.
