



(Top View)






## ILLUSTRATION OF THE TEST CIRCUIT 2 ASSEMBLED ON EVALUATION BOARD






VOLTAGE GAIN vs. FREQUENCY



VOLTAGE GAIN vs. POWER-SAVE PIN APPLIED VOLTAGE


OUTPUT POWER (2 tones), IM<sub>3</sub> vs. INPUT POWER








INPUT RETURN LOSS vs. FREQUENCY




OUTPUT RETURN LOSS vs. FREQUENCY

ISOLATION vs. FREQUENCY




