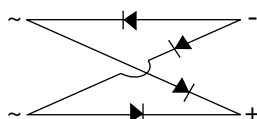
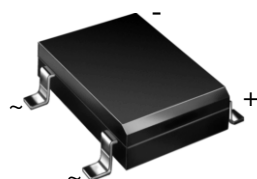

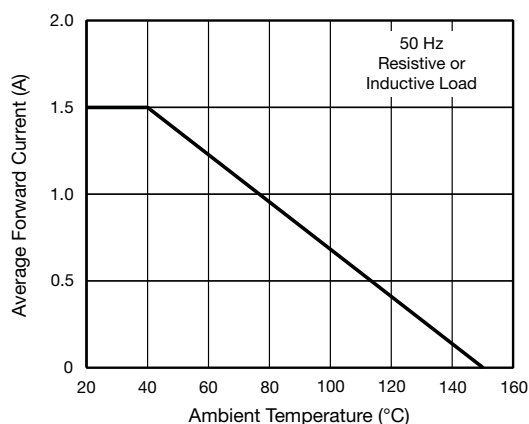

Fig. 1 - Forward Current Derating Curve Per Diode

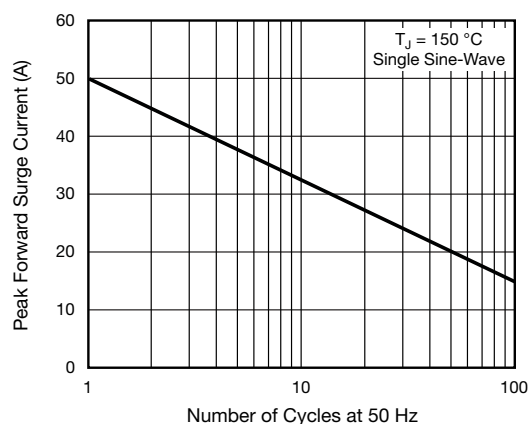
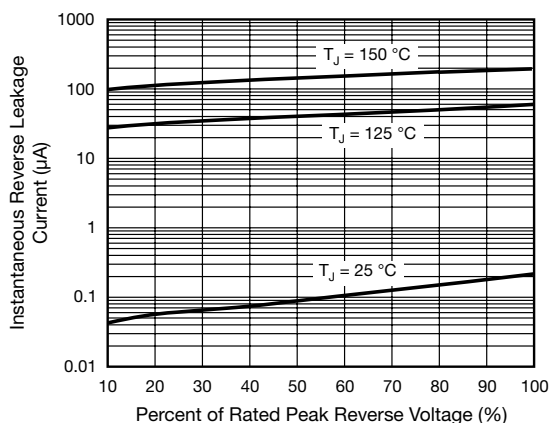
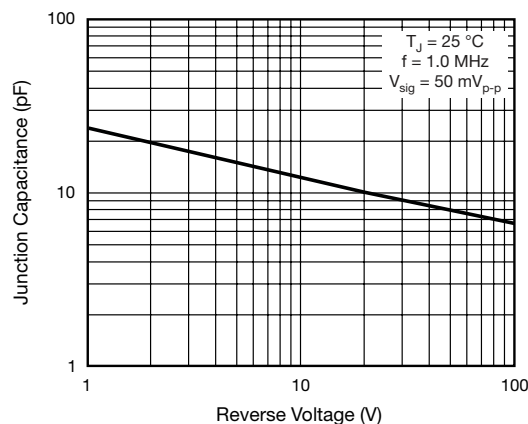
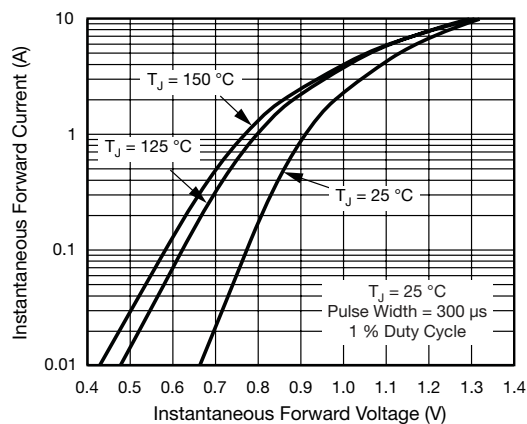
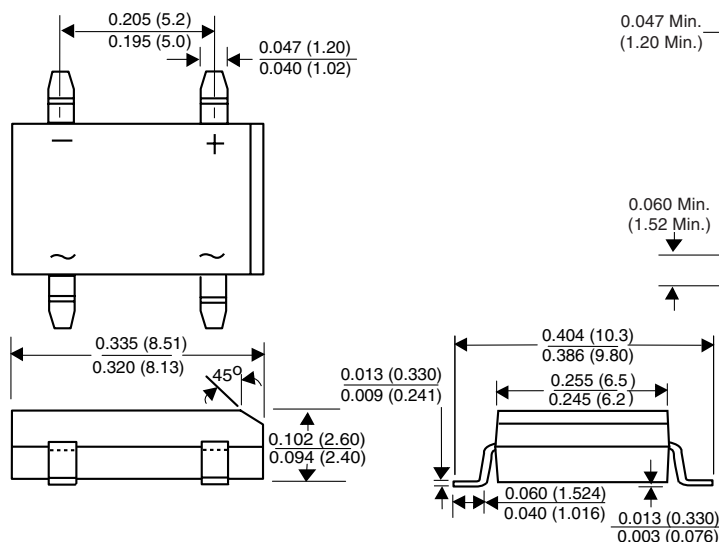


Fig. 2 - Maximum Non-Repetitive Peak Forward Surge Current Per Diode

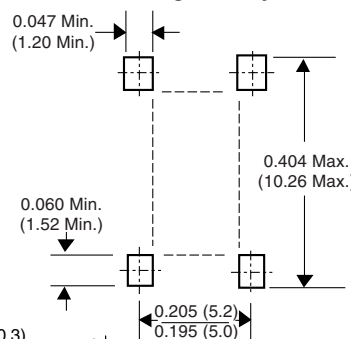


## PACKAGE OUTLINE DIMENSIONS in inches (millimeters)
