Forward Current vs. Forward Voltage:




Luminous Intensity vs. Forward Current:




The bin is defined on intensity, chromaticity coordinate or wavelength and forward voltage. In order to ensure highest availability, the reel binning of standard deliveries can vary. 

Product specific:


