




Figure 1. DC Current Gain




Figure 2. Collector-Emitter Saturation Voltage




Figure 3. Base-Emitter Saturation Voltage




Figure 4. Base-Emitter On Voltage




Figure 5. Collector-Base Cutoff Current




Figure 6. Emitter-Base Cutoff Current




Figure 7. Output Capacitance




Figure 8. Input Capacitance







Figure 9. Transient Thermal Resistance
