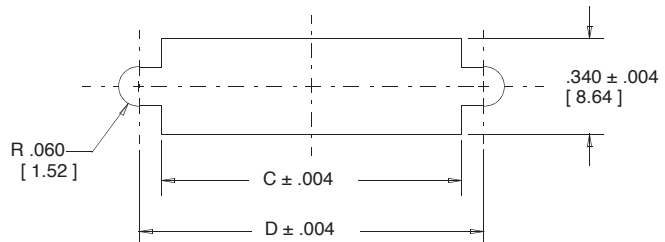

Recommended Board Layout Viewed from Connector Side

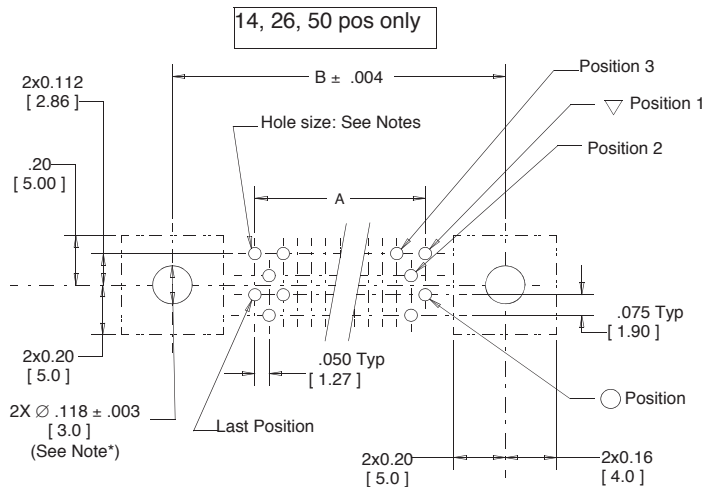
