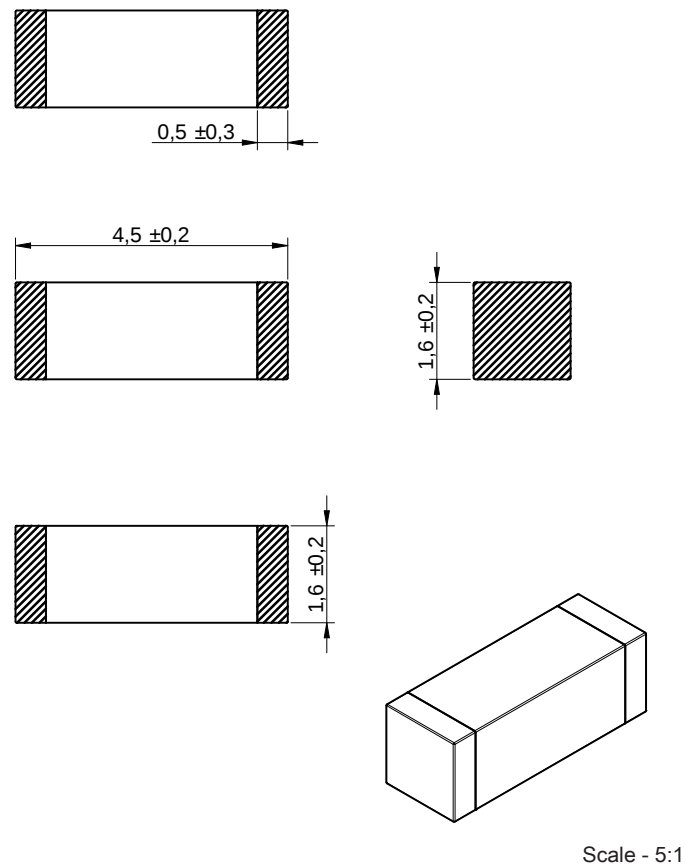

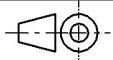
Storage Conditions:
