



Its trr is less than 100nsec and the reverse dv/dt immunity is 15V/ns while normal planar MOSFETs have over 200nsec and 4.5V/nsec respectively. Therefore, it can remove additional component and improve system reliability in certain applications in which the performance of MOSFET's body diode is significant. This device family is suitable for switching power converter applications such as power factor correction (PFC), flat panel display (FPD) TV power, ATX and electronic lamp ballasts.

Figure 1. On-Region Characteristics




Figure 3. On-Resistance Variation vs.

Drain Current and Gate Voltage




Figure 5. Capacitance Characteristics




Figure 2. Transfer Characteristics




Figure 4. Body Diode Forward Voltage Variation vs. Source Current and Temperature





Figure 6. Gate Charge Characteristics

Figure 7. Breakdown Voltage Variation vs. Temperature




Figure 8. Maximum Safe Operating Area




Figure 9. Maximum Drain Current vs. Case Temperature





Figure 10. Transient Thermal Response Curve






Figure 11. Gate Charge Test Circuit & Waveform




Figure 12. Resistive Switching Test Circuit & Waveforms

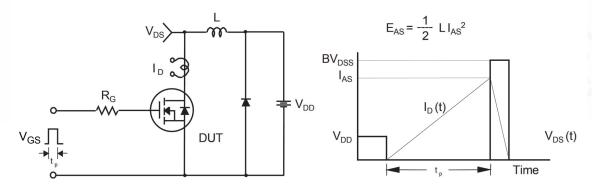


Figure 13. Unclamped Inductive Switching Test Circuit & Waveforms




Figure 14. Peak Diode Recovery dv/dt Test Circuit & Waveforms




Figure 15. TO220, Molded, 3-Lead, Full Pack, EIAJ SC91, Straight Lead
