

## LM320L/LM79LXXAC/LM13121 Series 3-Terminal Negative Regulators

### **General Description**

The LM320L/LM79LXXAC/LM13121 dual marked series of 3-terminal negative voltage regulators features fixed output voltages of –5V, –12V, and –15V with output current capabilities in excess of 100mA. These devices were designed using the latest computer techniques for optimizing the packaged IC thermal/electrical performance. The LM79LXXAC series, even when combined with a minimum output compensation capacitor of 0.1µF, exhibits an excellent transient response, a maximum line regulation of 0.07%  $V_{\rm O}/V$ , and a maximum load regulation of 0.01%  $V_{\rm O}/mA$ .

The LM320L/LM79LXXAC/LM13121 series also includes, as self-protection circuitry: safe operating area circuitry for output transistor power dissipation limiting, a temperature independent short circuit current limit for peak output current limiting, and a thermal shutdown circuit to prevent excessive junction temperature. Although designed primarily as fixed voltage regulators, these devices may be combined with simple external circuitry for boosted and/or adjustable voltages and currents. The LM79LXXAC series is available in


the 3-lead TO-92 package, 8-lead SOIC package, and the 6-Bump micro SMD package. The LM320L series is available in the 3-lead TO-92 package.

For output voltage other than -5V, -12V and -15V, the LM137L series provides an output voltage range from 1.2V to 47V.

#### **Features**


- Preset output voltage error is less than ±5% overload, line and temperature
- Specified at an output current of 100mA
- Easily compensated with a small 0.1µF output capacitor
- Internal short-circuit, thermal and safe operating area protection
- Easily adjustable to higher output voltages
- Maximum line regulation less than 0.07% V<sub>OUT</sub>/V
- Maximum load regulation less than 0.01% V<sub>OUT</sub>/mA


#### Adjustable Output Regulator



 $-V_0 = -5V - (5V/R1 + I_Q) \cdot R2,$ 5V/R1 > 3 I<sub>Q</sub>



#### TO-92 Plastic Package (Z)




**Bottom View**






Maximum Average Power Dissipation (TO-92)




#### **Short Circuit Output Current**




#### Ripple Rejection



## Peak Output Current




#### **Dropout Voltage**


## Output Voltage vs. Temperature (Normalized to 1V @ 25°C)






#### ±15V, 100mA Dual Power Supply








SOIC Package (M) **NS Package Number M08A** 




Molded Offset TO-92 (Z) **NS Package Number Z03A**
