

## Description

The ZXTR2108FQ monolithically integrates a transistor, zener diode and resistor to function as a linear regulator. The device regulates with an 8V nominal output at 15mA. It is designed for use in high voltage applications where standard linear regulators cannot be used. This function is fully integrated into a SOT23 package, minimizing PCB area and reducing the number of components when compared with a multi-chip discrete solution.

This linear regulator is designed to meet the stringent requirements of automotive applications.



Internal Device Schematic






**Typical Application Circuit**


Example of a 8V regulated supply from a nominal 24V for powering a Controller IC.



Pin Name	Pin Function	Notes
$V_{\text{IN}}$	Input Supply	Input voltage can vary from $-0.3\text{V}$ to $60\text{V}$ with respect to GND; for $V_{\text{OUT}}$ regulated then $10\text{V} \leq V_{\text{IN}} \leq 60\text{V}$ . It is recommended to connect a $1\mu\text{F}$ capacitor to GND.
GND	Power Ground	This pin should be tied to the system ground.
$V_{\text{OUT}}$	Voltage Output	Outputs a regulated 8V when $10\text{V} \leq V_{\text{IN}} \leq 60\text{V}$ . When $V_{\text{IN}} < 10\text{V}$ , then $V_{\text{OUT}}$ maximum = $V_{\text{IN}} - 1\text{V}$ . The pin can be pulled high to a maximum of $+13\text{V}$ with respect to GND, or $+5\text{V}$ with respect to $V_{\text{IN}}$ , whichever is lower. It is recommended to connect a $10\mu\text{F}$ capacitor to GND and a minimum of $10\mu\text{A}$ to be drawn from $V_{\text{OUT}}$ to maintain regulation.




**Line transient response**




**Load transient response**




**Line Regulation (Note 16)**




