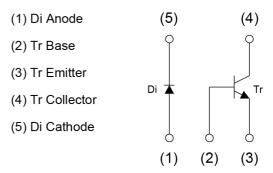

Reverse Voltage

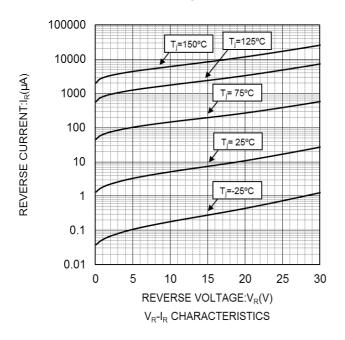


Fig.2 Forward Current vs. Forward Voltage

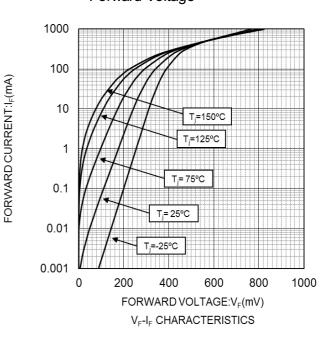
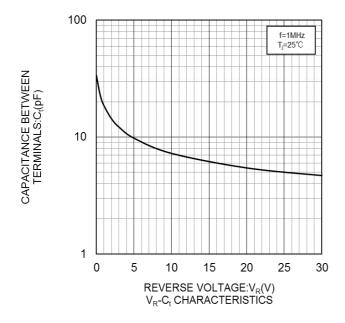


Fig.3 Capacitance Between Terminals vs. Reverse Voltage

Fig.4 Ground Emitter Propagation Characteristics

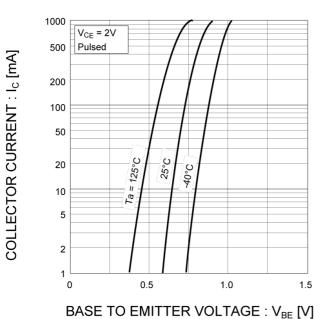
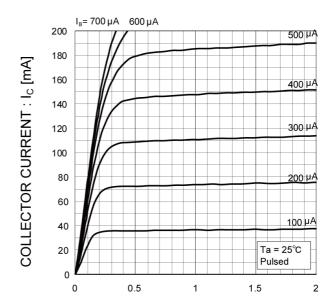


Fig.5 Typical Output Characteristics

Fig.6 DC Current Gain vs. Collector Current (I)

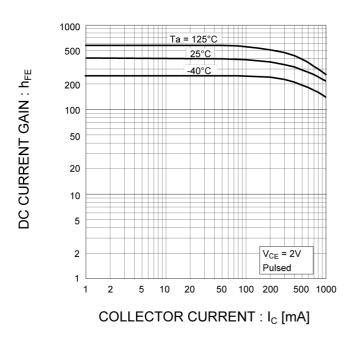
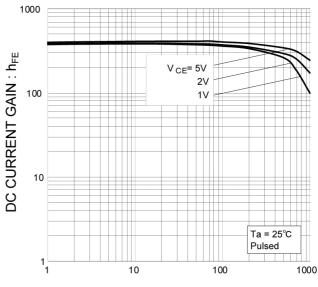


Fig.7 DC Current Gain vs. Collector Current (II)

Fig.8 Collector-Emitter Saturation Voltage vs. Collector Current (I)

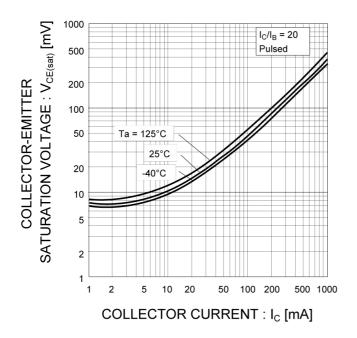


Fig.9 Collector-Emitter Saturation
Voltage vs. Collector Current (II)

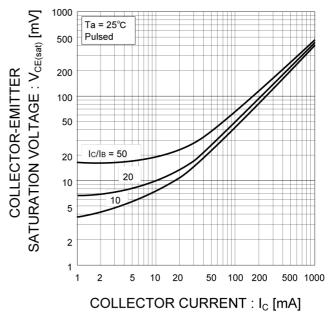


Fig.10 Base-Emitter Saturation Voltage vs. Collector Current

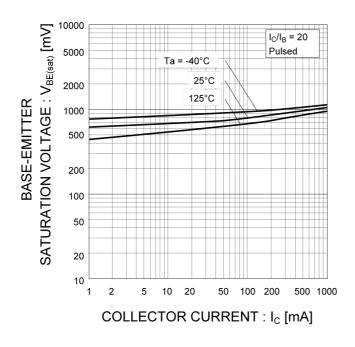
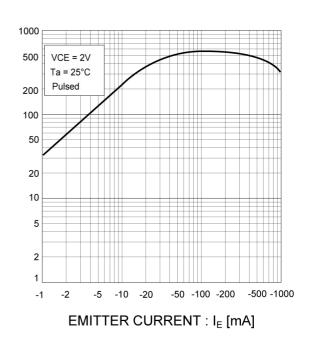


Fig.11 Gain Bandwidth Product vs. Emitter Current



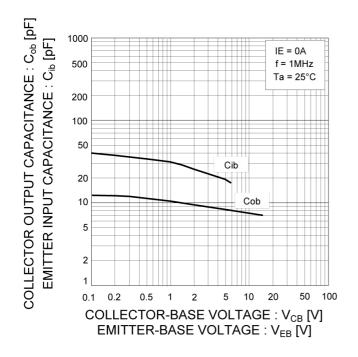

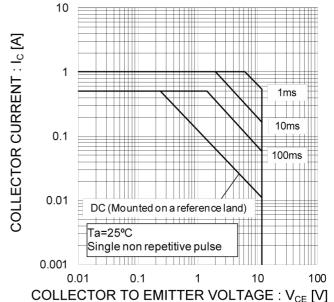

Collector-Base Voltage

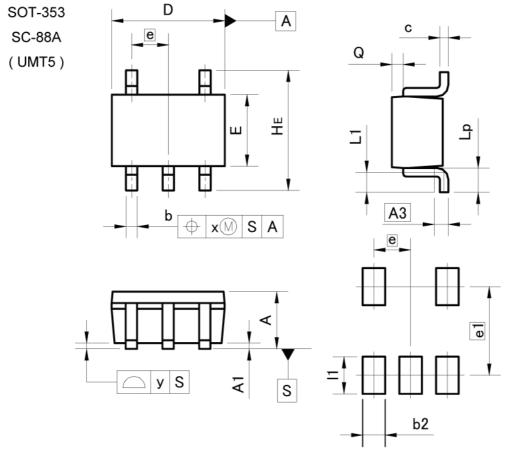
Fig.13 Safe Operating Area
