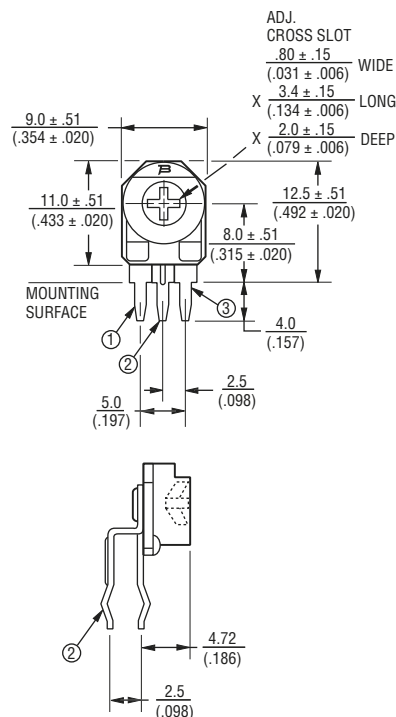

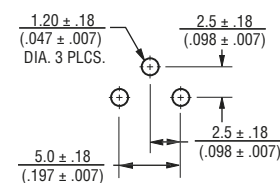
SUGGESTED PWB LAYOUT
