1. General description

The 74HC240; 74HCT240 is an 8-bit inverting buffer/line driver with 3-state outputs. The device can be used as two 4-bit buffers or one 8-bit buffer. The device features two output enables ($\overline{1OE}$ and $2OE$), each controlling four of the 3-state outputs. A HIGH on $n\overline{OE}$ causes the outputs to assume a high-impedance OFF-state. Inputs include clamp diodes. This enables the use of current limiting resistors to interface inputs to voltages in excess of V_{CC} .

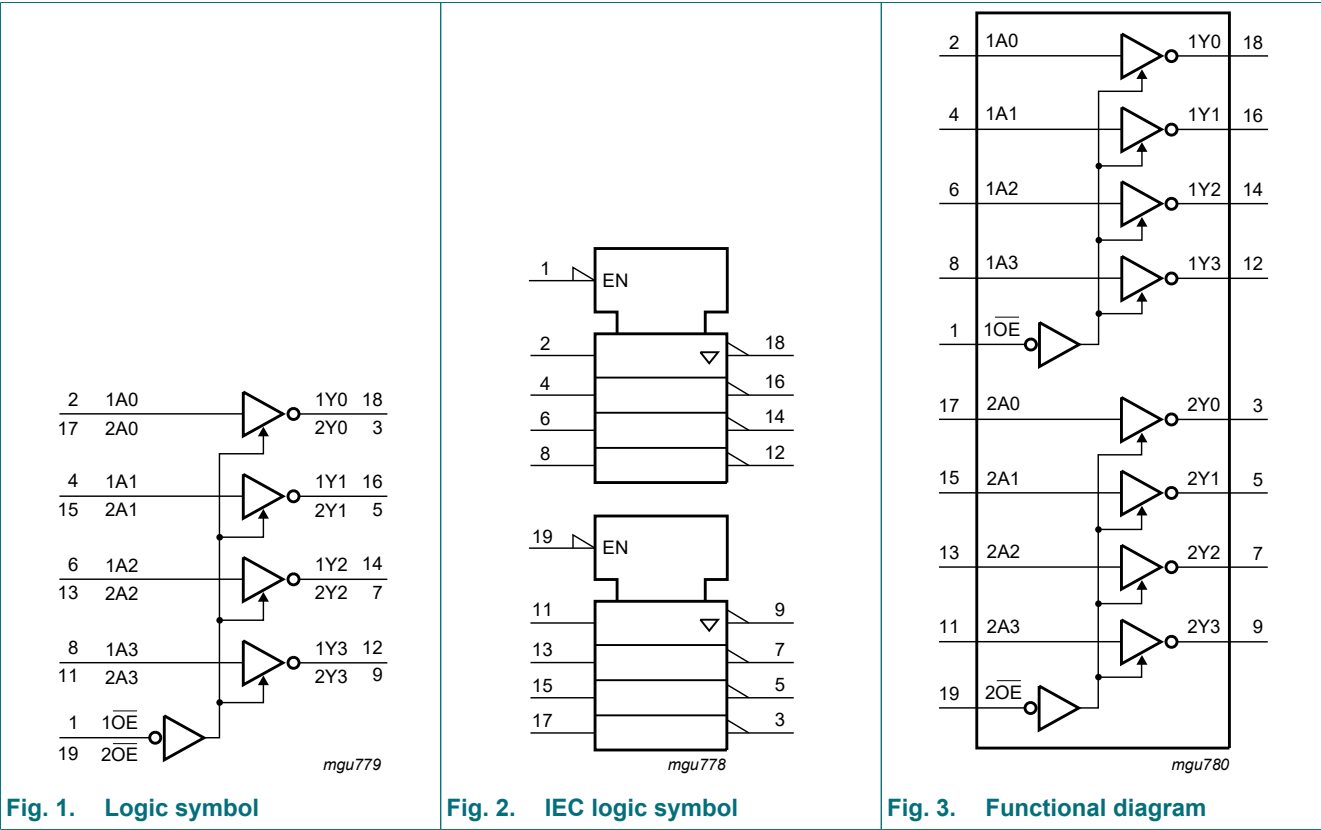

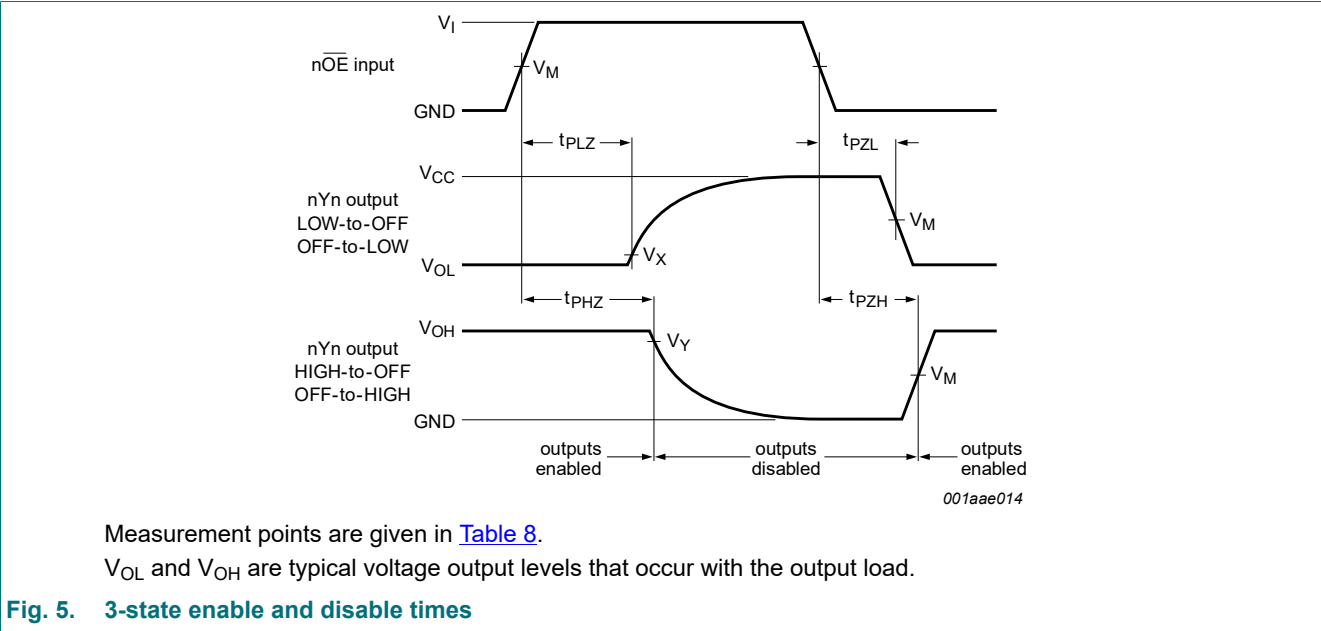
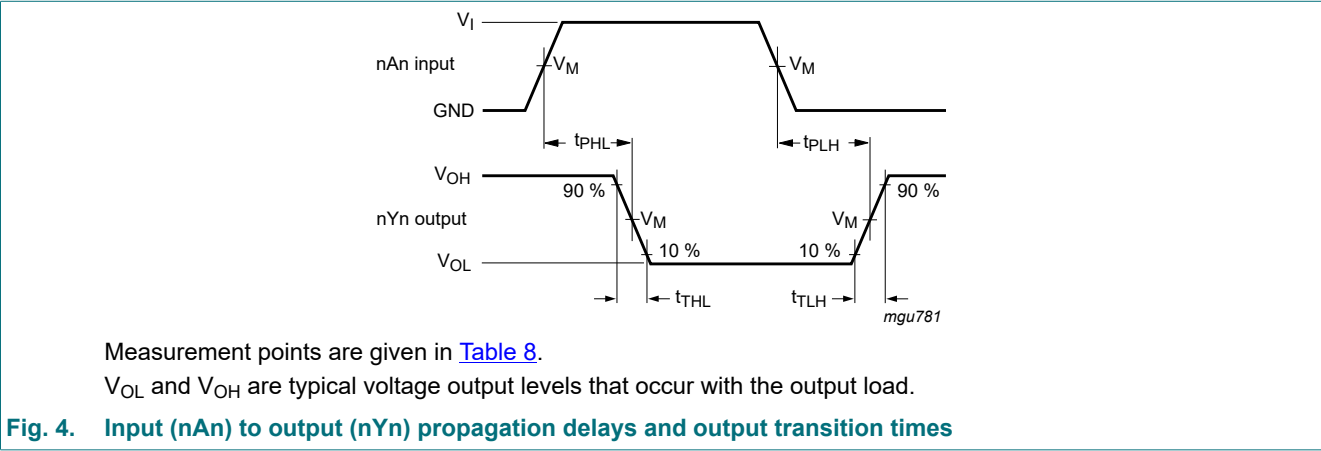

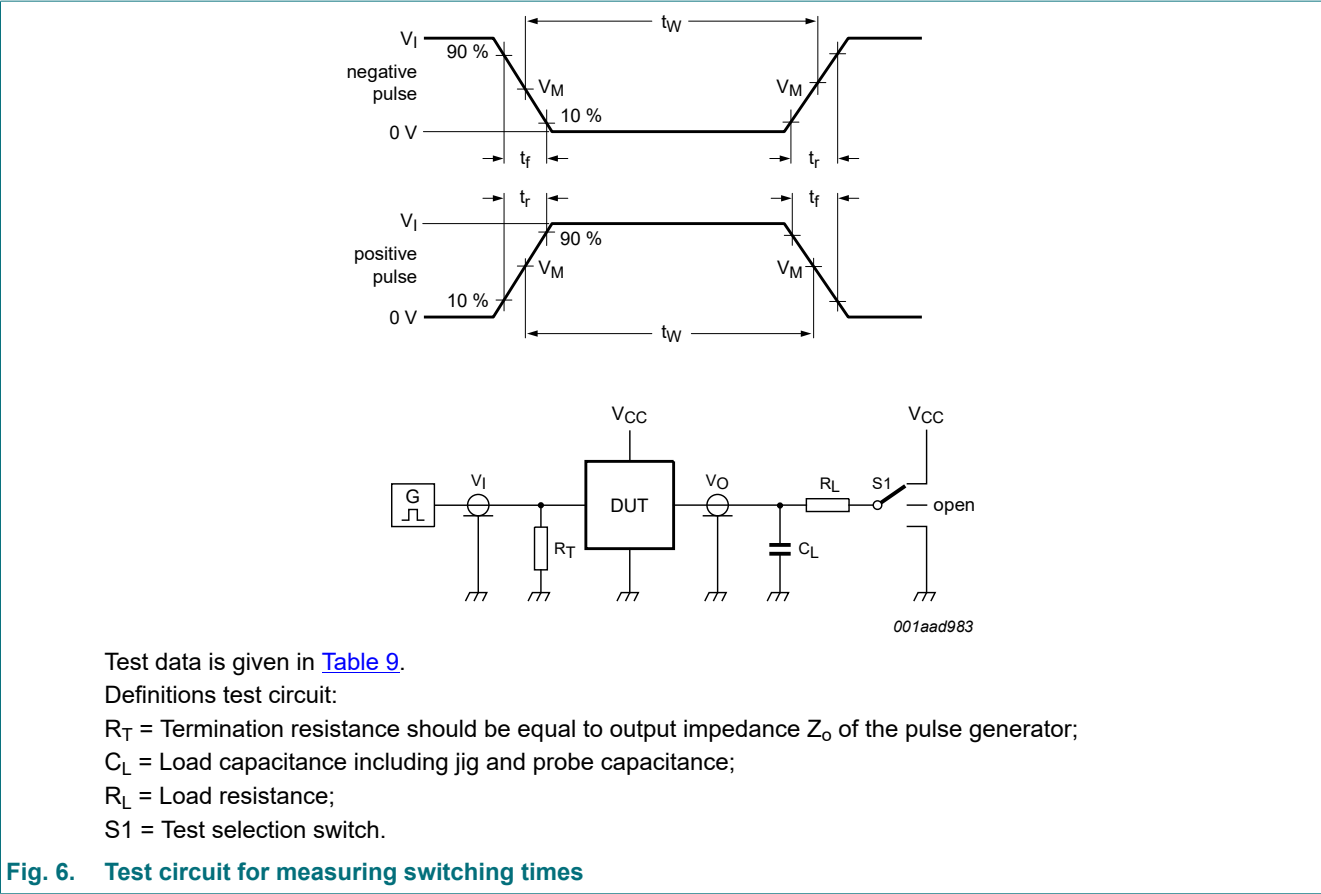


Fig. 6. Test circuit for measuring switching times

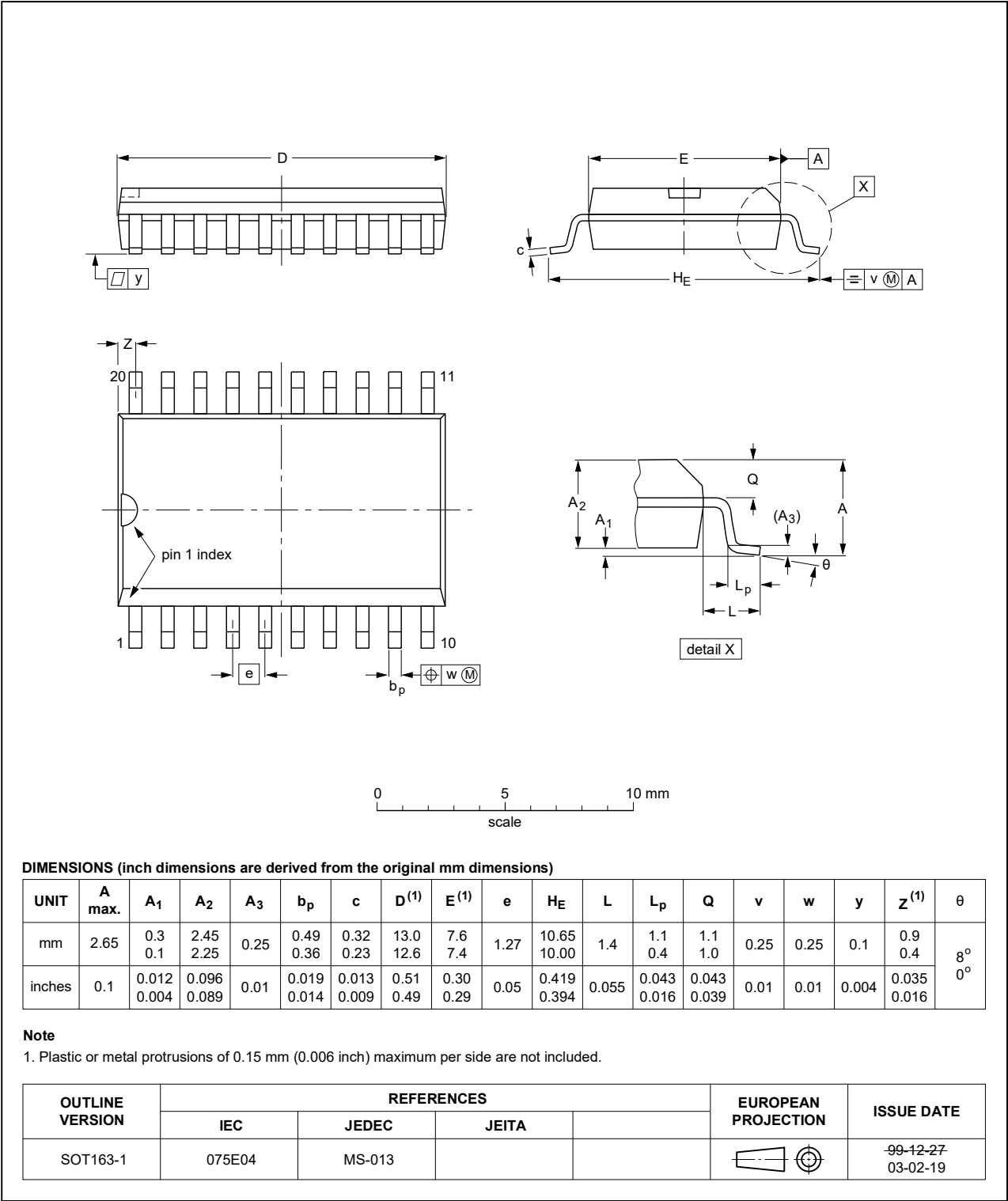


Fig. 7. Package outline SOT163-1 (SO20)

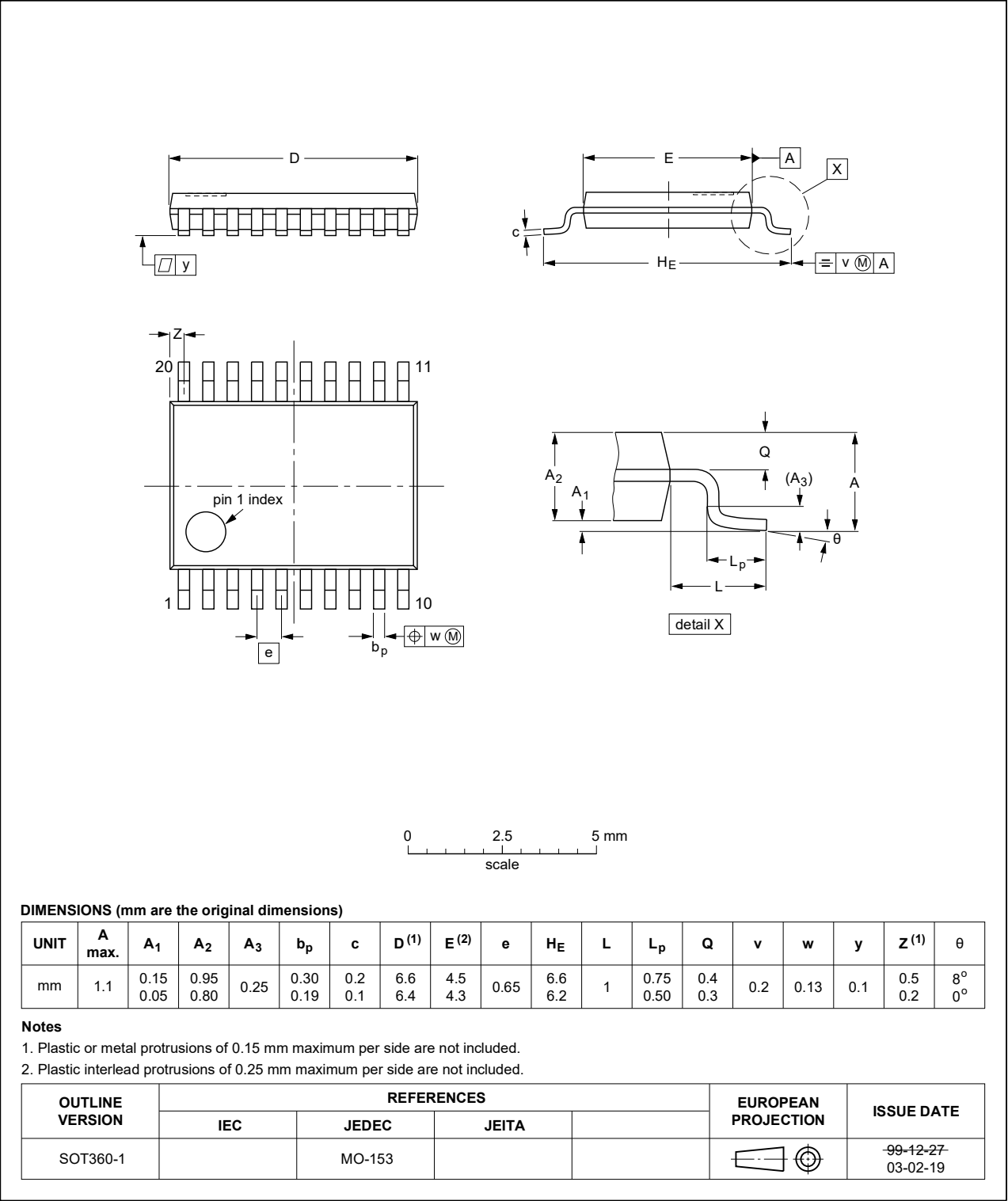


Fig. 8. Package outline SOT360-1 (TSSOP20)

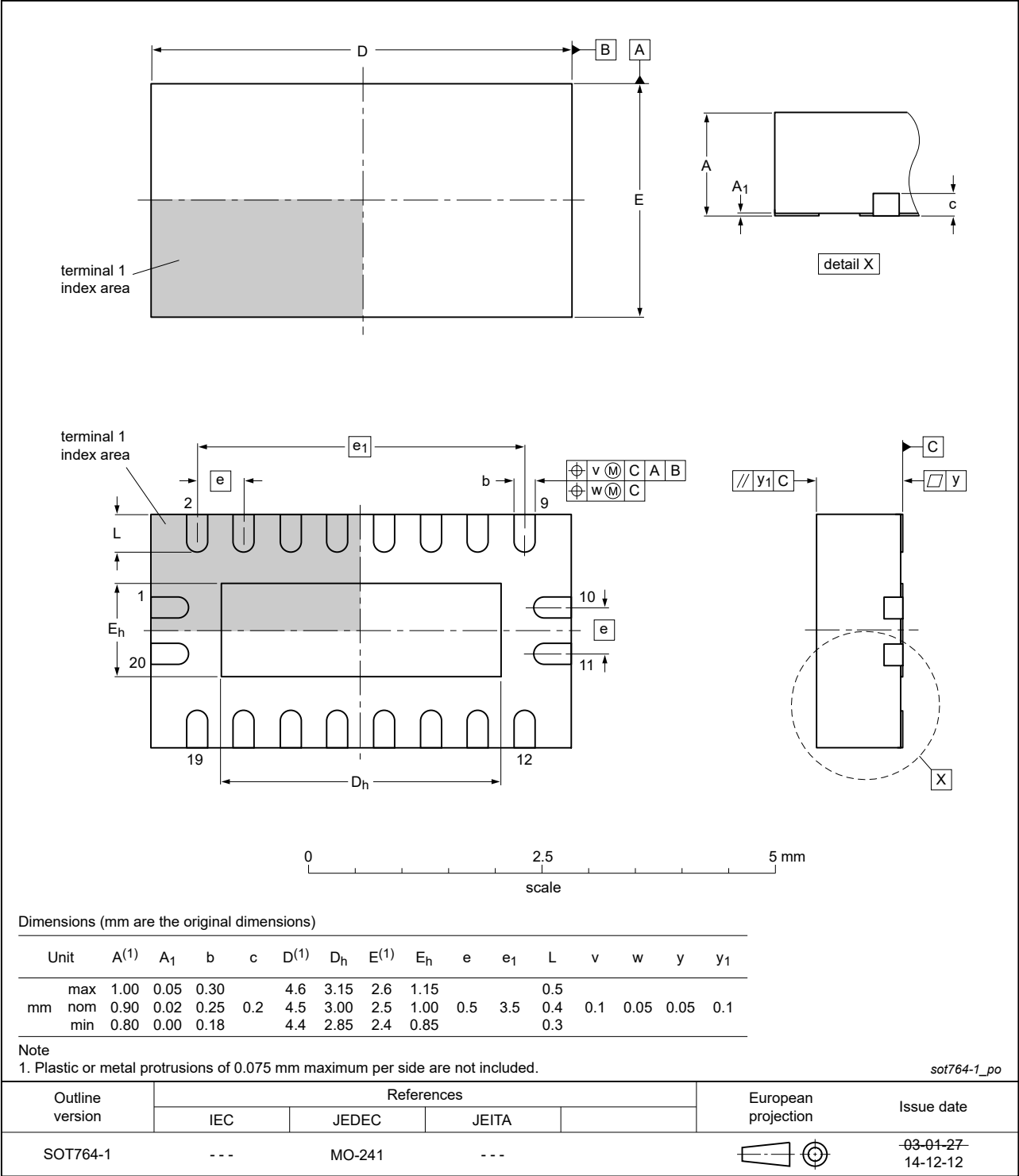


Fig. 9. Package outline SOT764-1 (DHVQFN20)
