C Schematic:



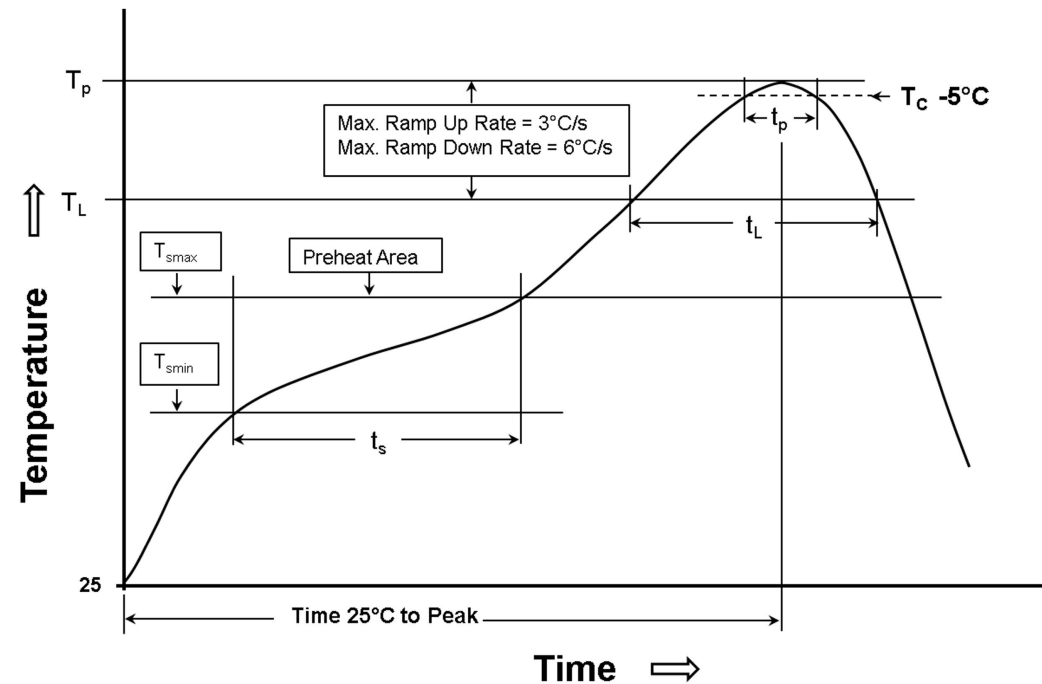

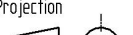
