




Luminous Intensity vs. Forward Current:



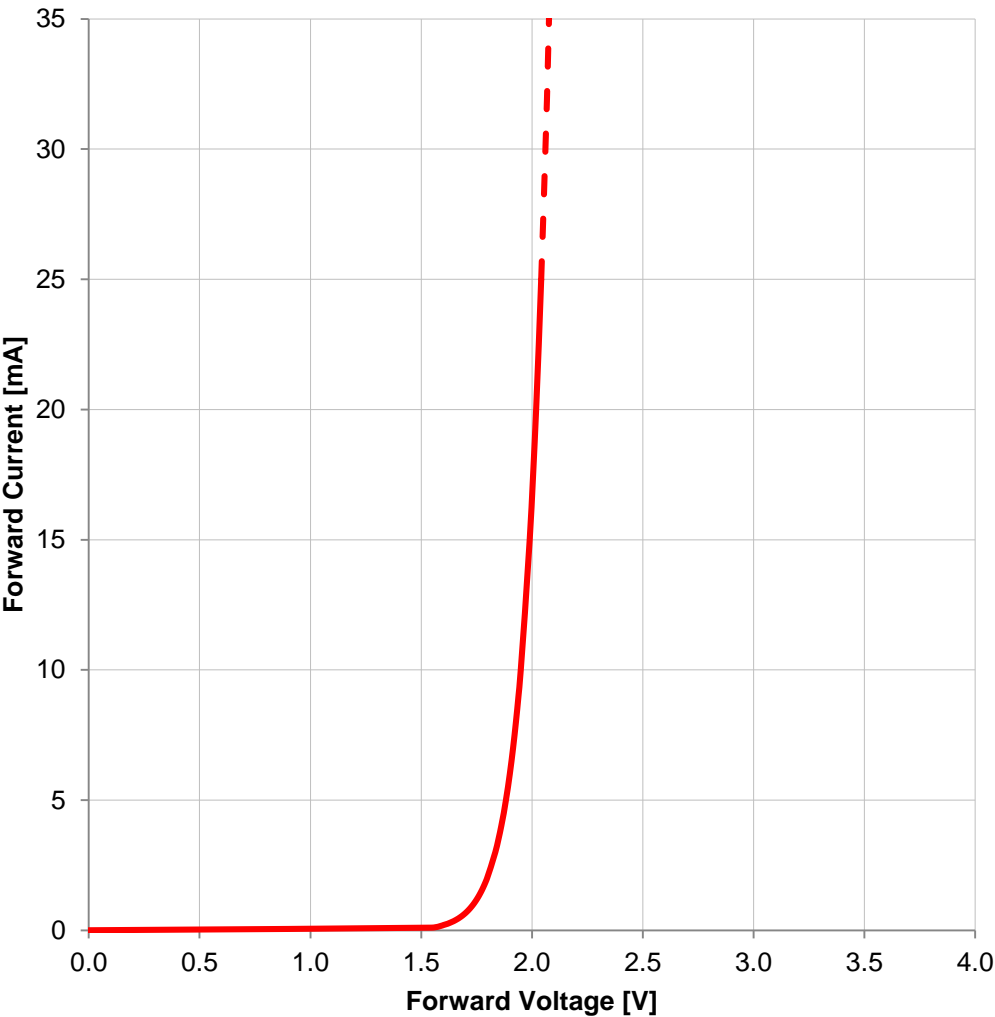

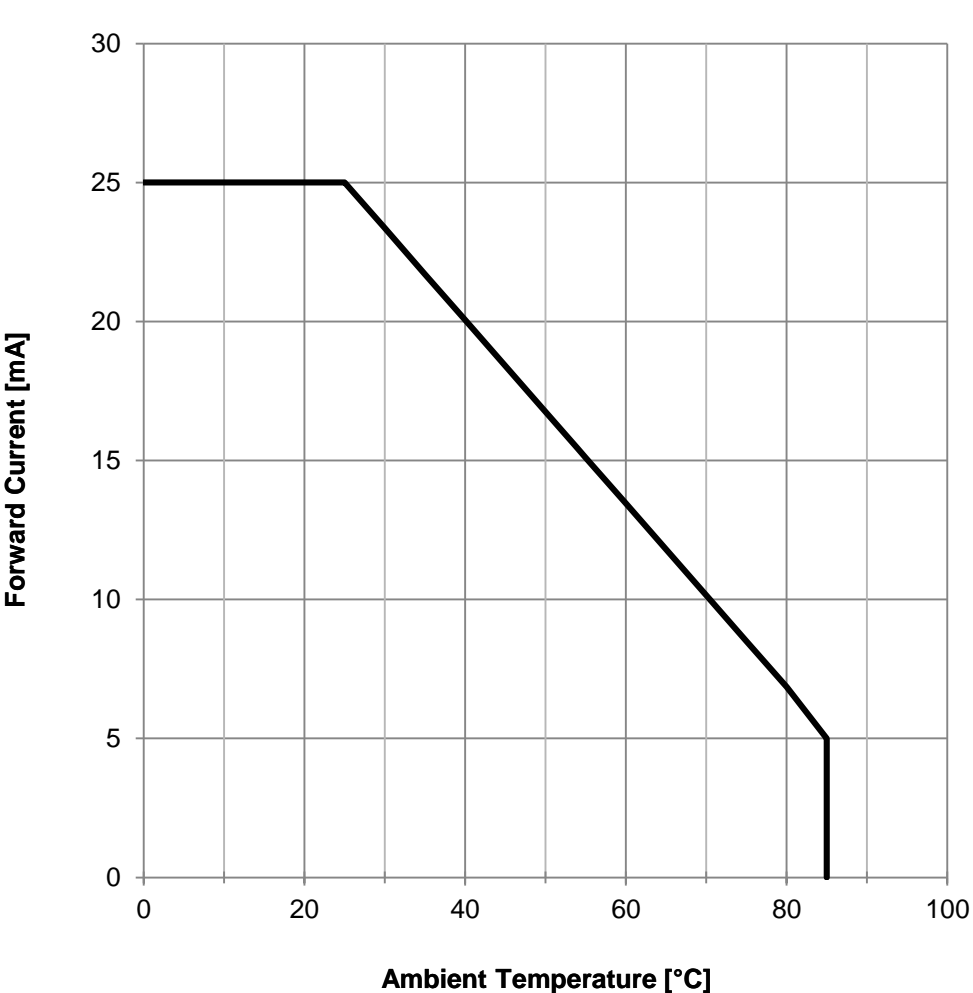



Forward Current vs. Forward Voltage:



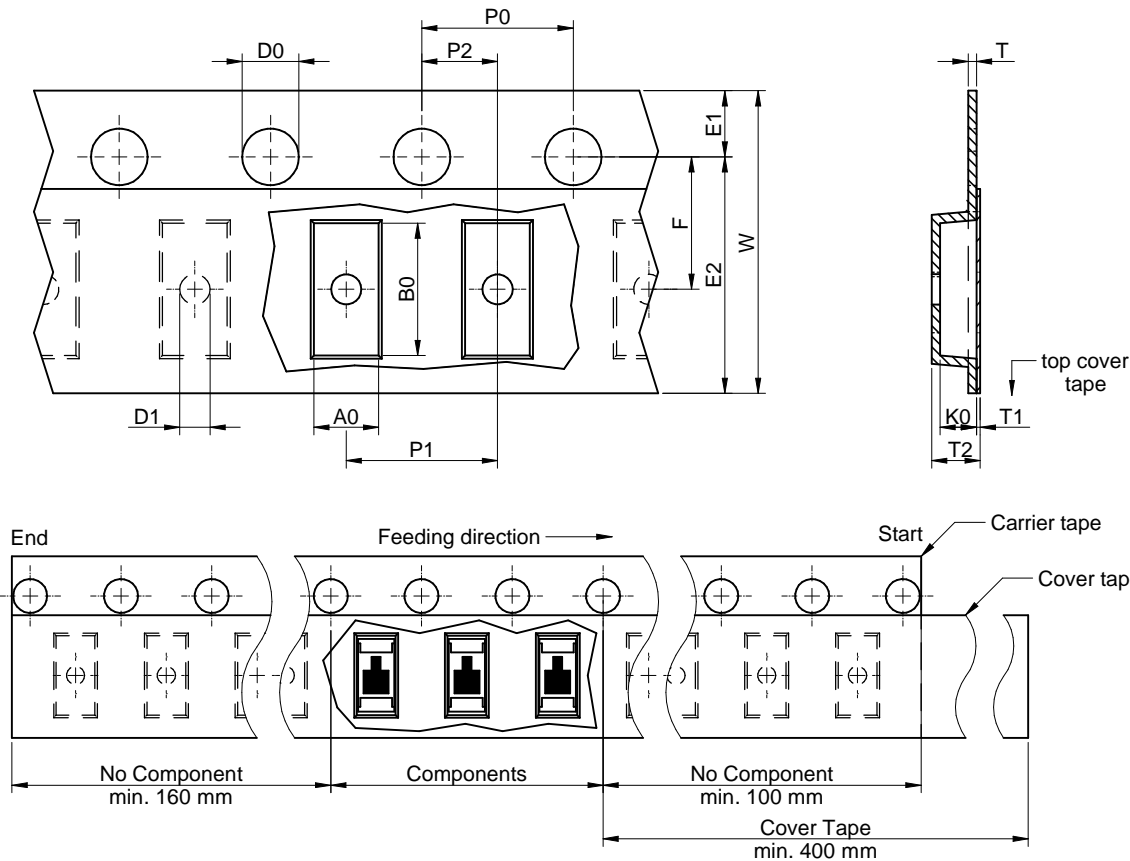
Derating Curve:

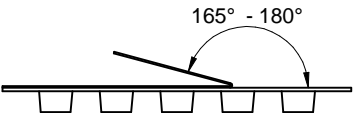



### Product specific:


