








TYPICAL CHARACTERISTICS ($T_A = 25$ °C, unless otherwise noted)




Surge-Drain Diode Forward Voltage


On-Resistance vs. Gate-to-Source Voltage






Threshold Voltage Variance vs. Temperature

I_{GSS} vs. Temperature








