






Figure 1. DC Current Gain




Figure 3. Input-Off Voltage




Figure 2. Input-On Voltage




Figure 4. Power Derating




Figure 5. 3-LEAD, SC70, EIAJ SC-70, 1.25 MM, WIDE (ACTIVE)
