General:

If the product is potted in customer applications, the potting material might shrink during and after hardening. The product is exposed to the pressure of the potting material with the effect that the ferrite body and termination is possibly damaged by this pressure and so the electrical as well as the mechanical characteristics are endangered to be affected. After the potting material is cured, the ferrite body and termination of the product have to be checked if any reduced electrical or mechanical functions or destructions have occurred.

Cleaning agents that are used to clean the customer application might damage or change the characteristics of the component, body, pins or termination.

- The soldering profile has to be complied with according to the technical reflow soldering specification, otherwise this will void the warranty.
- Wave soldering is only allowed after evaluation and approval.
- All products shall be used before the end of the period of 12 months based on the product date code, if not a 100% solderability can't be ensured.
- Violation of the technical product specifications such as exceeding the nominal rated current will void the warranty.
