






Safe Operating Area



Figure 1 Typical Collector Current vs. Collector-Emitter Voltage




Figure 2 Typical DC Current Gain vs. Collector Current




Figure 3 Typical Collector-Emitter Saturation Voltage vs. Collector Current




Figure 4 Typical Base-Emitter Turn-On Voltage vs. Collector Current




Figure 5 Typical Base-Emitter Saturation Voltage vs. Collector Current




Figure 6 Typical Capacitance Characteristics





Figure 7 Typical Gain-Bandwidth Product vs. Collector Current


