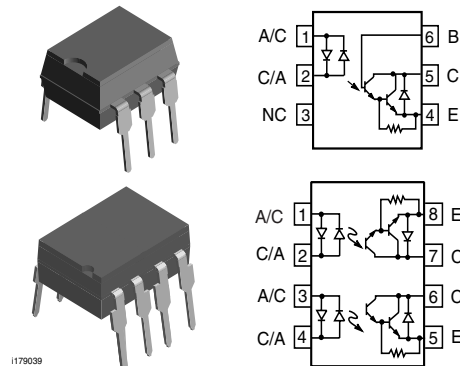

Description

The IL766/ ILD766 are bidirectional input optically coupled isolators. They consist of two Gallium Arsenide infrared emitting diodes coupled to a silicon NPN photodarlington per channel.

The IL766 is single channel optocouplers. The ILD766 has two isolated channels in a single DIP package.

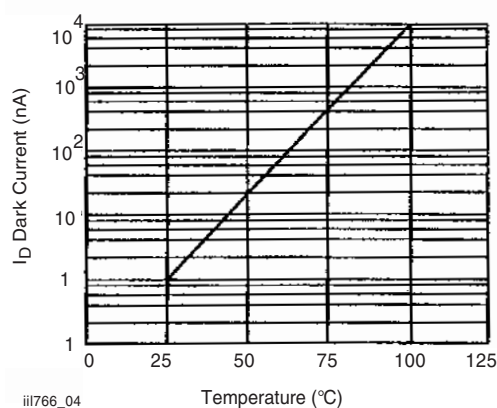

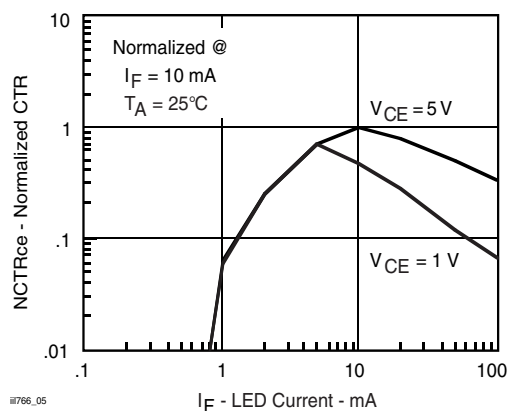


Fig. 5 Normalized CTR vs. Forward Current

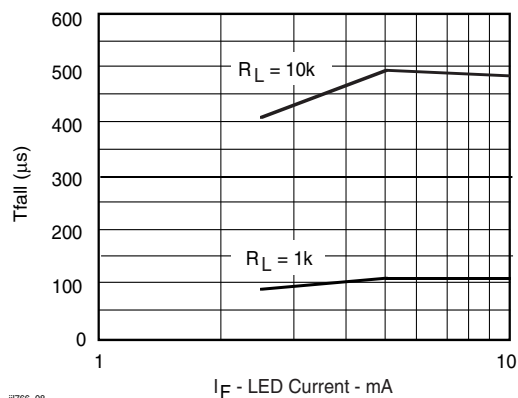


Fig. 8 t_{fall} vs. Forward Current

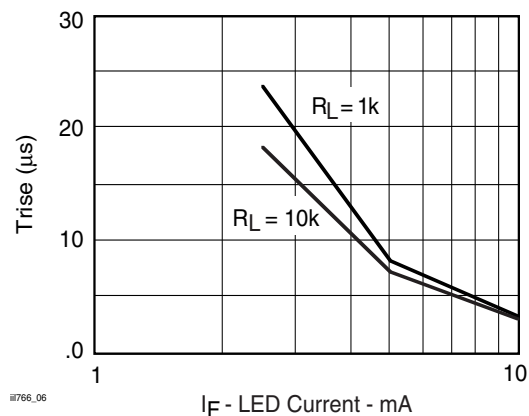


Fig. 6 t_r vs. Forward Current

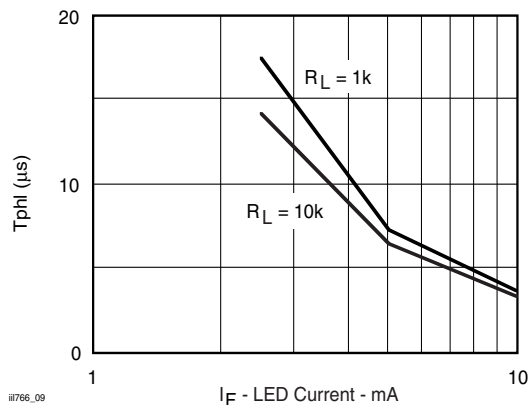


Fig. 9 t_{on} vs. Forward Current

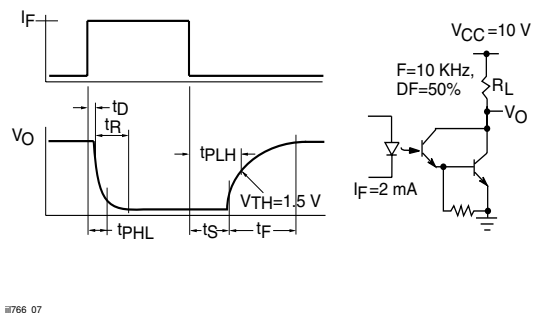


Fig. 7 Saturated Switching Characteristics Measurements- Schematic and Waveform

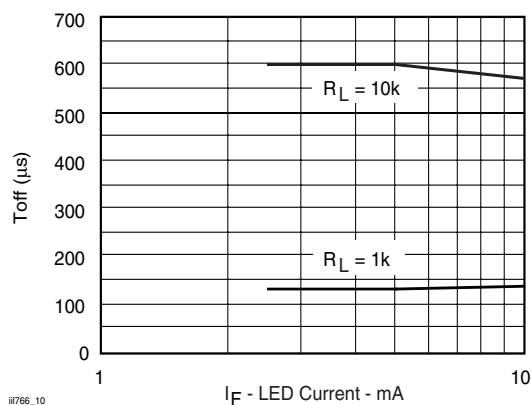


Fig. 10 t_{off} vs. Forward Current

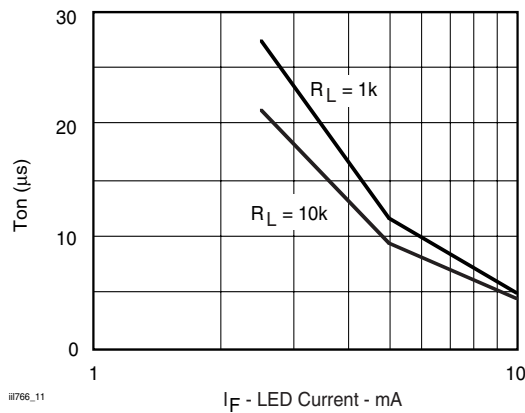


Fig. 11 t_{phl} vs. Forward Current

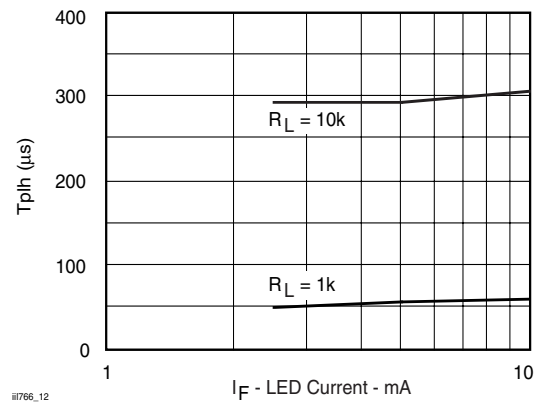
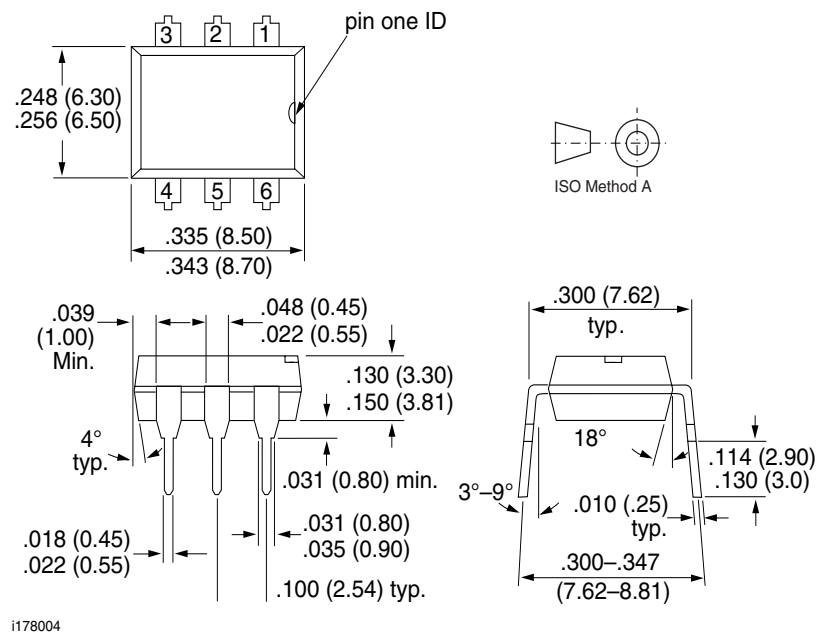
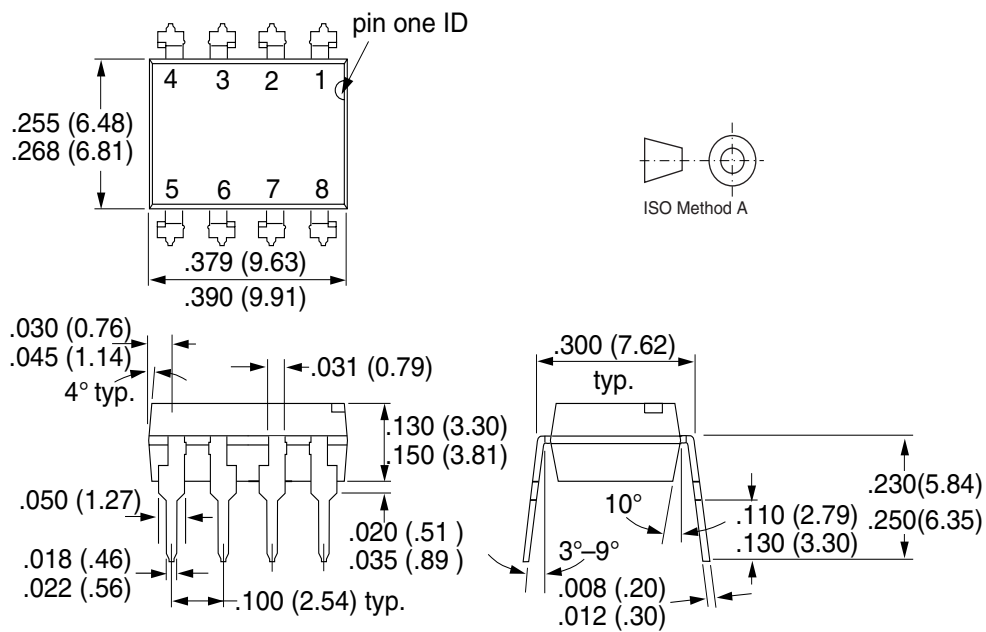


Fig. 12 t_{plh} vs. Forward Current

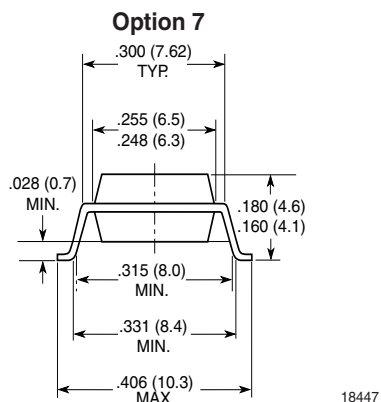
Package Dimensions in Inches (mm)
