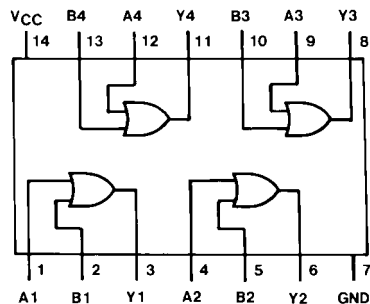

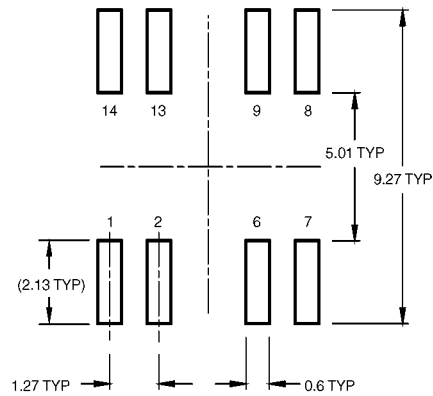

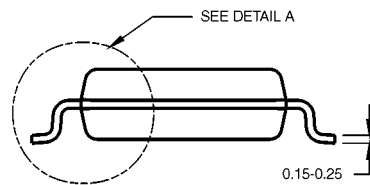

LAND PATTERN RECOMMENDATION



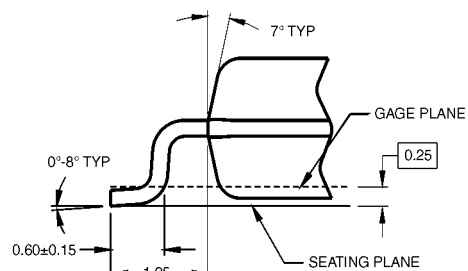
