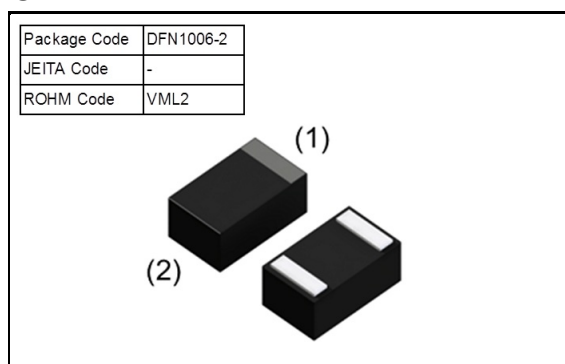

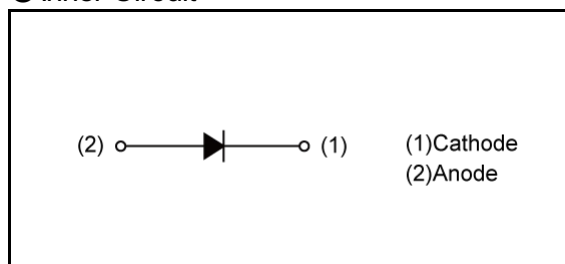
Attention

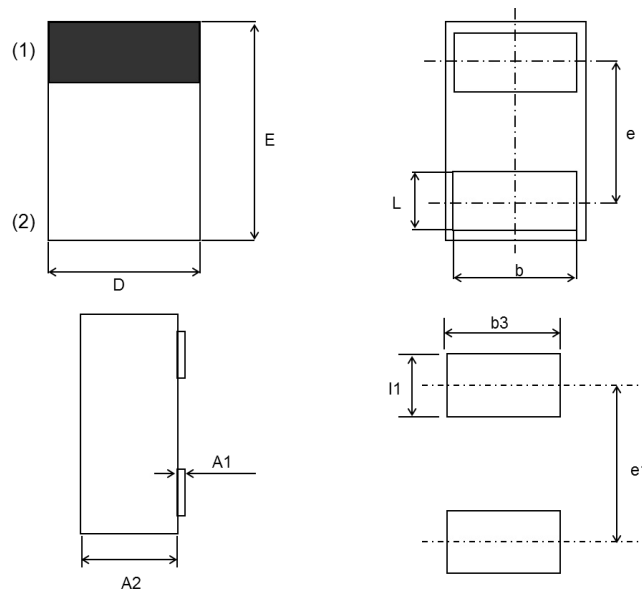

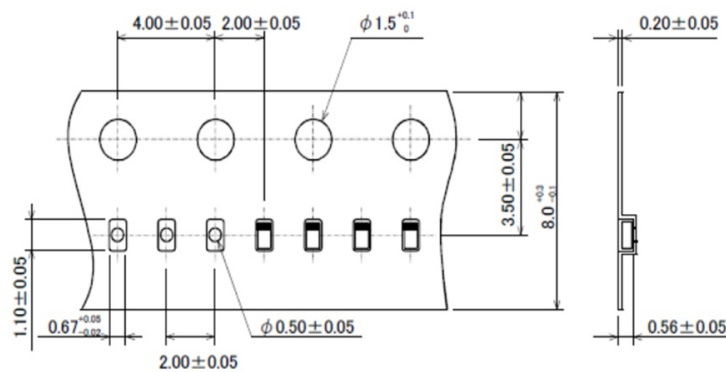
