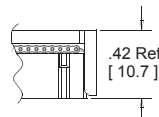

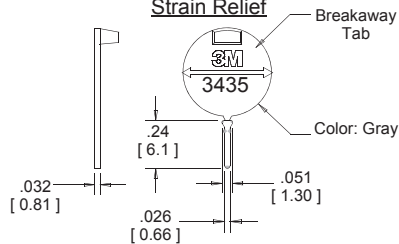
Bottom View of Body

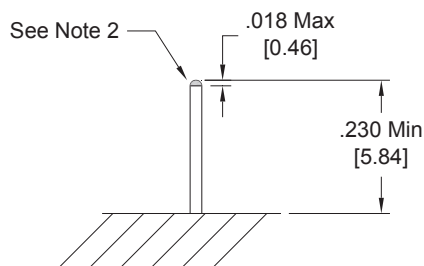
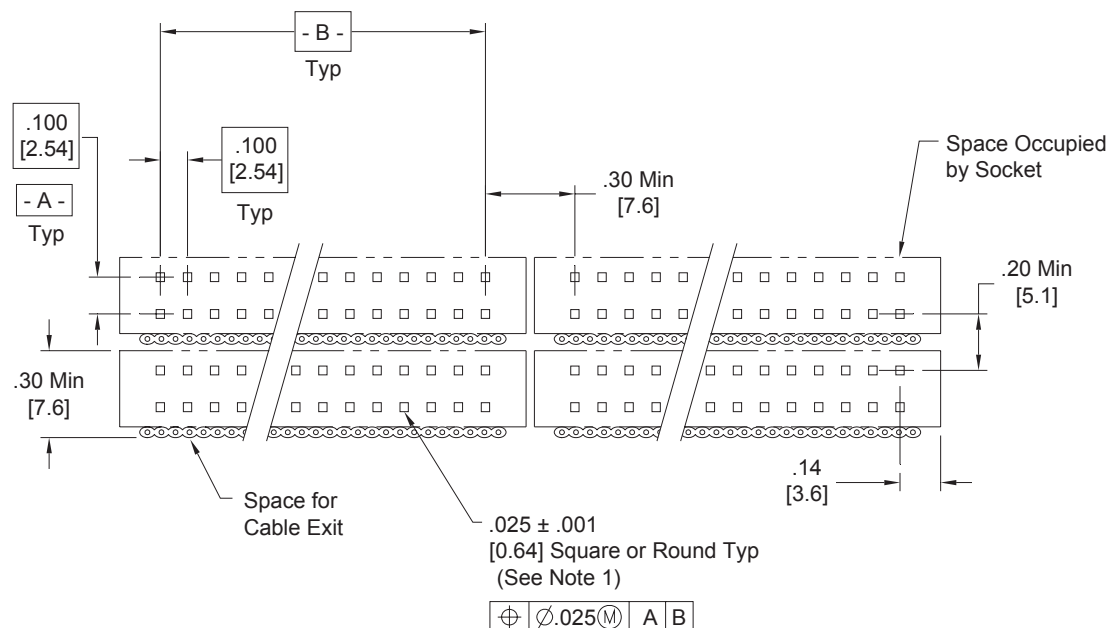
