Product data sheet

1. General description

The CBT3306 dual FET bus switch features independent line switches. Each switch is disabled when the associated output enable ($\overline{\text{nOE}}$) input is HIGH.

The CBT3306 is characterized for operation from $-40\text{ }^{\circ}\text{C}$ to $+85\text{ }^{\circ}\text{C}$.

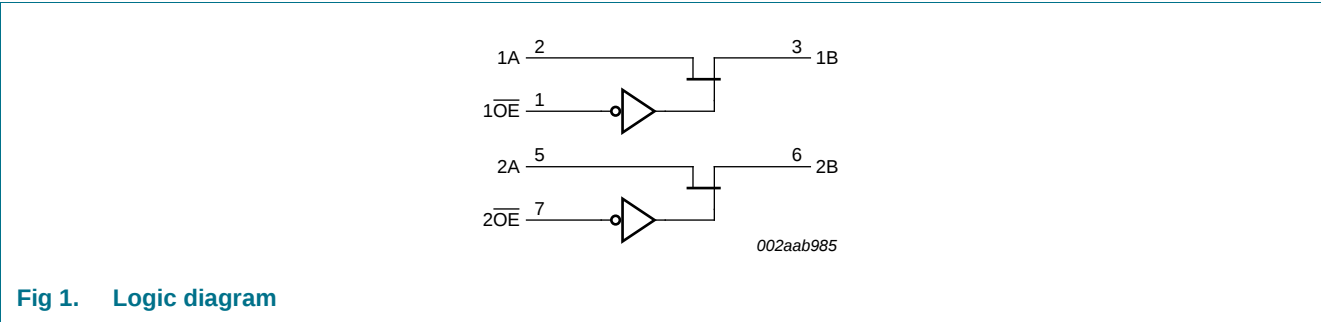

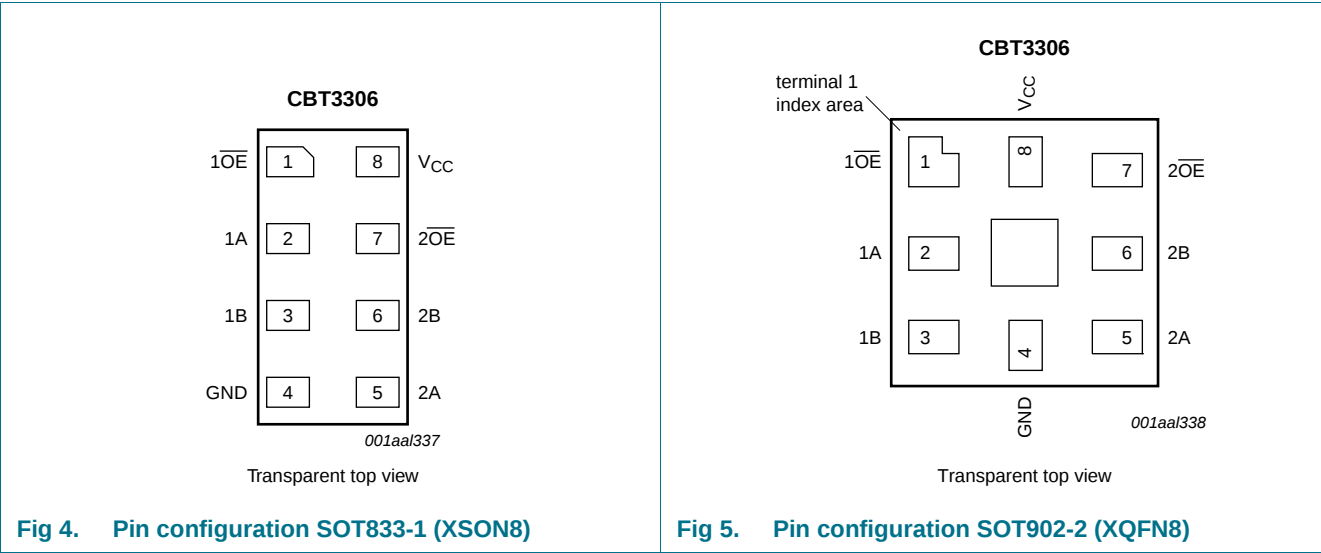
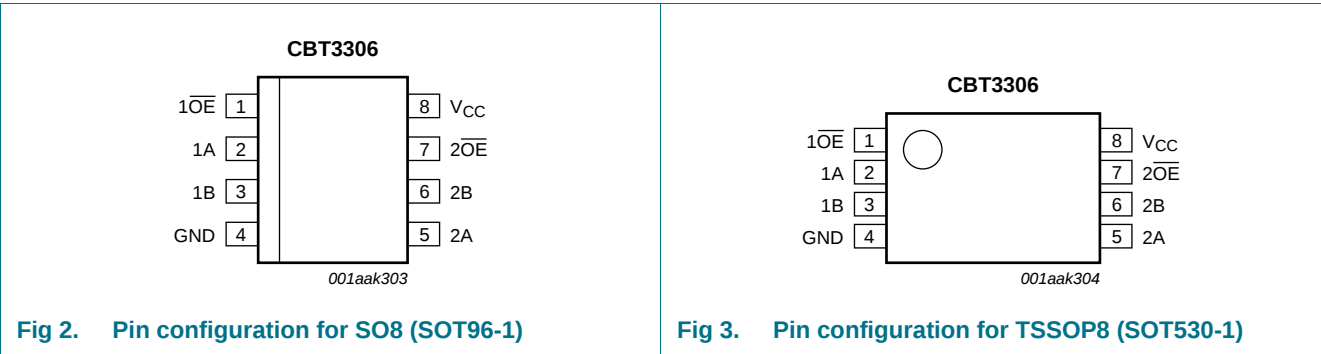


5. Functional diagram

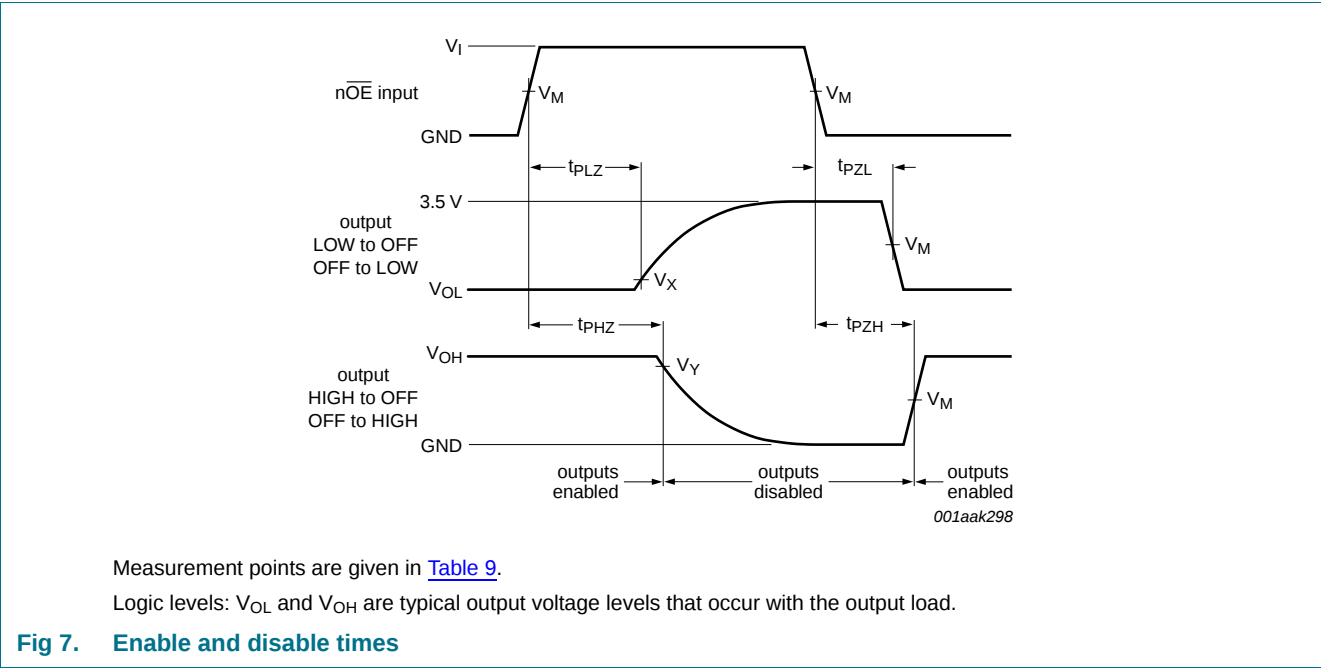
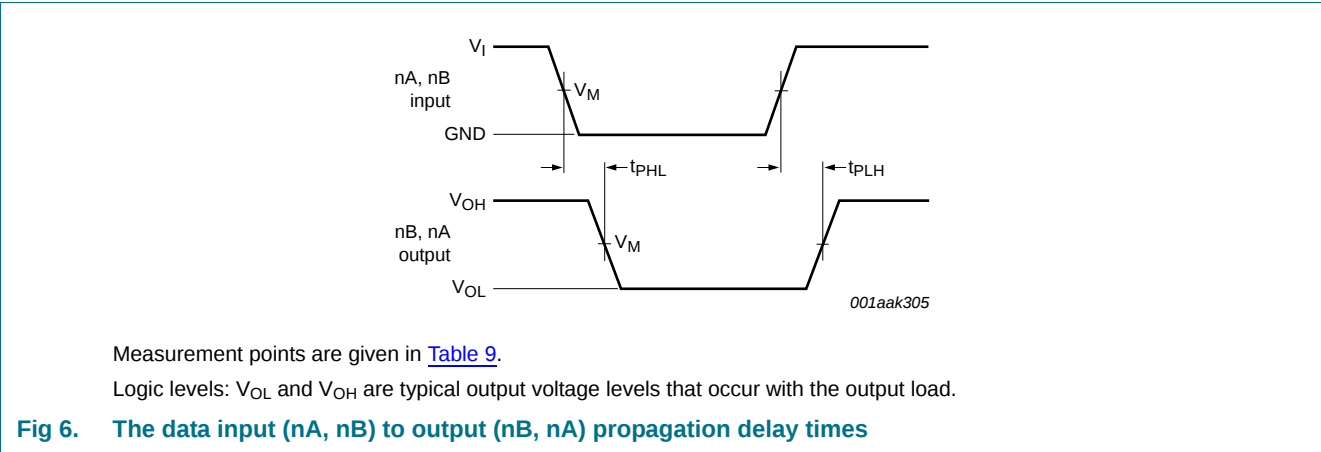
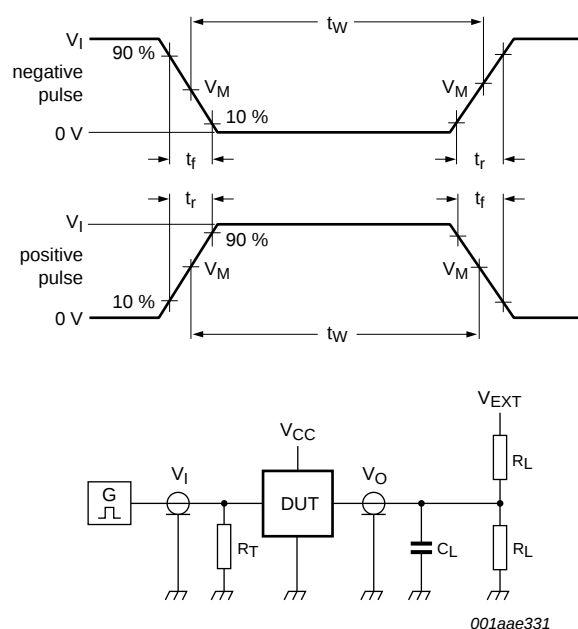

All input pulses are supplied by generators having the following characteristics: $PRR \leq 10$ MHz; $Z_0 = 50 \Omega$.

The outputs are measured one at a time with one transition per measurement.

Definitions for test circuit:

R_l = Load resistance.

C_L = Load capacitance including jig and probe capacitance.

R_T = Termination resistance should be equal to output impedance Z_0 of the pulse generator.

V_{EXT} = External voltage for measuring switching times.

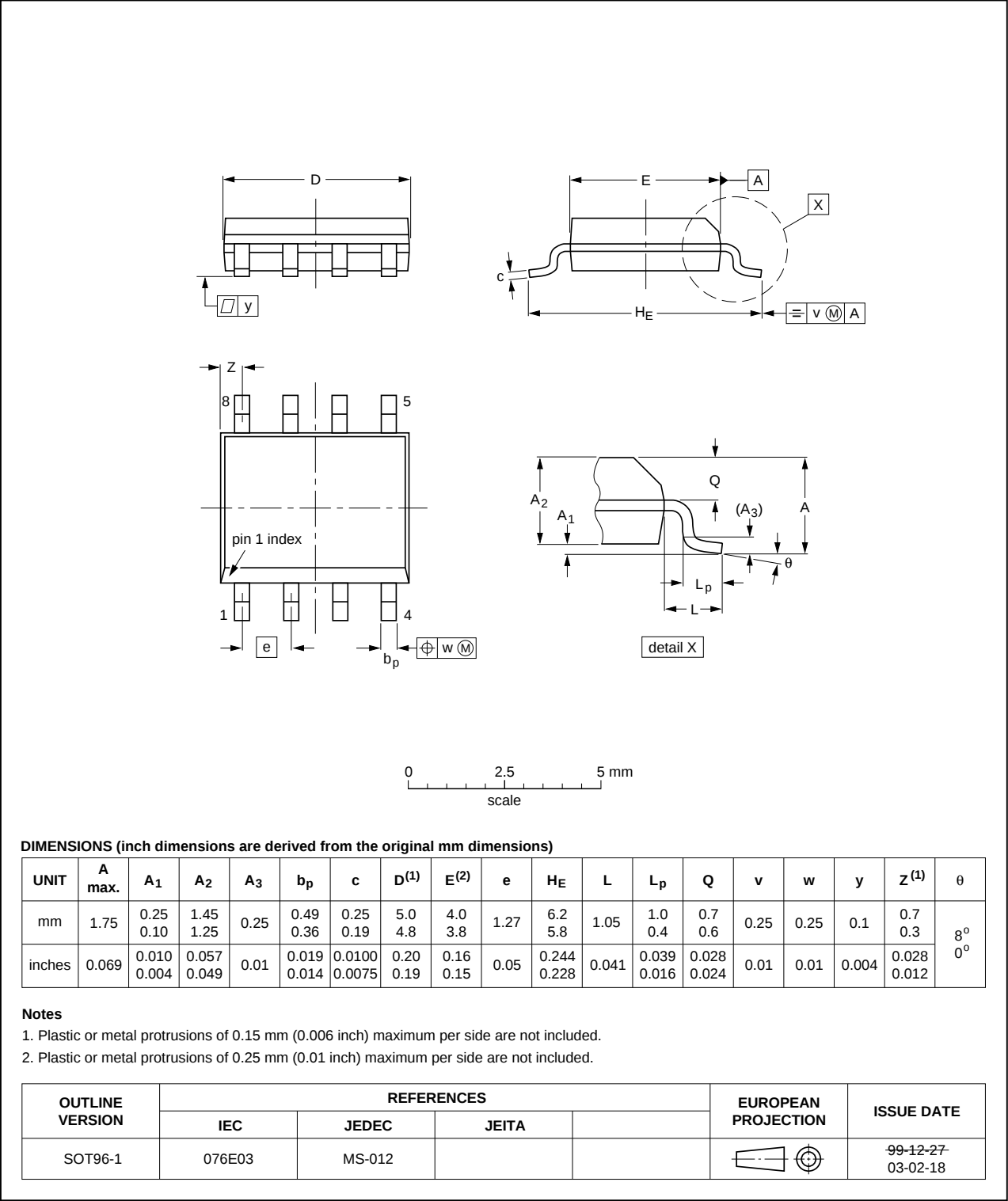


Fig 9. Package outline SOT96-1 (SO8)

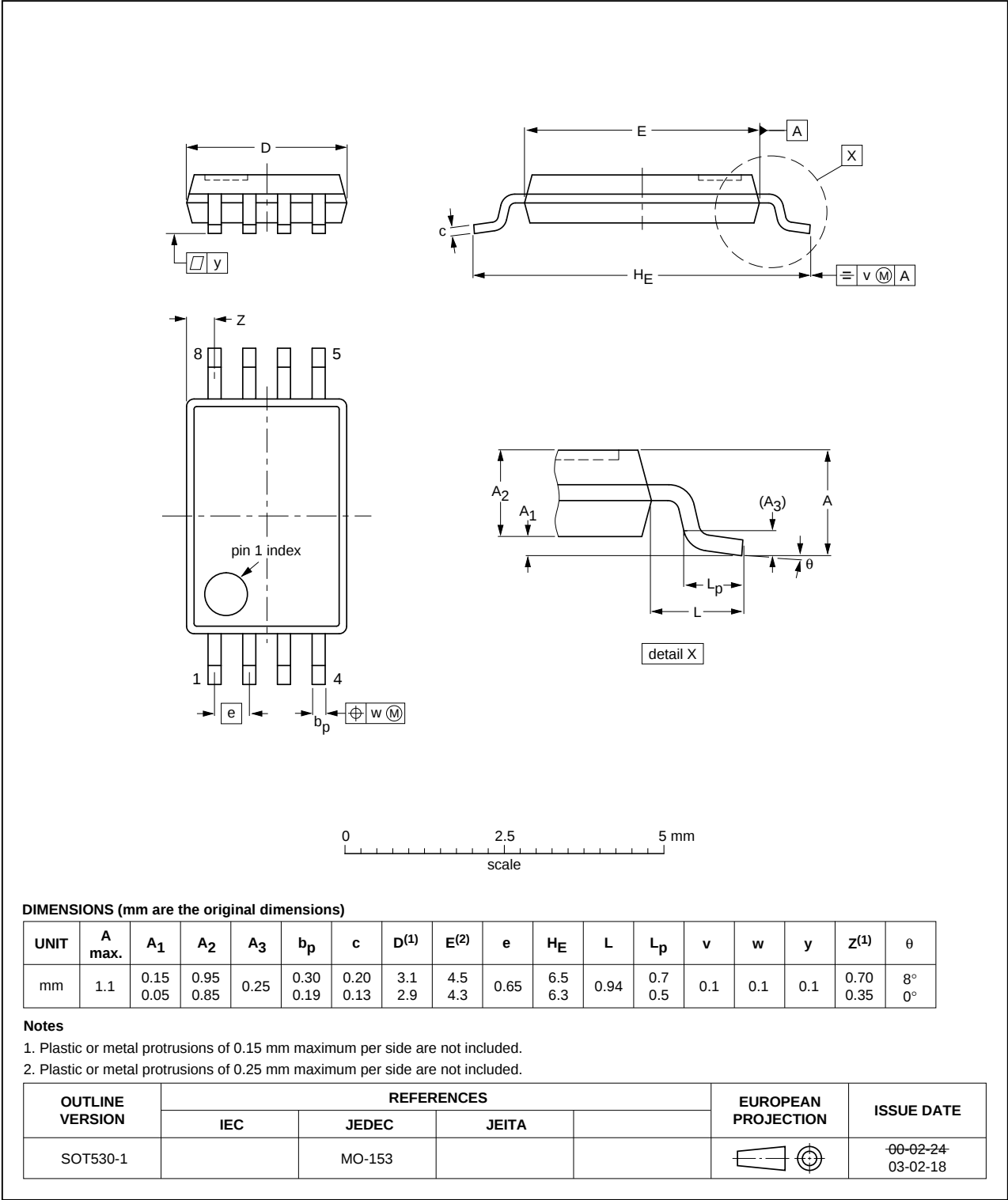


Fig 10. Package outline SOT530-1 (TSSOP8)

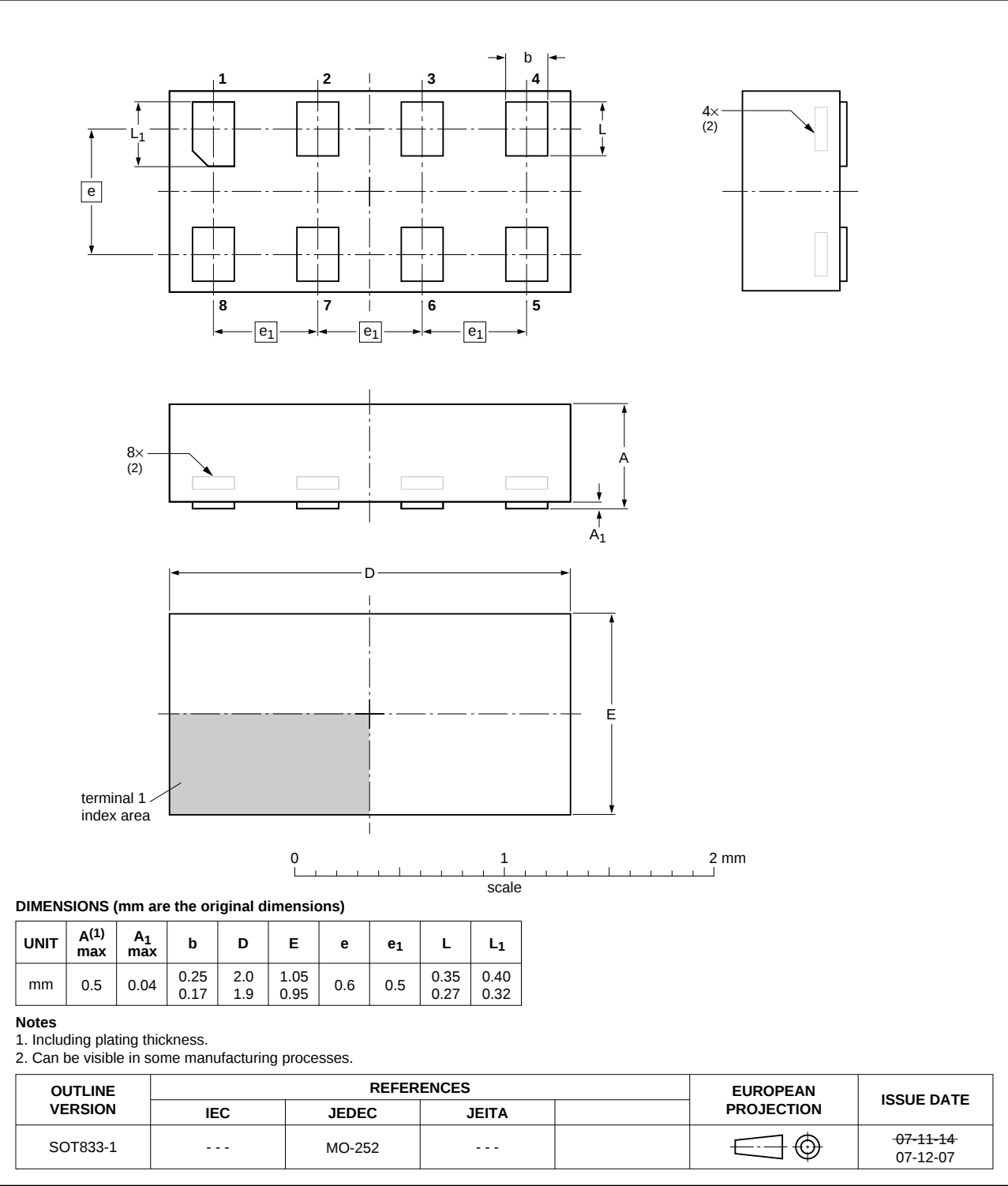


Fig 11. Package outline SOT833-1 (XSON8)

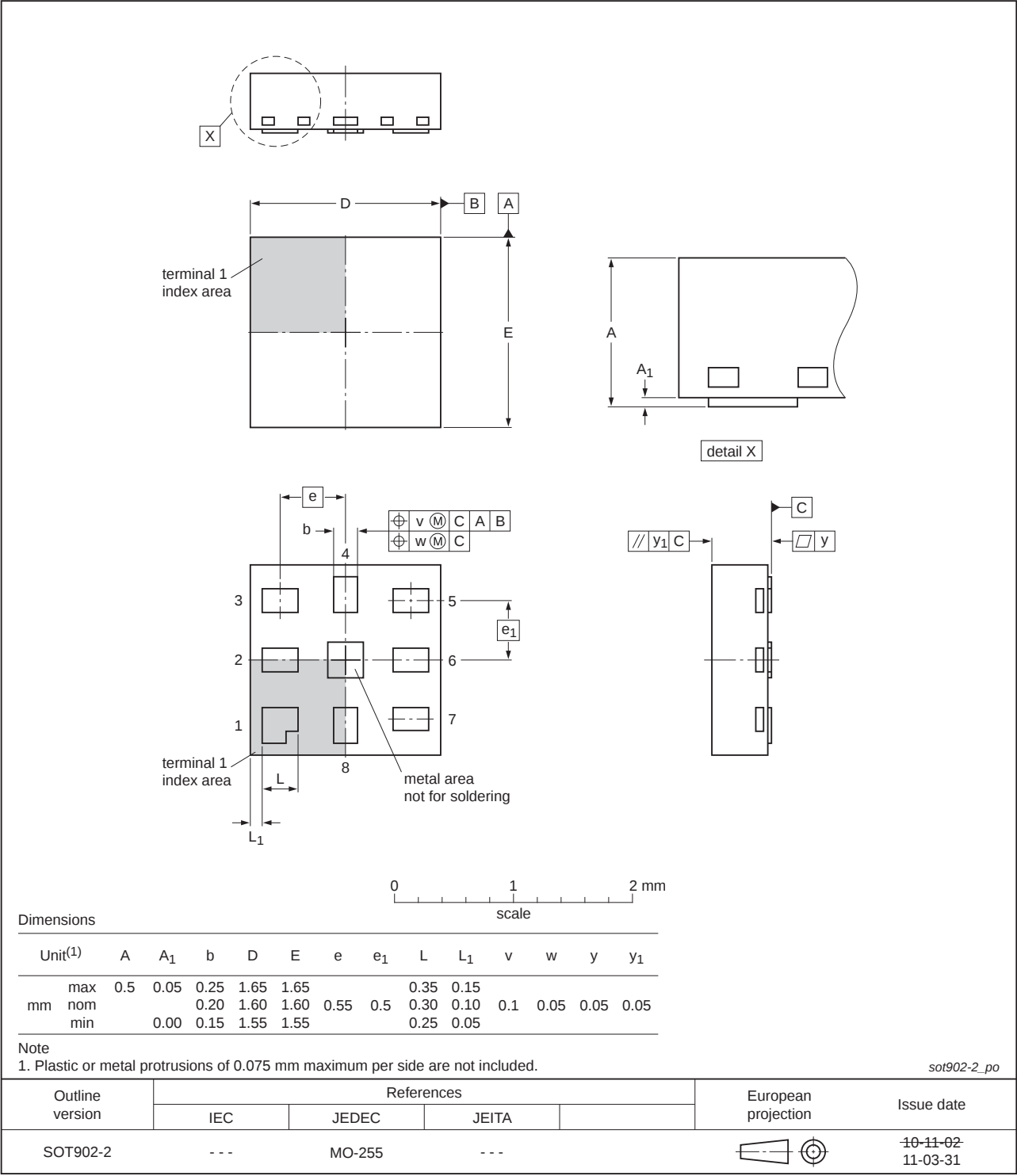


Fig 12. Package outline SOT902-2 (XQFN8)
