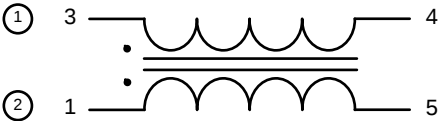

Typical Impedance Characteristics:



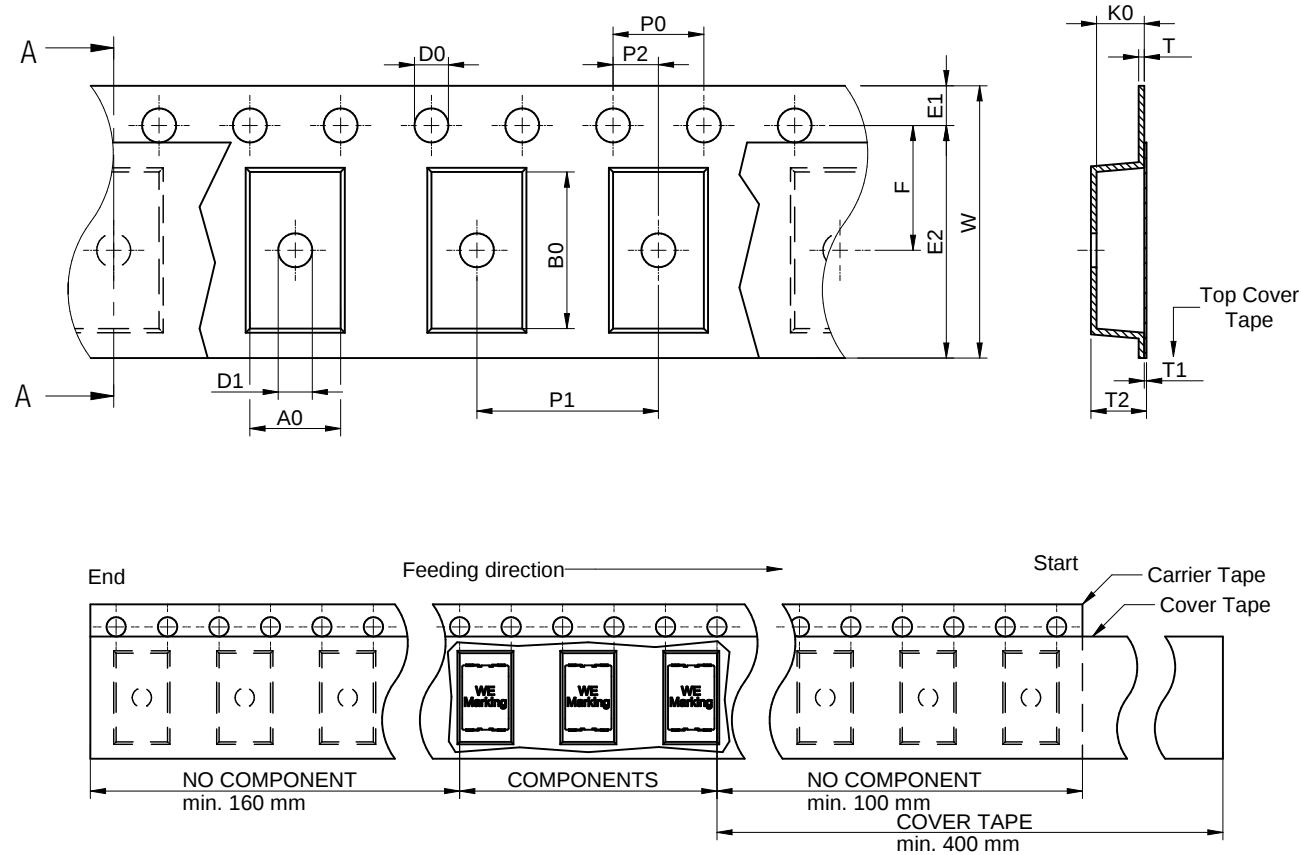

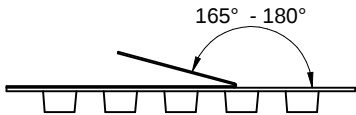
