sectional drawing A-A

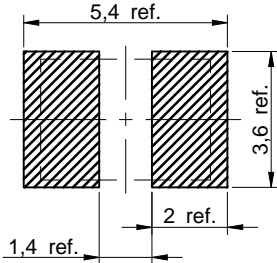

Typical Inductance vs. Current Characteristics:



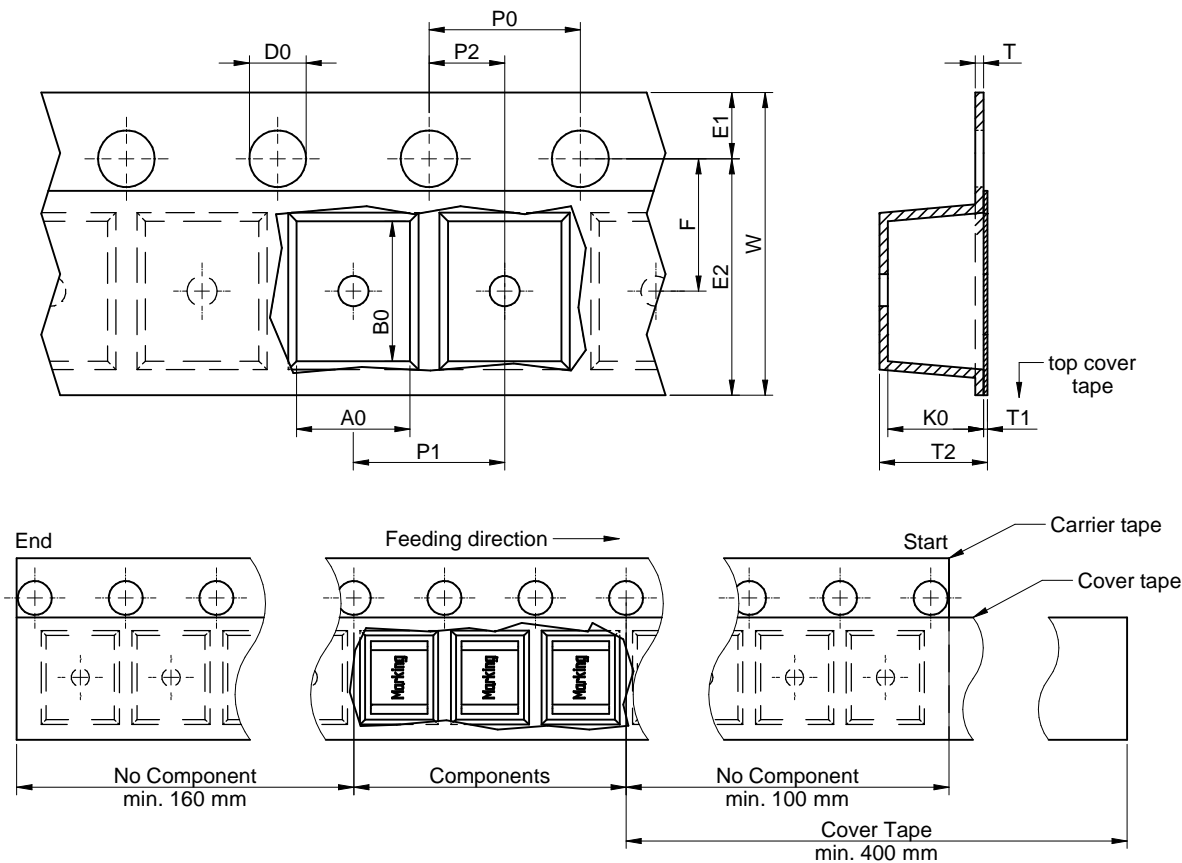
Typical Impedance Characteristics:



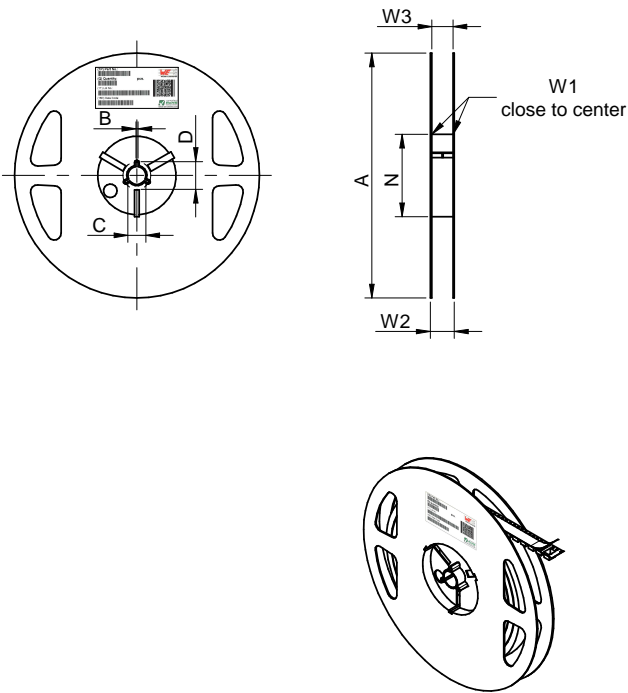
