Product data sheet

1. General description

The 74LV04AT is a hex inverter with TTL inputs.

Designed to operate over a V_{CC} range from 4.5 V to 5.5 V, the inputs are TTL compatible, which allows the device to be used to translate from 3.3 V to 5 V.

Schmitt-trigger action at all inputs makes the circuit tolerant of slower input rise and fall times.

This device is fully specified for partial Power-down applications using I_{OFF} . The I_{OFF} circuitry disables the output, preventing the damaging backflow current through the device when it is powered down.

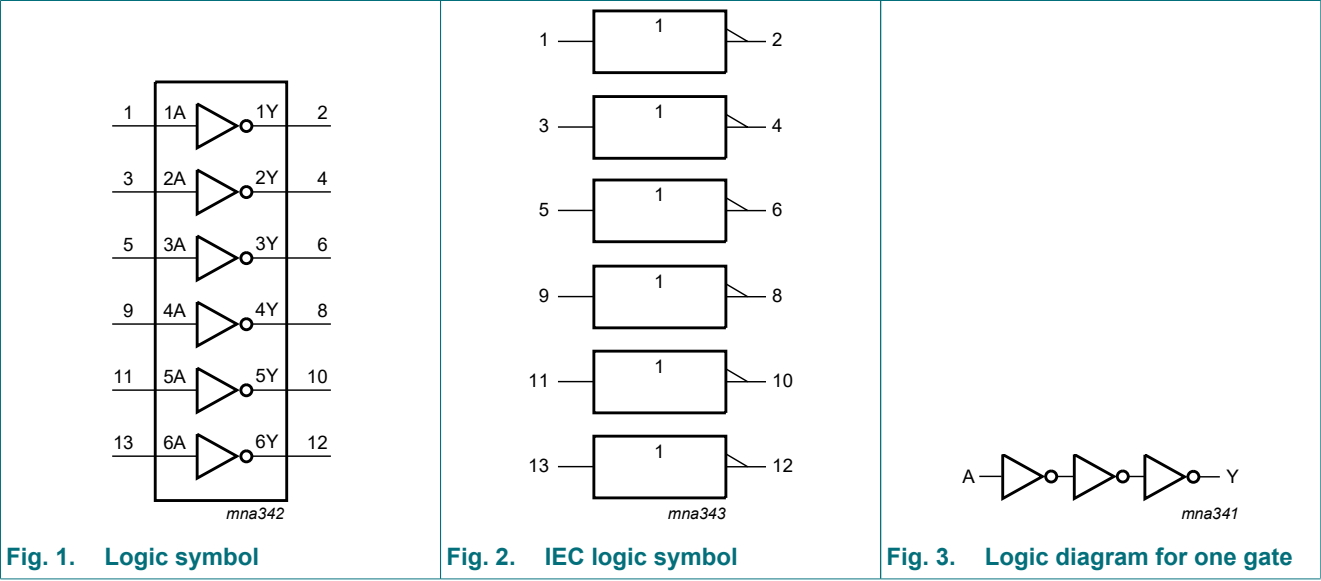

- Typical $V_{OH(v)} > 2.3$ V at $V_{CC} = 5$ V, $T_{amb} = 25$ °C
- Supports mixed-mode voltage operation on all ports
- I_{OFF} circuitry provides partial Power-down mode operation
- Latch-up performance exceeds 250 mA per JESD 78 Class II
- ESD protection:
 - HBM: ANSI/ESDA/JEDEC JS-001 class 2 exceeds 3000 V
 - CDM: ANSI/ESDA/JEDEC JS-002 class C3 exceeds 2000 V
- Specified from -40 °C to +85 °C and from -40 °C to +125 °C

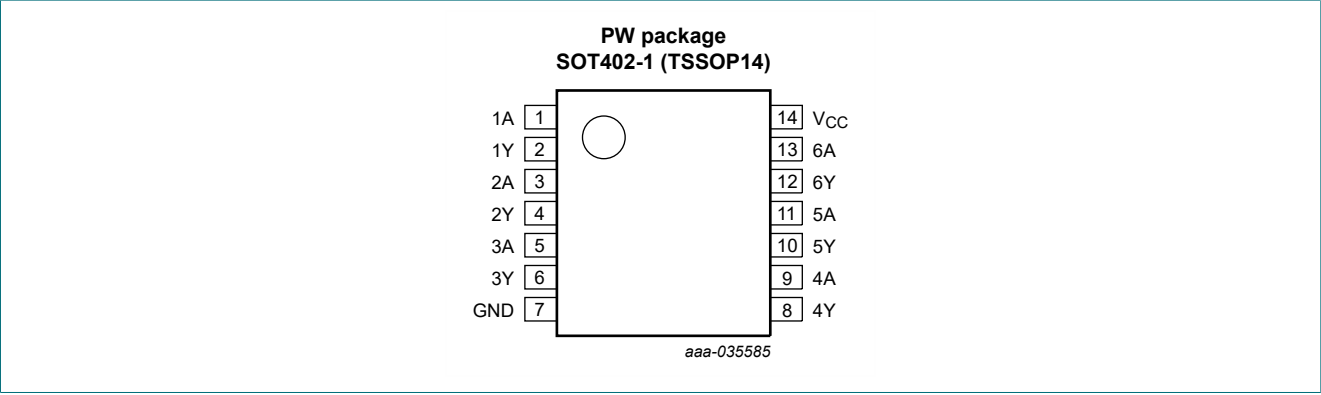

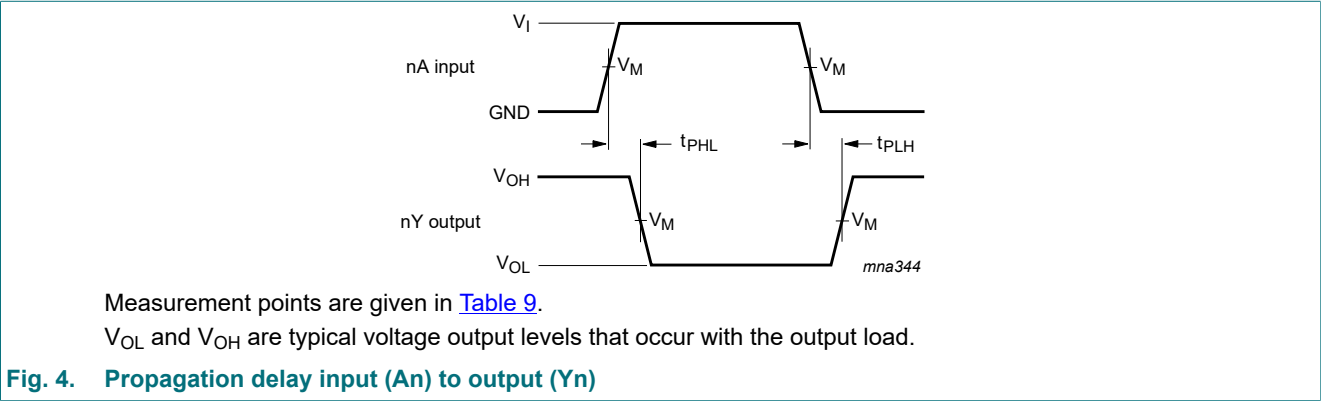

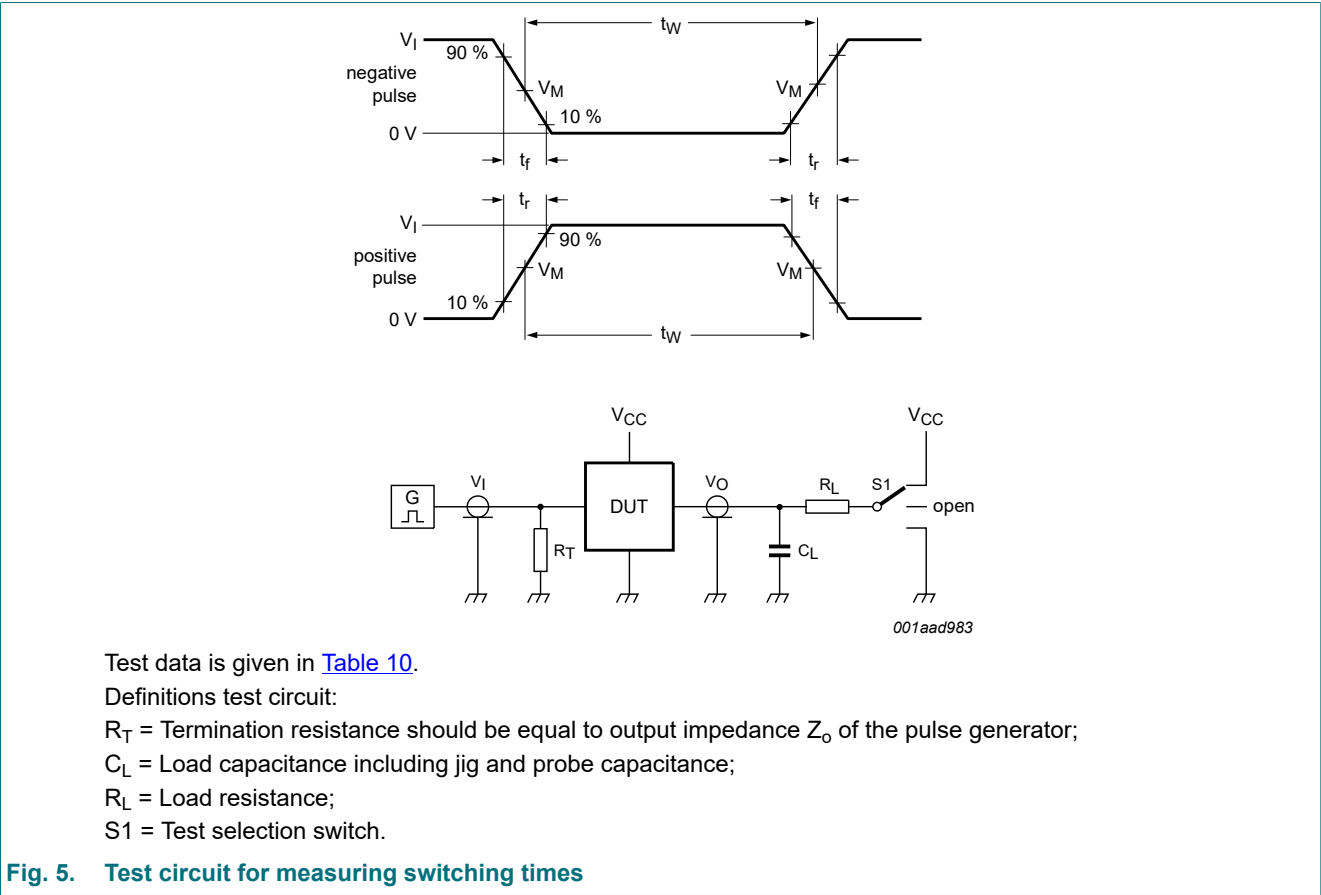

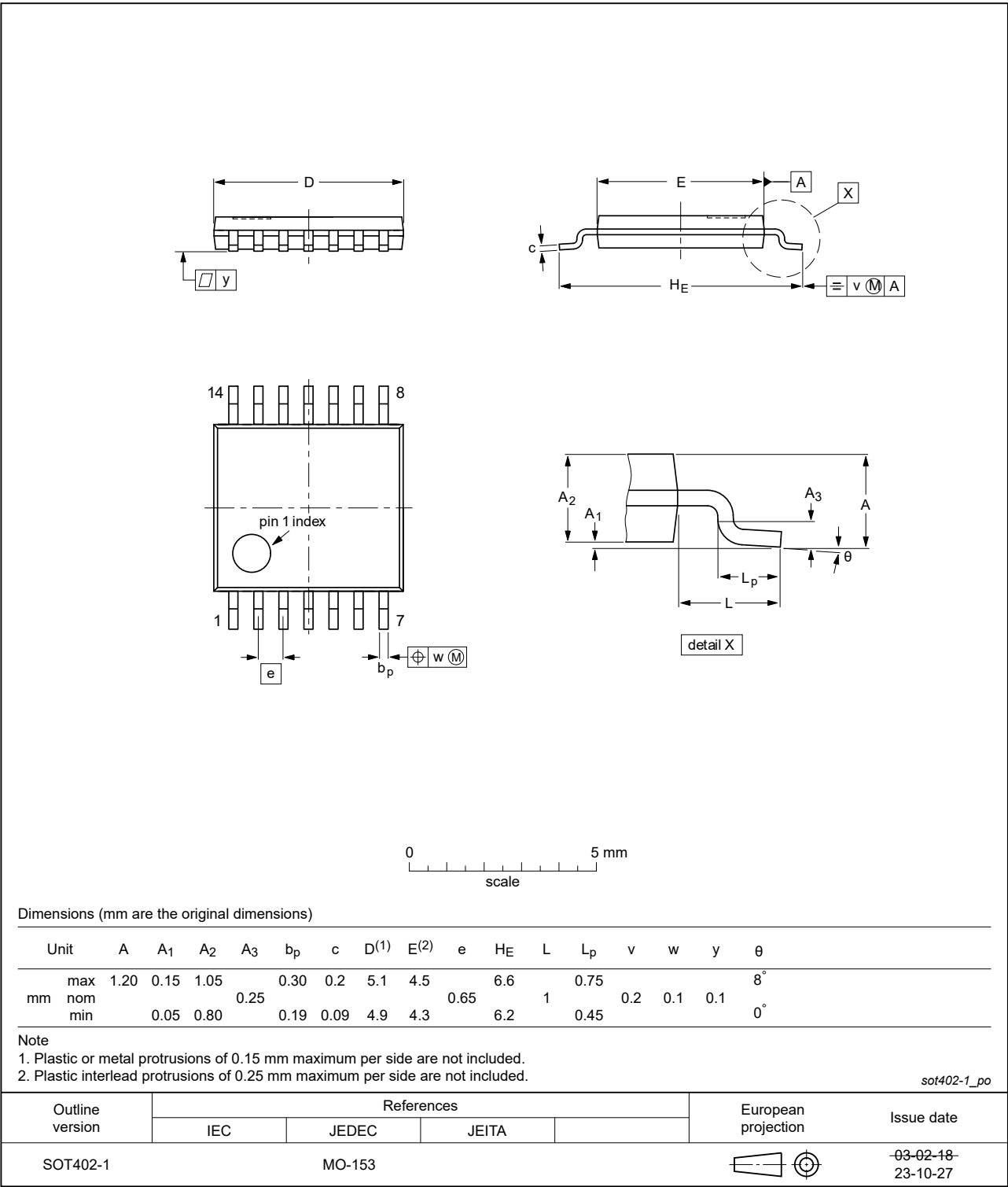


Fig. 6. Package outline SOT402-1 (TSSOP14)
