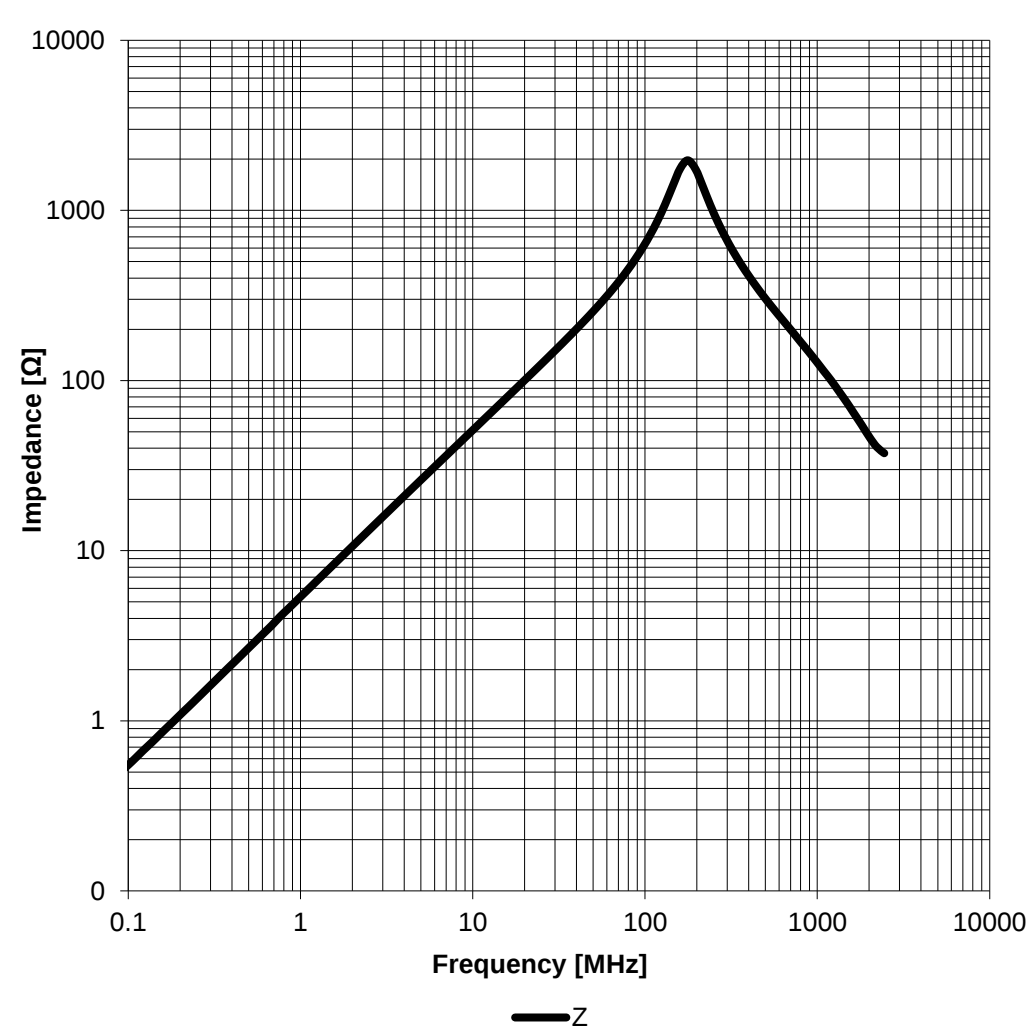

Typical Impedance Characteristics:

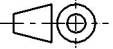
