


Figure 1. Forward Current Derating Curve




Figure 2. Non-Repetitive Surge Current




Figure 3. Forward Voltage Characteristics




Figure 4. Reverse Current vs. Reverse Voltage




Figure 5. Total Capacitance




Figure 6. 2-LEAD, SMA, JEDEC DO-214, VARIATION AC (ACTIVE)
